EXECUTIVE DIRECTOR'S REPORT

August 16, 2023

South Dakota State Board Examinations:

State board examinations are on schedule, and we currently have no backlog of applications for examination. We have also added additional examination dates for the theory examination to allow more scheduling flexibility for the office and examinees.

Personnel Updates:

The Board office has hired Miranda Wilson to fill the position of Senior Secretary. Miranda comes to the Board with over two years of experience working in State government as a senior secretary with the Board of Regents.

Fiscal Year 2023:

The Board office worked with the Department of Labor & Regulation (DLR) fiscal division to close out fiscal year 2023, which ended on June 30, 2023. Net revenue decreased, and current trends indicate that operating costs will exceed revenue going forward.

<u>36-14-14</u>. Qualifications for transfer of license or registration from another state or country.

Any person who is at least eighteen years of age may transfer a barber license or registration to this state if the applicant has:

- (1) A license or certificate of registration as a barber from another state or country that has substantially the same requirements for licensing or registering barbers as required by this chapter; or
- (2) Can prove by affidavits that the applicant has practiced as a barber in another state or country for at least five years.

After a qualified applicant pays the required fee, the Board of Barber Examiners shall issue a certificate of registration to practice barbering. If an applicant applying to transfer a barber license or registration to this state from another state or country that requires less than fifteen hundred hours of instruction as a prerequisite to licensing, the applicant shall receive an additional fifty hours of credit for each month the applicant has practiced as a licensed barber in the other state or country. This credit shall be applied toward the required fifteen hundred hours of instruction required by § 36-14-17.

36-14-6. Inspection of shops and schools by board.

Any member of the Board of Barber Examiners, or its agents or assistants, shall have authority to enter upon and to inspect any barbershop or barber school at any time during business hours.
