## AGENDA ITEM #5 OLD BUSINESS

### Action Items - reports

Neugebauer reported that he and Bacon had been working on updating the Land Survey Take Home exam. There are a few changes to be made. Members of the Board agreed to wait until the Legislative Session is over to complete

all the updates to the tests as well as the booklet of laws related to land surveying and making these effective on date of July 1, 2012. Neugebauer also stated his goal to complete the electronic file conversion of the land surveying history paper by the next Board meeting in May. Items on the Action Items list at this meeting that have been completed will be removed before the next meeting.

### **Rules and Statutes - reports**

Shafai reported that there are changes in the near future regarding NCEES application as far as the PDH log is concerned. Draft of the new Blue Book is complete but the Board will wait until after Legislative Session ends and new laws go into effect on July 1, 2012 to request a reprint and post a new copy on the website.

### **Investigator Duties**

Discussion was held by the Board regarding the allocated .5 staff position. Todd Kolden was contacted for clarification on the position and the requirements to fill the position. After further discussion, it was decided by the Board that they would prefer to contract for investigative duties on an as needed basis for cases and fill the .5 for clerical duties relating to office procedures and as support for investigations.

Discussion was held regarding the update of office equipment. A new copier for the office was discussed and noted that it would be obtained on a lease agreement rather than purchased. Humphreys is to send an email to Tacy Kennison and copy Todd Kolden on the office requirements for a new copier.

'Smart Boards' were also noted as possibility for installation in the Board room to be paperless at Board Meetings. The cost of the 'Smart Boards' can range from \$750 to \$3,000 depending on size and capabilities. Further investigation will be done on this particular item.

Board members asked if there would be a possibility of having WI-FI installed in the Board room for use during meetings. Humphreys is to follow up on this item along with the possibility of establishing a secure web page for Board members to access information sent to their attention.


