Vice Chairman Albertson invited Chris Brandriet to speak to the board about CLARB and any issues related to Landscape Architects. Mr. Brandriet updated the board on the progress GPC ASLA has made toward getting a landscape Architect seat on the board and any associated rules and statute changes.

#### NCARB Message on AIA intern titles

AIA recently issued a statement in support of two new titles to replace the title "intern" when referring to a candidate pursuing architectural licensure: "Architectural Associate" or "Design Professional." Many jurisdictions safeguard one or both of these titles in law or regulation. NCARB is working to ensure licensure candidates do not simply adopt these titles, potentially subjecting themselves to prosecution or disciplinary action. Vice Chairman Albertson invited John Riker to speak on this issue. Mr. Riker suggested that one possible reason could be that there is no real title for someone who is experienced, but not yet licensed. A person could potentially remain an "Architectural Intern" their whole career.
