## **Additional Information for Instructor Continuing Education Training:**

In order to renew a senior instructor license, you must attend an approved 12-hour education course each year on teaching methodology. The course must be completed before your license renewal date.

### **Other Providers/Courses**

Other options to obtain instructor continuing education include:

- Public or private colleges, universities, or technical schools
- Other online or classroom courses
- Courses sponsored by a South Dakota cosmetology school (school must submit their course materials to the Commission for preapproval)

The course must have approval from the Commission office before you take it. Course approval decisions will be given at a regularly scheduled Commission meeting before the license expires. After the course is completed and before your license expires, you must send the Commission all of the following information:

- Course title
- Dates and times the course was presented
- Length of course (number of hours not including lunch breaks) or total credits
- Course description such as syllabus or outline
- Sponsoring school
- An official transcript or certificate from the school
- Your renewal fee, if necessary
- \$35 verification fee payment

A qualified course must be a minimum of 12 education clock hours in length and should deal with teaching methods, such as:

## **Unapproved Providers/Courses**

Providers unlikely to receive approval are:

- Individual Educators
- Beauty Shows or Cosmetology Product Companies
- Cosmetology Schools (unless the education is part of a state-approved instructor-license program required by that state)

Courses unlikely to receive approval are:

- Business skills courses on typing, keyboarding or speed reading
- Orientation courses through cosmetology schools
- Courses through cosmetology schools that do not offer instructor training or normal business meetings.

## **Additional Information for Eyelash Extension, Electric File, and Microdermabrasion Education:**

The South Dakota Cosmetology Commission requires education prior to performing eyelash extension services, using a microdermabrasion machine or electric nail file. These are one-time educational requirements. Documentation must be sent to the Commission immediately upon completion of any course. A \$35 verification fee must be paid by the licensee to the Commission if the education provider is not approved by the Commission. The providers on the list below are approved providers for South Dakota licensees, so the licensee does not have to pay the \$35 verification fee to the Commission.

If you would like to apply for approval as an educator of eyelash extensions, microdermabrasion, or electric nail file, please fill out the Education Certification Course Provider Application (Adobe PDF format) and send to the Commission office with the \$100 application fee. Your application will be presented to the Commission for approval at their next regular scheduled meeting. Approval is valid for a one-year period of time.

- Performing eyelash extensions requires 16 hours of training, which must be completed before performing the service.
- Performing microdermabrasion requires 16 hours of training, which must be completed before starting the service.
- Using electric files requires eight hours of training, and licensees must complete the electric file course before using the electric file.
- If a licensee does not complete the education requirement and continues the service, the license may be suspended or revoked.

The Commission is not responsible for any course dates, rescheduled courses, cancelled courses, or fees paid to the provider.
