20:44:14:01(12) defines an "Owner's exemption" as an exemption from licensure requirements in SDCL 36-16-13 for an individual owner who is **personally installing** electrical wiring and fixtures in a residence or farmstead which is **owned** and **resided in or on** by the person installing the electrical wiring or fixtures. Owners doing electrical work on their own residence or farmstead in compliance with SDCL 36-16-15 may not allow their wiring permit to be used by any other person. Violators may be assessed a \$350 administrative fee.
