CONSENT ORDER

In resolution of the above matter and in lieu of a formal hearing, the undersigned parties do hereby agree to the following:

JAMAL BALDWIN, whose address of record is 574 Wabash Ave., Atlanta, GA 30312, is a nonresident insurance producer licensed in the State of South Dakota;

JAMAL BALDWIN is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The Division alleges the following:

- 1) JAMAL BALDWIN did not submit his application fee pursuant to his June 14, 2012 application until January 11, 2013 in violation of SDCL §§ 58-30-159(2), 58-2-29, and 58-30-167(3);
- 2) JAMAL BALDWIN was the subject of a January 7, 2013 administrative action by the State of Kansas ("Kansas Action") revoking his license;
- 3) JAMAL BALDWIN reported the Kansas Action to the Division on March 14, 2013;
- 4) JAMAL BALDWIN failed to report the Kansas Action to the Division within 30 days in violation of SDCL § 58-30-193;
- 5) JAMAL BALDWIN provided the Division with false, misleading or incomplete information in an e-mail to the Division on March 14, 2013 which purported to show that the Kansas Action was previously reported in February 2013 in violation of SDCL § 58-33-66(2);
- 6) JAMAL BALDWIN provided the Division with false, misleading or incomplete information in e-mails to the Division on March 14, 2013 which contained falsified dates in violation of SDCL § 58-33-66(2);
- 7) On March 18, 2013, JAMAL BALDWIN surrendered his license to the Division;
- 8) Pursuant to SDCL §§ 58-2-29, 58-30-159(2), 58-30-167 (2), (3), (7), (8), and (9), 58-30-170, 58-30-193, and 58-33-66(2), the Director of the Division may revoke JAMAL BALDWIN's nonresident insurance producer's license for any one of the above-cited reasons.

JAMAL BALDWIN is aware of and understands the nature of the charges and has been informed that he has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

In return for JAMAL BALDWIN agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute the final disposition pursuant to SDCL § 1-26-20;

JAMAL BALDWIN agrees, in lieu of contesting this matter formally, to the revocation of his nonresident insurance producer's license and to cease the transaction of insurance business in this state;

JAMAL BALDWIN further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;


By the execution of this Consent Order, JAMAL BALDWIN waives his right to contest the allegations contained in this Consent Order in any future licensing proceedings;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that the nonresident insurance producer's license of JAMAL BALDWIN is hereby revoked; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further


ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
