In resolution of the above matter and in lieu of issuance of a Notice of Hearing and a formal hearing, the undersigned parties do hereby agree to the following:

JULIA BLANK, whose address of record is Humana Inc., 2231 E Camelback Rd., Ste. 300, Phoenix, AZ 85016-3453, holds a nonresident insurance producer license in the State of South Dakota;

JULIA BLAK is aware that the South Dakota Division of Insurance has conducted an investigation;

The South Dakota Division of Insurance alleges the following with regard to JULIA BLANK:

- 1) JULIA BLANK failed to report an administrative action taken against her insurance license by the State of Utah on October 1, 2012 within 30 days of the final disposition to the South Dakota Division of Insurance, in violation SDCL 58-30-193 and 58-30-167(2);
- 2) JULIA BLANK failed to respond to a Division inquiry dated March 14, 2013, in violation of SDCL 58-33-66(1);
- 3) Pursuant to SDCL 58-30-167(2), 58-30-193, and 58-33-66(1), the Director of the South Dakota Division of Insurance may revoke or suspend JULIA BLANK 's nonresident insurance producer license for the above-cited reasons.

JULIA BLANK is aware of and understands the nature of the allegations and has been informed that she has the right to a Notice of Hearing, counsel and appeal and that by agreeing to sign this Consent Order, waives these rights;

In return for JULIA BLANK agreeing to and complying with the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute an informal disposition of this licensing matter pursuant to SDCL 1-26-20;

By the execution of this Consent Order and the payment of a penalty pursuant to this Consent Order, JULIA BLANK waives her right to contest the allegations contained in this Consent Order in any future actions or licensing procedures with the Division;

By signing this Consent Order, JULIA BLANK neither admits to nor denies any violation of the laws of this state;

JULIA BLANK agrees to pay Five Hundred Dollars (\$500) pursuant to SDCL 58-30-167 and SDCL 58-4-28.1, in lieu of a Final Order, and further agrees to conduct herself in accordance with the insurance laws and regulations of the State of South Dakota;

JULIA BLANK agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that JULIA BLANK pay a monetary penalty in the amount of Five Hundred Dollars (\$500) payable to the South Dakota Division of Insurance for deposit in the general fund of the State of South Dakota and that JULIA BLANK abide by the agreements made by her in this Consent Order; and it is

FURTHER ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority.

IT IS FURTHER ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
