CONSENT ORDER

---

In resolution of the above matter and in lieu of a formal hearing, the undersigned parties do hereby agree to the following:

COURTNEY DOUGLAS, whose mailing address of record is 8454 Trowbridge Way, Huber Heights, Ohio 4524, is a nonresident insurance producer licensed in the State of South Dakota;

COURTNEY DOUGLAS is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The Division alleges the following:

- 1) COURTNEY DOUGLAS failed to timely report an administrative action by the State of Ohio to the Division in violation of SDCL § 58-30-193;
- 2) COURTNEY DOUGLAS failed to timely report a felony prosecution to the Division in violation of SDCL § 58-30-194;
- 3) COURTNEY DOUGLAS failed to report a felony prosecution on her 2013 license renewal in violation SDCL § 58-30-167(1), (2), and (3);
- 4) Pursuant to SDCL §§ 58-30-167(1), (2), (3), (6), and (8), the Director of the Division may revoke COURTNEY DOUGLAS' nonresident insurance producer license for any of the above-cited conduct.

COURTNEY DOUGLAS is aware of and understands the nature of the charges and has been informed that she has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

In return for COURTNEY DOUGLAS agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute the final disposition pursuant to SDCL § 1-26-20;

COURTNEY DOUGLAS agrees, in lieu of contesting this matter formally, to the revocation of her nonresident insurance producer's license and to cease the transaction of insurance business in this state;

COURTNEY DOUGLAS further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;


By the execution of this Consent Order, COURTNEY DOUGLAS waives her right to contest the allegations contained in this Consent Order in any future licensing proceedings;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that the nonresident insurance producer's license of COURTNEY DOUGLAS is hereby revoked; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further


ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
