CONSENT ORDER

In resolution of the above matter and in lieu of a formal hearing, the undersigned parties do hereby agree to the following:

SUSAN DAUB, whose address of record is 5879 NW 124th Way, Coral Springs, FL 33076, is a nonresident insurance producer licensed in the State of South Dakota;

SUSAN DAUB is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The Division alleges the following:

- 1) SUSAN DAUB was the subject to administrative actions in West Virginia, Idaho, Louisiana, Georgia, and Arkansas which resulted in the revocation or suspension of her insurance licenses in those states;
- 2) SUSAN DAUB failed to timely report administrative actions to the Division in violation of SDCL § 58-30-193;
- 3) SUSAN DAUB failed to timely respond to Division inquiries regarding her administrative actions in violation of SDCL §§ 58-33-66 and 58-33-68;
- 4) Pursuant to SDCL §§ 58-30-167(2), (8), and (9), 58-30-193, 58-33-66, and 58-33-68, the Director of the Division may revoke SUSAN DAUB's insurance producer license for any one of the above-cited reasons.

SUSAN DAUB is aware of and understands the nature of the charges and has been informed that she has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

In return for SUSAN DAUB agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing on October 11, 2016 and agrees that this Consent Order will constitute the final disposition of this matter pursuant to SDCL § 1-26-20;

SUSAN DAUB agrees, in lieu of contesting this matter formally, to the revocation of her nonresident insurance producer's license and to cease the transaction of insurance business in this state;

SUSAN DAUB further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;


By the execution of this Consent Order, SUSAN DAUB waives her right to contest the allegations contained in this Consent Order in any future licensing proceedings;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that the nonresident insurance producer's license of SUSAN DAUB is hereby revoked and that SUSAN DAUB cease the transaction of insurance business in South Dakota; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.


