CONSENT ORDER

In resolution of the above matter and in lieu of issuance of a Notice of Hearing and a formal hearing, the undersigned parties do hereby agree to the following:

JESSIE J. BIBLE, whose address of record is 2902 Gables Vale Court, Las Vegas, NV 89121 holds a nonresident insurance producer license in the State of South Dakota;

JESSIE J. BIBLE, is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The South Dakota Division of Insurance alleges the following with regard to JESSIE J. BIBLE:

- 1) JESSIE J. BIBLE failed to timely report a 2016 North Dakota administrative action that revoked her insurance producer license in violation of SDCL § 58-30-193;
- 2) JESSIE J. BIBLE failed to respond the Division's requests for explanation dated July 21, 2016 in violation of SDCL §§ 58-33-66 and 58-33-68;
- 3) JESSIE J. BIBLE failed to update her contact information with the Division in violation of SDCL § 58-30-157;
- 4) Pursuant to SDCL § 58-30-167(2), (8), and (9), 58-33-66, 58-33-68, 58-30-157 and 58-30-193, the Director of the South Dakota Division of Insurance may revoke or suspend JESSIE J. BIBLE's nonresident insurance producer license for any of the above-cited reasons.

JESSIE J. BIBLE is aware of and understands the nature of the allegations and has been informed that she has the right to a Notice of Hearing, counsel and appeal and that by agreeing to sign this Consent Order, waives these rights;

In return for JESSIE J. BIBLE agreeing to and complying with the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute an informal disposition of this licensing matter pursuant to SDCL § 1-26-20;

JESSIE J. BIBLE agrees to pay \$500 pursuant to SDCL §§ 58-30-167 and 58-4-28.1, in lieu of an administrative hearing and Final Decision;

JESSIE J. BIBLE further agrees to conduct herself in accordance with the insurance laws and regulations of the State of South Dakota;

JESSIE J. BIBLE further agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

JESSIE J. BIBLE waives her right to contest the allegations contained in this Consent Order in any future actions or licensing procedures;

Wherefore, good cause appearing from the foregoing, it is hereby:

ORDERED that JESSIE J. BIBLE pay a monetary penalty in the amount of \$500 payable to "South Dakota Division of Insurance" for deposit in the general fund of the State of South Dakota; and it is further

ORDERED that JESSIE J. BIBLE abide by the agreements made by her in this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.


