RE: Application for Insurance Producer License

Dear Mr. Clickner,

This letter is to notify you that your application for licensure as a nonresident insurance producer in South Dakota has been denied. The reason for the denial is as follows:

You submitted an application for an individual nonresident insurance producer license to the South Dakota Division of Insurance ("Division") on June 11, 2020. You answered "yes" to the licensing application question asking if you had ever been convicted of a felony. You also answered "yes" to whether you had a child support obligation in arrearage, and disclosed you were 9 months in arrearage. The Division conducted an investigation and corroborated that on July 22, 2005, you were convicted of a felony DUI in Ohio.

On June 24, 2020, the Division sent a letter requesting a written explanation and documentation describing your criminal history to the mailing and email addresses you provided. On July 14, 2020, this letter was returned as not deliverable as addressed. The Division again sent the letter and also sent an additional letter to the residential address you provided. In this correspondence, the Division also requested that you update your mailing address and an explanation as to why you provided inaccurate information. The Division sent correspondence to the same addresses again on July 24, 2020. USPS tracking showed that letters arrived at your residential address and your mailing address. The Division received no response to the letters and called you on August 24, 2020 at the number you provided but received no response. To date, the Division has not received a response.

Based on the above information, your application is denied under SDCL § 58-30-167(1), (6), and (8) for providing incorrect, misleading, incomplete, or materially untrue information in the license application, for having been convicted of a felony, and for demonstrating incompetence or untrustworthiness in the conduct of business in this state or elsewhere.

Please note that this denial is considered an administrative action which will be reported to the database maintained by the National Association of Insurance Commissioners. If an administrative action occurs, an insurance producer may be required to report the action to any and all states in which an insurance license is held and in accordance with the timeframes and requirements of each state.
