RE: Application for Insurance Producer License

Dear Ms. Medlin,

This letter is to notify you that your application for licensure as a nonresident insurance producer in South Dakota has been denied. The reason for the denial is as follows:

You submitted an application for an individual nonresident insurance producer license to the South Dakota Division of Insurance ("Division") on April 27, 2020. On your answer to the application questions concerning felony convictions, you indicated you have a felony conviction. You did not provide the required information or documentation regarding the crime requested in the application.

The Division wrote to you at the address you provided in your application on May 4, 2020 to request written explanations regarding why you did not provide the requested information, the circumstances of the arrest, and documents related to the arrest. The Division also sent this letter to the email address provided in the application. After receiving no response, the Division again mailed and emailed you on June 4, 2020 making the same requests. A licensing representative responded to that email request on June 9, 2020 on your behalf. She included the requested documentation as well as a written statement by you explaining the arrest and its aftermath.

Based on the above information, your application is denied based upon SDCL § 58-30-167(1), (2), and (6) for providing incomplete information in a nonresident producer license application, violating South Dakota's insurance laws, and having a felony conviction.

Please note that this denial is considered an administrative action which will be reported to the database maintained by the National Association of Insurance Commissioners. If an administrative action occurs, an insurance producer may be required to report the action to any and all states in which an insurance license is held and in accordance with the timeframes and requirements of each state.

Pursuant to SDCL § 58-30-168, you may make a written request to the Division of Insurance of the date of this denial for a hearing to determine the reasonable cause for licensure.
