RE: Application for Insurance Producer License

Mr. Monk,

This letter is to notify you that your application for licensure as a nonresident insurance producer in South Dakota has been denied. The reason for the denial is as follows:

You submitted an application for an individual nonresident insurance producer license to the South Dakota Division of Insurance ("Division") on October 22, 2019. On your answer to the application question concerning misdemeanors, you answered "Yes". Despite being required with the application, no documentation of those crimes or violations was provided to the Division. The Division wrote to you and called you on several occasions to clarify your application and obtain required documentation. To date, no response has been provided to the Division by you.

Based on the above information above in view of ARSD 20:06:01:03(4) and (6), your application is denied based upon SDCL § 58-30-167(1) for providing incorrect, misleading, incomplete, or materially untrue information in the license application.

Please note that this denial is considered an administrative action which will be reported to the database maintained by the National Association of Insurance Commissioners. If an administrative action occurs, an insurance producer may be required to report the action to any and all states in which an insurance license is held and in accordance with the timeframes and requirements of each state.

Pursuant to SDCL § 58-30-168, you may make a written request to the Division of Insurance within thirty days of the date of this denial for a hearing to determine the reasonableness of this decision to deny your application for licensure.
