In resolution of the above matter and in lieu of a formal hearing, the undersigned parties do hereby agree to the following:

DANIEL SELNICK, whose address of record is 500 NE Spanish River Blvd Ste 26, Boca Raton, Florida 33431-4517 is an individual who is currently licensed as a non-resident insurance producer in the State of South Dakota;

DANIEL SELNICK is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The Division alleges the following with regard to DANIEL SELNICK:

- 1) DANIEL SELNICK was the subject to administrative actions in the State of Maryland;
- 2) DANIEL SELNICK failed to report the administrative actions to the Division within 30 days, in violation of SDCL § 58-30-193;
- 3) DANIEL SELNICK had an insurance producer license, or its equivalent, denied, suspended, or revoked in another state, province, district, or territory, in violation of SDCL § 58-30-167(9);
- 4) DANIEL SELNICK accepted a commission, service fee, brokerage, or other valuable consideration for selling, soliciting, or negotiating insurance without being appointed, in violation of SDCL § 58-30-172;
- 5) Pursuant to SDCL §§ 58-30-167(2),(9), 58-30-172 & 58-30-193; the Director of the Division may revoke DANIEL SELNICK's insurance producer license for violating the insurance laws of South Dakota.

DANIEL SELNICK is aware of and understands the nature of the charges and has been informed that he has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

By the execution of this Consent Order DANIEL SELNICK neither admits to nor denies any violations of the laws of the State of South Dakota, but waive his right to contest the allegations contained in this Consent Order;

In return for DANIEL SELNICK agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute the final disposition pursuant to SDCL § 1-26-20;

DANIEL SELNICK agrees, in lieu of contesting this matter formally, to the revocation of his nonresident insurance producer's license and to cease the transaction of insurance business in this state;

DANIEL SELNICK further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of determining the appropriate

sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

By the execution of this Consent Order, DANIEL SELNICK waives his right to contest the allegations contained in this Consent Order in any future licensing proceedings;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that the nonresident insurance producer's license of DANIEL SELNICK is hereby revoked; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
