RE: Application for Insurance Producer License

Dear Mr. Elliott,

This letter is to notify you that your application for licensure as a nonresident insurance producer in South Dakota has been denied. The reason for the denial is as follows:

You submitted an application for an individual nonresident insurance producer license to the South Dakota Division of Insurance ("Division") on October 29, 2021. On your answers to the application questions, you answered "Yes" to the question concerning misdemeanor convictions. You provided documentation with your application of your criminal history and potential child support issues. While your application was pending, you were the subject of administrative actions in the states of Kansas, Wisconsin, and South Carolina. The state of Kansas denied your licensure application on November 3, 2021 based on your criminal history. The state of Wisconsin revoked your license on November 29, 2021 due to your failure to pay taxes; however, it appears your Wisconsin license has since been reinstated. The state of South Carolina revoked your license on February 23, 2022 based on administrative actions from another state, failure to report that administrative action, and your failure to respond.

Due to this, the Division wrote to you on February 2, 2022 via email to request an explanation regarding your child support documentation, recent criminal history, and the revocation and reinstatement of your Wisconsin license. After receiving no response, the Division wrote to you on March 8, 2022 via email, regular mail, and certified mail requesting a response from you. After receiving no response, the Division made one last attempt to contact you via email on April 11, 2022. To date, the Division has not received a response from you.

Based on the above information, your application is denied based upon SDCL 58-30-167(1), (2), and (9) for providing incorrect, misleading, incomplete, or materially untrue information in a license application; violating the insurance laws or rules of the State of South Dakota and other states; and having an insurance producer license, or its equivalent, denied, suspended, or revoked in another state.

Please note that this denial is considered an administrative action which will be reported to the database maintained by the National Association of Insurance Commissioners. If an administrative action occurs, an insurance producer may be required to report the action to any and all states in which an insurance license is held and in accordance with the timeframes and requirements of each state.

Pursuant to SDCL 58-30-168, you may make a written request to the Division of Insurance within thirty (30) days of the date of this denial for a hearing to determine the reasonableness of this decision to deny your application for licensure.
