Re: Application for South Dakota Non-Resident Insurance Producer License

Dear Mr. Ostrau,

This letter is to notify you that your application for licensure as a non-resident insurance producer in South Dakota has been denied. The reason for the denial is as follows:

You submitted an application for an individual non-resident insurance producer license to the South Dakota Division of Insurance ("Division") on April 6, 2022. You answered "no" to Question 2 of the licensing application asking if you had ever been named or involved as a party in an administrative proceeding. However, in reviewing your application, it was discovered that you have been named in an administrative action.

Due to this discrepancy with your application, the Division wrote to you on June 27, 2022, requesting an explanation and a written statement explaining the facts and circumstances of the administrative action, along with documentation related to the administrative action. The Division received no response and wrote a citation letter on July 18, 2022, which was sent via email, first-class mail, and first-class certified mail. No response was received. A call was placed to your home phone of record on August 18, 2022, in an attempt to contact you. A voicemail was left informing to respond to the Division no later than August 24, 2022. No response was received.

Therefore, your application is denied based upon SDCL 58-30-167(1) and (2) for providing incomplete information in the license application and violating any insurance laws, rules, or order of another state's insurance director.

Please note that this denial is considered an administrative action which will be reported to the data base maintained by the National Association of Insurance Commissioners. If an administrative action occurs, an insurance producer may be required to report the action to any and all states in which an insurance license is held and in accordance with the timeframes and requirements of each state.
