RE: Application for Insurance Producer License/Denial

This letter is to notify you that your application for licensure as a resident insurance producer in South Dakota has been denied. The reason for the denial is as follows:

You submitted an application for an individual resident insurance producer license to the South Dakota Division of Insurance ("Division") on June 15, 2022. In your application, you answered "YES" to question 1B, indicating you have been convicted of felony. In reviewing your application, it was determined that not all of your criminal history was disclosed in your application. After speaking with Division, the Division, you eventually provided documentation showing that you were charged with or found guilty of the following:

- 2010—SD—DUI—Misdemeanor
- 2011—SD—Interfere with a Peace Officer—Misdemeanor
- 2015—MN—Possession of a controlled substance—Felony
- 2015—MN—Possession of a controlled substance—Felony
- 2015—MN—DUI—Misdemeanor
- 2017—SD—Possession of a controlled substance—Felony
- 2017—SD—Ingestion of Intoxicant—Misdemeanor
- 2018—SD—Unauthorized ingestion of controlled substance—Felony
- 2019—SD—Intentional Damage to Property—Misdemeanor

Based on the above information, your application is denied because you have been determined not to be in good standing under ARSD 20:06:01:03 and for violating SDCL §§ 58-30-167(1),(2),(6),(8), for providing incorrect or incomplete information on the licensure application; and for violating the insurance laws or rules of South Dakota or any other state; and for having been convicted of a felony; and for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in this state or elsewhere.

Please note this denial is considered an administrative action which will be reported to the database maintained by the National Association of Insurance Commissioners. If an administrative action occurs, an insurance producer may be required to report the action to all states in which an insurance license is held and in accordance with the timeframes and requirements of each state.

Pursuant to SDCL § 58-30-168, you may make a written request to the Division of Insurance within thirty (30) days of the date of this denial for a hearing to determine the reasonableness of this decision to deny your application for licensure.
