## Farm Mutual Tax Return (Annual Fees & Fire Marshal Taxes)

#### Instructions

#### File your return through TriTech

Your premium tax return will now be filed electronically. The South Dakota Division of Insurance, in conjunction with TriTech, is implementing an online premium tax application for insurers to prepare and submit their premium tax returns electronically. Required attachments are easily attached to the electronic filing. Non-subscribers to TriTech can use the following link to get started with filing — <a href="https://nonsub.tritechsoft.com/#/?folderId=42">https://nonsub.tritechsoft.com/#/?folderId=42</a>. Non-subscribers can sign in to use this service free through TriTech. For companies that currently use the TriTech Premium Pro software, they will be able to submit the electronic filing within the software with the click a button. Any company filing their 2020 premium tax return after March 1, 2021 will be subject to penalty fees.

### Make your payment through OPTins

The payment process to the State of South Dakota is now available electronically through OPT*ins*. If you are already registered to use OPT*ins* to file your premium tax filings to other states, you are already set up within OPT*ins* to pay South Dakota.

The steps to submit your tax payment are very simple and require no formal training. Easy to follow instructions are available at: https://www.optins.org.

Using OPTins allows you to save time and ensure that the payment is received on time. Please visit <a href="www.optins.org">www.optins.org</a> and click on New Users: Get Started to download the implementation paperwork labeled "Implementation Forms - All Other". Make sure you choose between ACH Debit and ACH Credit. Once it is completed, submit the forms to OPTins Marketing at <a href="mailto:optinsmktg@naic.org">optinsmktg@naic.org</a> and a product specialist will work with you through your implementation. Setup of a new account takes 5-7 business days.

Once registered and set up, you will be able to log in and submit your payment online. No more paper checks – everything is electronic and your payment is received at the South Dakota Division of Insurance immediately upon submission by the company.
