Dear Sir/Madam:

This document constitutes notice pursuant to the Workers Adjustment Retraining Notification Act, 29 U.S.C. Section 2101 et seq. ("WARN Act") that Capital One Services ("Capital One") will be implementing job eliminations and closing its facility located at 2200 East Benson Road, Sioux Falls, SD 57104.

As a result, Capital One anticipates that it will eliminate approximately 751 jobs at the 2200 East Benson Road facility in 41 different job titles. The layoffs are projected to occur in phases between October 1, 2015 and the second Quarter of 2016. The layoffs are "permanent" as defined by the WARN Act.

When these layoffs have been completed, the site located at 2200 East Benson Road will be closed. Once the job loss dates have been finalized, an addendum will be sent to all recipients of this notice with the details for each phase of separations.

A list with all employees expected to suffer a job loss is included with this letter. The list identifies the job titles of the positions to be affected and the number of affected employees in each title. The employees are not represented by a union, and they will not have bumping rights.

All employees whose jobs will be eliminated in this event at this site will receive at least 60 days written notice in advance of the effective date of the termination of their position. In accordance with and subject to the terms of any applicable severance plan, employees will be eligible for severance pay and benefits beginning upon the termination of their employment. Outplacement assistance is being provided to affected employees.

Moreover, affected employees are being provided opportunities to seek roles at other Capital One facilities.
