Request from Candidate

Nicole Kasin

An exam candidate made a request for an extension for their NTS:

Background of record:

8/5/21 application for exam part 1 (12-month NTS, expires 8/5/22)

8/1/22 sat for exam

9/20/22 application for exam part 1 (6-month NTS, expires 3/20/22)

3/18/22 scheduled for exam, Prometric closed due to weather

3/22/23 NASBA requested extension for candidate, 30-day extension granted (NTS expires 4/22/23)

4/18/23 scheduled for exam, Prometric cancelled due to operational issue

4/20/23 NASBA requested extension for candidate, 30-day extension granted (NTS expires 5/22/23)

4/24/23 email from candidate requesting extension through 5/31/23:

The NASBA extended my NTS through 5/22 but that isn't ideal for the commitments I already had planned for my full time job at the CPA firm when we are just catching our breath from tax deadlines and other projects still coming along with personal commitments with being out of town through 5/23.

Follow-up response from candidate when I emailed her that the extension was granted for 30 days:

I completely understand that there is a 30-day policy. I am requesting a possible exception to the policy due to the cancellation of my exam twice on dates that worked in the schedule I had laid out. I am asking for an additional nine days for a NTS good through 5/31 to accommodate the commitments I had set on my schedule for the end of April and beginning of May.

Note: Using the Prometric seat availability tool 5/23/23 to 5/31/23 adds two dates of availability 5/23/23 & 5/26/23 at this time. Candidate has noted that she is not available on 5/23/23, so this would add one date option.

The 30-day extension has been the standard extension provided when the candidate is scheduled for an exam and the exam appointment is cancelled through no fault of their own.

The Board has to make a determination with the request. ARSD 20:75:01:07 states: Upon good cause shown by the applicant or licensee, the board may waive any application or administrative fees or any deadlines set in this article. For the purpose of this section, good cause includes any personal emergency, act of God, administrative error made by the board or the board of another state, military deployment, or substantial compliance with SDCL chapter 36-20B or article 20:75.
