Via Teleconference June 16, 2022 12:30 p.m. CDT

Chairman Kilmer called the meeting to order at 12:34 p.m. A guorum was present.

Johnston made a motion to approve the agenda. Giovanis seconded the motion. **MOTION PASSED.** Little was absent.

Kilmer asked for any public comments. Allstot offered recommendations for rule changes regarding scoring to be consistent with the unified rules of mixed martial arts.

Little made a motion to approve the May 13, 2022 commission meeting minutes. Johnston seconded the motion. **MOTION PASSED.**
