Proposed Athletic Commission Policy Regarding Multiple Events by a Promoter in a Calendar Year

The Commission delegates to the executive secretary the authority to approve additional event(s) for a licensed promoter who has already had at an event approved by Commissioners in a calendar year under the same conditions imposed by the Commissioners on the first approved event.

Effect:

Delegation of this authority allows the Commission staff to approve additional events for a promoter in a calendar year without the need for special meetings of the Commission to consider the event application. If the event will follow the same process as the previously approved event, the additional date would be confirmed with the requirements of the first event. If circumstances change for a promoter or event, Commissioners would need to be involved in the approval of additional events.
