South Dakota Board of Barber Examiners Notice of Public Hearing to Adopt Rules

A public hearing will be held by Microsoft Teams, on April 1, 2025, at 10:00 a.m. Central Time, to consider the adoption and amendment of proposed Administrative Rules of South Dakota numbered:

§§ 20:39:03:04, 20:39:05:01, 20:39:05:03, 20:39:05:04, and 20:39:05:05.

The effect of the rules will be to revise the renewal date for a barber school license, increase fees for barber certificate renewal, barber certificate restoration, barber certificate restoration annual penalty, barber school license, barbershop license (initial and renewal), and barber chair (initial and renewal). The changes also establish new fee rules for fees related to annual inspections and initial barber licensure.

The reason for adopting the proposed fee rules is to raise revenue necessary for sustaining board operations. The revised renewal date change is to ensure continuity of renewal dates across various fees.

Persons interested in presenting amendments, data, opinions, and arguments for or against the proposed rules may appear in-person at the hearing, or mail or e-mail them to Board of Barber Examiners, 217 W. Missouri Ave, Pierre, SD 57501, tyler.evins@state.sd.us. The deadline to submit any such written comments for consideration by this part-time board is seventy-two hours before the date of the public hearing and no later than 10:00 a.m. Central Time on March 29, 2025.

After the written comment period, the Board of Barber Examiners will consider all written and oral comments it receives on the proposed rules. The Board of Barber Examiners may modify or amend a proposed rule at that time to include or exclude matters that are described in this notice.

20:39:03:04. Length and annual renewal of school license. A barber school license is valid for a period of one year expiring on ~~June 30~~ May thirty-first. To renew a license, the school shall apply to the board by ~~May 1~~ April first. The renewal application shall contain a statement that the school has complied with SDCL 36-14 and this article during the previous year.

The renewal application shall be accompanied by the school's curriculum and textbook list for review and approval by the board.

20:39:05:01. ~~Renewal fee~~ Fee for barber certificate of registration. The fee for the initial barber license is two hundred twenty-five dollars which includes the cost of examination or, for reciprocity applicants, a waiver of examination. For the annual renewal of a certificate of registration to practice barbering the fee is \$75 two hundred dollars. For the restoration of an expired certificate the fee is \$15 thirty dollars, plus \$12 twenty-five dollars penalty for each expired year, plus the annual license fee.

the initial license year is two hundred fifty dollars plus ~~\$10~~ twenty dollars for each barber chair.
The fee for a barber shop license annual renewal is two hundred twenty-five dollars plus twenty
dollars for each barber chair.
