NCARB has been privileged over the past several years to be in partnership with the American Institute of Architecture Students (AIAS) on a variety of fronts, including the dynamic Freedom by Design™ (FBD) program. FBD has evolved from the seed of an idea first planted in Denver to utilize design to free disabled individuals from traditional design biases. AIAS adopted FBD and has encouraged its campus chapters to design projects that now reach beyond residential adaptations to other spaces—private and public—which through creative collaboration can enhance the accessibility and impact on the user and greater community.


Grant dollars to support campus chapter projects and AIAS national efforts to market and sustain the program are provided by NCARB. This relationship is a win/win for both organizations: the design team projects qualify for Architectural Experience Program® (AXP®) credit and require a licensed architect to supervise the work, and the AIAS investment into the local community provides a platform for celebrating emerging professionals and exposing them to many aspects of architectural practice.

When feasible, NCARB and AIAS seek to pair architects serving on NCARB Member Boards with FBD teams as the project's licensed supervisor. An additional benefit to NCARB and its Member Boards is the establishment of a relationship between licensing boards and college students. The voice of the student is elevated, and the role of the licensing board is introduced and clarified.


A highlight of this past year was the opportunity to see firsthand the work of the University of Minnesota's FBD team, which was supervised by architect Wayne Hilbert, AIA, LEED AP, of the Minnesota Board. This FBD project focused on supporting the needs of students attending a special school designed for autistic children or facing other challenges to socializing and integrating into their peer groups in public schools. The FBD team designed an outdoor music garden, featuring elements designed to encourage collaboration and sound tolerance. On a late afternoon in November, several of us gathered to view the project and accompany one of the school's instructors in an informative tour and conversation about how the project and other design elements in the school are contributing to an enhanced learning environment.

As we move through this season of thanks and season of giving, we celebrate the good works that our student colleagues—and their architect partners—are achieving throughout the United States. Our investment is an investment in hope and an investment in the future, through the application of teamwork and creativity to the design process—yet another example of going further as we support our Member Boards in protecting the public.







### ORGANIZATIONAL DEVELOPMENT & OFFICE LIFE

- A series of "visioning sessions" with the chief executive officer (CEO), chief operating officer (COO), chief innovation and information officer (CIIO) and each of NCARB's seven departmental vice presidents has been launched. These sessions build on efforts of the Board and senior staff to identify short term, multi-year goals and express their vision of a successful organization. Through this effort along with staff retreats and refreshing departmental business plans, a focus on opportunities presented by the Council's second century will be sustained through the coming months. Expected outcomes include new approaches to staffing and budget priorities, evolved concepts around staff culture, and preparing for the impacts of future activities. These future activities include the upcoming Analysis of Practice, ongoing advocacy support for reasonable regulation, increasing support for Member Boards, and adopting a "lifecycle" perspective toward the Council's engagement with its customers.
- An internal work group of staff are developing an initiative to encourage building upon the diversity of the staff community into practices that promote inclusion and acknowledge the unconscious biases we all bring with us into the workplace. It is anticipated that these

- efforts will reinforce the value of the staff's "Agile" project management tool and incorporate individuals already volunteering for the Brand Ambassador and Quality of Life teams.
- A pilot program to experiment with "hoteling" spaces
  for staff working part of each week away from the office
  will be implemented after the first of the coming year.
  Utilizing examples of "best practices" for progressive
  workplaces, the pilot will emphasize the value of staff
  culture while acknowledging the value of multiple
  venues to perform work.





- Rolling out Last Pass password security system to all NCARB staff. The system will enhance our security posture by securing all passwords in an encrypted system.



This provides Member Boards and testing services with the 1-year notice required by the NCEES Manual of Policy and Position Statements, Exam Development Policy (EDP) 9.

### Fall 2020 Exam Changes

- PE Industrial and Systems—The PE Industrial and Systems exam has new specifications and will transition to computer-based testing in October 2020. The specifications are posted on the NCEES website. This will be a <u>single-day testing event</u> similar to paper-based exam administrations and the PE Nuclear and Petroleum computer-based exams administration. The <u>test date is Thursday, October 22, 2020.</u>

  Registration with NCEES for this exam began November 4, 2019. Examinees may reserve their seat at a Pearson VUE test center once they are registered with NCEES and approved by their board. Member Boards who manually approve candidates are encouraged to approve candidates as they register to allow them to reserve their seat for this single-day event as early as possible. The PE Nuclear and Petroleum exams will be offered on the same day.
- **PE Fire Protection**—The PE Fire Protection exam will transition to computer-based testing in October 2020. This will be a <u>single-day testing event</u> similar to paper-based exam administrations and the PE Nuclear and Petroleum computer-based exams administration. The <u>test date is Thursday, October 22</u>, 2020. Registration with NCEES for this exam began November 4, 2019. Examinees may reserve their seat at a Pearson VUE test center once they are registered with NCEES and approved by their board. Member Boards who manually approve candidates are encouraged to approve candidates as they register to allow them to reserve their seat for this single-day event as early as possible. The PE Nuclear and Petroleum exams will be offered on the same day.
- **PE Mining and Mineral Processing**—The PE Mining and Mineral Processing exam will be offered for the <u>last time in pencil-and-paper format in October 2020</u> and transition to <u>CBT in October 2021</u>.
- **PE Electrical and Computer**—The PE <u>Electrical and Computer exams will be offered for the last time</u> in <u>pencil-and-paper format in October 2020</u>. The <u>Power exam will transition to CBT in April 2021</u> and the <u>Electronics, Controls, and Communication exam and the Computer exam will transition to CBT in October 2021</u>.

### Spring 2020 Exam Changes

As a reminder, the following changes are in place for the first half of 2020.

- Fundamentals of Surveying—The FS exam will have new specifications starting in July 2020. The specifications will be posted on the NCEES website early in January 2020.
- Fundamentals of Engineering—The FE exam will have new specifications starting in July 2020. The specifications will be posted on the NCEES website early in January 2020.
- PE Chemical—The PE Chemical exam will have new specifications starting in January 2020. The specifications are posted on the NCEES website.
- **PE Mechanical**—The PE Mechanical exam had its <u>last paper administration in October 2019</u>. Beginning November 4, 2019, examinees were able to register and schedule CBT appointments, which <u>will be available</u> year-round starting April 1, 2020.
- **PE Agricultural and Biological**—The PE <u>Agricultural and Biological exam</u> will be offered for the <u>last time in pencil-and-paper format in April 2020</u> and transition to <u>CBT in October 2021</u>.

### Spring 2020 NCEES Pencil and Paper Registration Deadlines

- Spring 2020 Exam Dates—The spring pencil-and-paper exams will be administered on April 17 and 18, 2020. The PE exams and the Vertical Forces component of the SE exam will be administered only on Friday, April 17. The Lateral Forces component of the SE exam will be administered only on Saturday, April 18. Any other requests for deviations from the schedule must be submitted to Bob Whorton, P.E., Manager of Compliance and Security, at <a href="mailto:bwhorton@ncees.org">bwhorton@ncees.org</a>.
- Spring 2020 Registration—Registration for the spring exams opened on December 9, 2019, and closes for examinees at 3:00 p.m. eastern time on February 20, 2020. The deadline for boards/testing services to mark candidates approved and confirm shipping information is 3:00 p.m. eastern time on March 5, 2020. To meet the fulfillment and shipping requirements, we cannot add candidates after this time.
- **Special Accommodations**—All requests for testing accommodations must be submitted through the E3 system by the registration deadline of **February 20**, **2020**. These include accommodations for ADA and religious reasons and for active military service. More information about special accommodations is posted on the NCEES website. Member boards/testing services must provide site-specific details for approved ADA and religious accommodations to ensure that correct information is shown on a candidate's exam authorization.
- Exam Shipping—The earliest day an exam order will be delivered to a site is March 30, 2020. The last day an exam order will be delivered to a site is April 13, 2020. Inventory must be completed by April 14, 2020. A packing list will be included with each shipment, identifying the exam booklet serial numbers. Discrepancies between the packing list and the actual contents of the boxes should be reported to Bob Whorton at <a href="mailto:bwhorton@ncees.org">bwhorton@ncees.org</a> as soon as they are found.





#### What is the NCARB Legislative Guidelines and Model Law/Model Regulations?

The current NCARB Legislative Guidelines and Model Law/Model Regulations is one resource document made of three elements: The legislative guidelines, model law language, and model regulations language.

Initially adopted in 1970 at the request of several state boards, the legislative guidelines outline ideas accepted by the Council on nine significant areas of state regulation. Early in its consideration of state laws regulating the practice of architecture, NCARB concluded that guidelines were more appropriate than draft law language. Years later, NCARB added model law language to the legislative guidelines to illustrate the way in which guideline principles would fit into a statutory framework. However, it is important to note that the model law does not cover all matters appropriate to governing the licensing and regulation of architects.

To round out the legislative guidelines and model law language, the Council added the model regulations to show how the model law interacts with a set of board rules.

The NCARB Legislative Guidelines and Model Law/Model Regulations leave state boards flexibility and discretion to bring their states in line with the developing national standards for architectural licensure and regulation.

Why is this document a "model"? What is a "model law" or "model regulation"?

A model (law or regulation) is language meant to serve as a guide or template for subsequent legislation or rules. It is not usually meant to be enacted exactly as it is written, but is a suggestion to the various state and territorial legislatures from which they create their own law or rules.

#### What is a law?

A law is a general framework that establishes broad authorities within a government (e.g., federal, state, municipal, etc.) For instance, a law may establish an architectural regulatory board's authority to license and regulate architects.

Laws, also referred as statutes or acts, are developed by a jurisdiction's legislative branch (e.g., state legislatures) and approved and carried out by the executive branch (e.g., governors).

#### What is a regulation or rule?

A regulation or rule is the detailed execution of a law. For example, an architectural regulatory board has the power to create regulations and carry out the purpose of the law establishing licensing and regulation requirements for practice.

#### What is the difference between laws and regulations?

Laws tend to be broadly written, while regulations are much more detailed. In the case of architectural regulatory boards, the law should be at a high level and establish the board's broad authority, in contrast to the regulations, which should go into greater depth.

#### What are the similarities between laws and regulations?

Both are adopted with the intent of protecting the public's health, safety, and welfare. They are also both legally binding.

We hope this information is helpful and will share more resources in the coming months to aid with your review of the revised NCARB Model Law and Regulations resolution. #### Occupational Licensing Briefing

On Wednesday, November 13, 2019, the National Conference of State Legislatures (NCSL), the Council of State Governments (CSG), and the National Governors Association (NGA) held a



briefing of to highlight recent case study reports on occupational licensing reforms. The briefing attracted a variety of attendees from the Department of Labor, state regulatory boards, and national organizations. NCARB staff and several representatives from the Alliance for Responsible Professional Licensing of (ARPL) also attended.

Opening statements from the event hosts focused on loosening overall licensing regulations and barriers to entry. Representatives from NCSL, CSG, and NGA emphasized the increase in burdensome licensure requirements and mentioned their improved collaboration with states to engage on generic licensing reform.

American Institutes for Research (AIR) researcher Gauri Rege presented key findings from the NCSL Occupational Licensing Consortium Case Study Reports . The consortium consists of the following II states: Arkansas, Colorado, Connecticut, Delaware, Illinois, Indiana, Kentucky, Maryland, Nevada, Utah, and Wisconsin.

Many of the case studies from consortium states included enacted legislation intended to accommodate specific populations in their pursuit of licensure. For instance, Delaware and Wisconsin specifically examined the licensure process with regard to those with criminal backgrounds. Utah's case study focused on legislation to accommodate military service members and their spouses. Utah State Representative Norm Thurston then applauded the consortium and its effort to bring states together around a unified goal of reducing barriers to entry and creating economic opportunity.

Some of the case study results were informative and suggested credit to the consortium. However, the reform actions presented are proactive measures several architectural regulatory boards already use to improve licensure standards and regulations. NCARB continues to encourage Member Boards to regularly examine their statutes and regulations to maintain current and streamlined processes.

Although most of the case study reforms highlight areas that are being proactively addressed by Member Boards, legislative sessions occasionally bring forward efforts to loosen standards to an unwarranted degree. It is important to note that while participants in the consortium may also target "low hanging fruit" like occupations, NCARB and Member Boards continue to monitor legislative efforts that may have unintended consequences related to architects.

Fortunately, efforts to weaken licensure and regulatory standards generally lack the support necessary to affect a board's ability to protect the public health, safety, and welfare. NCARB is committed to engaging with groups like CSG, NCSL, and NGA to ultimately educate policymakers on the important role boards play as regulators. These flyers  $\mathbf{C}$  are also a great tool for boards to use to further engage their local policymakers with important data from a recent public perception survey  $\mathbf{C}$ .



#### Who's Afraid of Occupational Licensing?

Wisconsin State Representative Jonathan Brostoff recently authored an op-ed in *The Capital Times*. His piece, titled "Who's afraid of Occupational Licensing?," discusses ongoing trends around licensure and regulations. Brostoff affirms "the purpose of licensure is to protect the public's health and safety, as well as to protect consumers" and presents counterarguments to deregulation advocates' line of thinking.

The piece also strongly aligns with one of the primary goals of architectural regulatory boards—to protect the public, health, safety, and welfare. Not only does Brostoff express the necessity for reasonable standards to protect the public, but he also emphasizes strong economic factors to consider. He highlights the results of a recent survey commissioned by the Wisconsin Department of Safety and Protection that includes important statistics from state licensees. Of the individuals surveyed, Brostoff cites that "84.3% of respondents indicated that their license was 'extremely,' 'very,' or 'somewhat' useful in increasing their wages or salary." While this differs from both NCARB and our Member Boards' focus on public protection, he provides data points to support the connection between licenses and increased wages, in contrast to arguments often provided by those seeking to weaken licensure standards.

Brostoff goes on to ensure that while licensure and regulation proponents were "able to defeat the push for deregulation" last session, they will continue the effort this coming session as well.

#### Legislative Update

- Missouri Senate Bill 560 © —Recently introduced, this bill would require professional licensing boards to issue permanent licenses to nonresident military spouses. The Missouri Board For Architects, Professional Engineers, Professional Land Surveyors and Professional Landscape Architects currently provides accommodations for active duty members of the military, veterans, and their spouses, such as a temporary courtesy license. Upon meeting specific criteria, this bill would require a board to issue a permanent license rather than a temporary license. This bill was pre-filed on December 1, 2019.
- Missouri Senate Bill 673 Similar to Missouri Senate Bill 560, this bill intends to provide additional accommodations for nonresident military spouses. Under current law, and upon meeting specific criteria, the board is required to waive any examination, education, or experience requirements for reciprocal licensure within six months for a licensure applicant. This bill would reduce the review time from six months to 90 days for eligible nonresident military spouses. This bill was pre-filled on December 1, 2019.
- Ohio Senate Bill 246 @ —Modelled after a recently passed Arizona bill @, Ohio Senate Bill 246 intends to modify paths to licensure for those seeking to offer services in the state. Currently, the Ohio Architects Board allows for applicants to pursue reciprocal licensure if they, among other requirements, are "licensed or registered as an architect in another state or jurisdiction." However, this bill would amend the aforementioned reciprocity provision and replace "state" or "jurisdiction" with "country." This may cause internal inconsistencies as the bill also proposes changing an examination-related statute to include reciprocity accommodations for



domestic applicants. Because the bill proposes changes to an already streamlined licensuré process, NCARB has provided support and resources for the board to educate legislators on the effectiveness of Ohio's current licensure and reciprocity arrangements. We will continue to monitor its progress and inform you of any pertinent developments.

## Board approves 2019-20 exam item costs

THE NCEES BOARD OF DIRECTORS RECENTLY APPROVED values for each exam item for fiscal year 2019–20, which began October 1. The values are calculated in three groups: multiple-choice items for exams administered via computer-based testing, or CBT; multiple-choice items for pencil-and-paper exams; and constructed response, or essay, questions for pencil-and-paper exams.

The following are the exam item costs for 2019-20:

- CBT item cost: \$2,123
- Pencil-and-paper exam item cost for multiple-choice items: \$1,897
- Pencil-and-paper exam constructed response: \$17,448

Each year, NCEES assesses the potential financial damages associated with an exam breach and sets a cost to replace an exam item, or question, if it can no longer be used. NCEES considers travel expenses, subject-matter experts' time, psychometric costs, and office and personnel costs when establishing the dollar value of each exam item.

#### 2020 approved calculators

NCEES recently approved the calculator models that can be used on computer-based and pencil-and paper exams in 2020:

- Casio: All fx-115 and fx-991 models (Any Casio calculator must have "fx-115" or "fx-991" in its model name.)
- Hewlett Packard: The HP 33s and HP 35s models, but no others

■ Texas Instruments: All TI-30X and TI-36X models (Any Texas Instruments calculator must have "TI-30X" or "TI-36X" in its model name.)

Limiting the types of calculators allowed in the exam room is one of the measures NCEES takes to protect the integrity of its exams.

Spring 2020 exam changes
The new year will usher in several changes to NCEES exams:

- The Principles and Practice of Engineering Chemical exam has new specifications starting in January 2020.
- With the final pencil-and-paper administration completed in October, registration for the computer-based PE Mechanical exam opened November 4.

  Examinees can now schedule CBT appointments, which will be available year-round starting April 1, 2020.
- The PE Civil exam's transportation module has updated design standards starting in April 2020.
- The Fundamentals of Engineering and Fundamentals of Surveying exams will have new specifications starting in July 2020. The specifications for these exams will be updated on nees org January 1, 2020.

#### CBT conversion timetable



Preliminary results of Group B voting in person and online have been announced by the Code Council With the completion of the 2019 Group B Public Committee Hearings in Las Vegas October 23-30 and the post-hearings online voting, the International Code Council recently released the preliminary results which will shape the 2021 International Codes. Keep in mind they are not final as they have yet to be certified by the Validation Committee and confirmed by the ICC Board of Directors (in accordance with Section 10.1 of Council Policy 28 Code Development). The 2019 Group B Final Action results, including vote tallies from the OGCV, will be posted following certification in accordance with Section 10.4 of CP 28.

DOE report announces that 2018 International Energy Conservation Code helps produce cost savings The U.S. Department of Energy (DOE) recently announced the 2018 International Energy Conservation Code (IECC) will improve energy efficiency in residential buildings. In support of this determination, DOE conducted technical analysis evaluating the impacts of the updated code relative to the previous 2015 edition. DOE estimates national savings of approximately:

- 1.97 percent energy cost savings
- 1.91 percent source energy savings
- 1.68 percent site energy savings

Upon publication of an affirmative determination, states are required to certify that they have reviewed the provisions of their residential building code regarding energy efficiency, and made a determination as to whether it is appropriate for them to revise their code to meet or exceed the updated edition of the IECC. <u>Click here for a Building Safety Journal news feature</u> on the IECC authored by Michelle Britt, ICC Director of Energy Programs.

April 1 is the deadline to submit applications for the prestigious Emory R. Rodgers Fellowship
The deadline to submit applications to receive the 2020 Emory R. Rodgers Leadership in Building Safety
Fellowship Award is April 1. Emory R. Rodgers spent more than four decades devoting himself to the
building safety profession and to the creation and ongoing development of the International Codes. As a
leader in the industry and in the Code Council community, he put forth unprecedented efforts in
educating and preparing the next generation of building safety professionals. This Fellowship is available
annually to a building safety professional, who has embarked upon a demonstrated executive-level
career path, and wants to further develop leadership skills through an eligible executive development
program. The Fellowship will afford up to \$20,000 dollars to cover the full cost of the educational
program and the award recipient's travel to and from the program. The 2019 recipient of the award was
Chris Landreth, Supervising Building and Fire Inspector for the City of Tracy, Calif. Read more here.

**2020** budget packages have several appropriations that are important to America's built environment The U.S. Congress recently passed and President Donald Trump signed into law two spending packages for fiscal year 2020, including an appropriations agreement which funds several programs that benefit the building safety industry and which the International Code Council supported through engagement with lawmakers. They include:

- A \$100 million increase to \$3.4 billion total for the <u>Community Development Block Grant</u>
   <u>Program</u>, which funds code adoption and enforcement activities at the state and local levels.
- A \$167 million increase in funding for the National Institute of Standards and Technology (NIST). The Institute's Science and Technical Research and Services received a \$29.5 million boost over current levels. NIST's disaster resilience grants were preserved and current funding levels will allow NIST's premise plumbing research to continue.
- An \$80 million increase in FEMA preparedness grants to \$2.9 billion, including a \$35 million increase to \$560 million for the State Homeland Security Grant Program and a \$5 million increase to \$355 million for the Assistance to Firefighters Grant Program, staffing for an adequate Fire & Emergency Response Grant Program, and Emergency Management Performance Grant Program, respectively.
- A \$20 million increase to \$1.26 billion for Perkins career and technical education state grants.
- A \$1.6 million increase to \$4.5 million for <u>WaterSense</u>, which the International Green Construction Code leverages and which is supported by both the International Accreditation Service and ICC Evaluation Service products.

• A \$3 million increase to \$10 million for the Department of Energy's <u>Building Energy Codes</u>

<u>Program</u>, which supports the development and implementation of the IECC.

The appropriations legislation also extends from December 31, 2017, to December 31, 2020, the 45L tax credit for new homes that are 50 percent more efficient than the 2006 IECC and, over the same period, the 179D tax deduction for efficiency improvements to commercial buildings. The Code Council looks forward to continuing to work with the federal government, our members and our partners to aid in efforts to improve building safety and resilience. Advisory Council urges FEMA to partner with ICC to protect safety and property with current codes The Federal Emergency Management Agency's (FEMA) statutorily established National Advisory Council (NAC) recently urged the agency to partner with ICC to raise awareness of codes' mitigation benefits. The report recommended FEMA to encourage up-to-date codes in grant programs that improve community preparedness and resilience. In the aftermath of Hurricane Katrina, the U.S. Congress required the establishment of the NAC—a 35 member cross-section of officials, emergency managers, and emergency response providers from state, local, tribal and territorial governments, the private sector and nongovernmental organizations—to advise FEMA. The Code Council participates in the NAC's recommendation development process and presented before the NAC in October. According to FEMA, roughly two-thirds of communities that face hazard risk have not adopted hazard resistant codes. Many studies have demonstrated the extensive loss avoidance benefits current codes provide. Read more here about this ongoing effort.

ICC joins stake holders in U.S. House testimony on the National Windstorm Impact Reduction Program Virtually every state of our nation experiences some variety of windstorm, and from 1980 to 2017, these natural disasters have resulted in over 5,000 fatalities and \$1 trillion in economic losses. That's why recent testimony from ICC and stake holders before the U.S. House of Representatives' Subcommittees on Research and Technology and Environment stressed support for the reauthorization of the National Windstorm Impact Reduction Program (NWIRP). The program is implemented through a coordinated effort between federal agencies, academia, and private sector organizations such as the International Code Council. The Federal Emergency Management Agency (FEMA), National Institute of Standards and Technology (NIST), National Oceanographic and Atmospheric Administration (NOAA) and National Science Foundation are all participants. The program supports the development, adoption and enforcement of building codes and other mitigation strategies. "Building codes have been recognized as a highly cost-effective hazard mitigation measure," Ryan Colker, ICC Vice President of Innovation and Executive Director of the Alliance for National and Community Resilience (ANCR). "We stand ready to support this Committee and the NWIRP agencies in achieving shared goals of better understanding windstorms and assessing and reducing their impacts." The Congressionally-established National Institute of Building Sciences found that adopting the 2018 International Building Code and International Residential Code, which govern commercial and residential construction and renovations, provided \$10 in mitigation benefits against hurricane winds for every \$1 invested. Defense legislation leverages a model maintenance code to improve conditions in military housing Congress recently passed and the President signed into law the House-passed National Defense Authorization Act (NDAA) for fiscal year 2020, which authorizes funding and policies for U.S. Department of Defense (DOD) programs and requires that privatized military housing meet or exceed requirements set by a nationally recognized, consensus-based, model property maintenance code, such as the International Property Maintenance Code (IPMC). Separately, DOD recently updated its building code, the Unified Facilities Criteria (UFC), to use the 2018 International Building Code, 2018 International Existing Building Code and 2018 International Plumbing Code. The UFC had previously required using the 2015 versions of these codes. The UFC establishes common requirements for DOD construction activities, and addresses safety, functionality and durability. International Code Council and RESNET create new voluntary certification for building safety industry. The International Code Council and the Residential Energy Services Network (RESNET) developed a new certification designation, the International Energy Conservation Code (IECC)/Home Energy Rating

System (HERS) Compliance Specialist. This certification combines the energy code knowledge of code officials with the energy efficiency knowledge of HERS Raters to identify experts in energy plan review and inspection. The credential leverages the strengths of both organizations to increase the number of qualified individuals available for evaluating energy code compliance and home energy performance. The IECC/HERS Compliance Specialist designation verifies competence in energy performance measurement and energy code proficiency. These certified specialists can supplement the work of jurisdictions facing resource constraints that affect their ability to conduct the necessary reviews. IECC/HERS Compliance Specialists may now be used for both code compliance and energy performance rating services. Read more about this innovative program here.





#### **Bill Tracking Updates**

In many jurisdictions, legislatures are either back in session or will be within the next few weeks. Between the start of these sessions and those legislatures operating on a two-year calendar, CLARB currently has about 139 bills on its tracker. CLARB's most recent report showing legislative activity from the past month is now available.

#### Most concerning bills so far this month:

VA - HB601 - Administrative Process Act: Review of occupational regulations

This bill creates a procedure by which a person may petition an agency to review whether an existing occupational regulation is necessary for the protection or preservation of the health, safety, and welfare of the public and meets other statutorily enumerated criteria.

VA - SB829 Governor, authority to reinstate professional licenses

This bill gives the Governor the power to reinstate the license for any profession regulated by an executive branch agency that has been revoked by such agency. The Governor shall establish a process by which a person who has had their professional license revoked by an executive branch agency may apply to have their license reinstated. Each executive branch agency shall assist the Governor in the administration of such process.

WA - HB2355 Creating alternative professional licensing standards

This bill authorizes the department of licensing to develop a competency-based assessment which allows individuals to demonstrate proficiency of the knowledge and skills otherwise required by an occupational licensing examination. Defines competency-based licensing as a practical assessment of knowledge and skills that clearly demonstrate a person is prepared to engage in an occupation or profession regulated by

the department, and which the director of the department of licensing determines is at least as effective as examination-based occupational licensing requirements at demonstrating proficiency and protecting the health and safety of the public.

WV - SB218 Creating the Occupational Licensing Consumer Choice Act

This bill is a re-hash of one that failed in WV last year. It creates the Consumer Choice Act, allowing practice of a licensed profession by an unlicensed person who has disclosed in writing to the client that they are not licensed. Defines: Lawful Occupation, Nonlicensed Disclosure, etc. Includes statements to be signed by nonlicensed persons and clients and remedy for damages via small claims or district court. Act does not apply to medical professionals.

CLARB stands ready to support all members – let us know what we can do to help. In the meantime, we encourage you to remain vigilant, continue relationship building, and proactively educate about how regulation protects the public's health, safety and welfare. <u>Licensure support tools</u> can be found on the CLARB website.
