HEARING TRANSCRIPT

The hearing started at 8:33 a.m. on May 12, 2017; In the matter of Case 17-01 Failure to Report Discipline on the part of Stephen P. Maslan. This hearing is being held pursuant to the legal authority and jurisdiction granted to the South Dakota Board of Technical Professions (Board), under Chapter 1-26 which is the administrative procedures act of the South Dakota Code, Chapter 36-18A of the South Dakota Code, which is the Technical Professions License Law and ARSD 20:38 which are the Administrative Rules of the South Dakota Board of Technical Professions.

The following Board members were present: Chairman Steve Williams, Vice Chairman Steve Peters; Secretary Mike Albertson; Steve Thingelstad; Jeff Nelson; and Dennis Micko. Board member Alissa Matt was not in attendance. Others present were Staff Attorney Graham Oey and staff members, Kathryn Patterson, Tamara Moore and Susan Neuf.

The licensee failed to appear at the scheduled time of the hearing, no legal representative attended on the licensee's behalf, and no notice of intent to attend or request to change the scheduled hearing was received from the licensee.

This is a formal administrative hearing, therefore, all testimony presented at this hearing will be sworn and all exhibits must be admitted into the record through the Chair. This hearing is an adversarial proceeding as far as possible. Any party to this hearing has the right to be present and to be represented by legal counsel. Each party will have reasonable opportunity to inspect documentary evidence and present evidence in support of that party's interest and shall have the rights ordinarily afforded parties at hearings. The purpose of this hearing is to determine if Mr. Maslan has violated South Dakota licensing law or administrative rule, and is subject to discipline by the Board. The specific sections of law that are alleged to have been violated are SDCL 36-18A-56 subdivisions (6) and (21), and ARSD 20:38:36:01 subdivisions (1), (11), (12), and (33).

Due to the possible suspension or revocation of a license, the standard of proof in this case is clear and convincing evidence, which is more than preponderance of the evidence and less than beyond a reasonable doubt.

Since the Board has the burden of proof in this case, Staff Attorney Oey will present evidence on behalf of the Board. Afterward, the Board will consider any evidence that Mr. Maslan has submitted.

Kathryn Patterson, Executive Director for the South Dakota Board of Technical Professions, was sworn in as a witness by Chairman Williams. Staff Attorney Oey asked Patterson questions regarding Mr. Maslan, such as his current license status, history of violations, and disciplinary action taken by boards in other jurisdictions.

Staff Attorney Oey offered Exhibit 1 and 2 into the record as certified public documents that are self-authenticating.

Exhibit #1 is a certified copy of the Missouri state Settlement Agreement dated October 22, 2009; Findings of Fact and Conclusions of law for Probation violation in case 13-001, dated February 24, 2014; and Findings of Fact and Conclusions of law for Probation violation case 2008-00279, dated December 8, 2014.

Exhibit #2 is a certified copy of the Kansas state Settlement agreement and Consent order for case number 10-20; Modified Settlement agreement and Consent order for case 10-20; Final order for case number 12-06; and Final order for case number 15-32.

Exhibits 1 and 2 were reviewed individually and received into evidence by Chairman Williams.

Staff Attorney Oey opened up the witness to questions from the Board.

Micko: It is my understanding that we would be taking reciprocal action? Or would we be taking action as a result of Mr. Maslan perjuring himself on his renewal application?

Staff Attorney Oey: Mainly taking reciprocal action based on his violations in other jurisdictions, but also because he failed to report his disciplinary actions. In other US jurisdictions, he violated the terms of his professional services in practicing in areas beyond his competency, failed to comply with the license laws governing professional practice, and failed to approve and seal only documents that conform to accepted standards. He also failed to notify this Board within 30 days of his disciplinary actions.

Chairman Williams: If Lunderstand Exhibit #1 correctly, he's actually had three different instances of doing things in Missouri that are not right?

Kathryn Patterson; They had placed him on probation and he didn't comply with his probation he went outside the probation, and they came back and took his license for not meeting the terms of his probation.

Chairman Williams asked if there were any more questions for Patterson. Receiving no further responses, Chairman Williams dismissed Patterson as a witness

Staff Attorney Oey stated the closing arguments.

GUIDELINES FOR CERTIFYING, SEALING, SIGNING AND DATING DOCUMENTS PREPARED BY LICENSED TECHNICAL PROFESSIONALS IN SOUTH DAKOTA

Introduction. This document was prepared to provide recommendations and guidance to licensees regarding certifying, sealing, signing and dating various documents prepared by licensed technical professionals. Except for direct excerpts from South Dakota Codified Law (SDCL) and Administrative Rules of South Dakota (ARSD) contained herein, this guide document is not intended to be prescriptive in nature. If any person has any comments or suggestions regarding this guide document, please forward such comments or suggestions preferably in writing to the Board office at the addresses provided above.

Which technical professionals are required to use a seal in South Dakota? According to SDCL 36-18A-44, architects, engineers, land surveyors, and landscape architects who are duly licensed in South Dakota are required to use a professional seal on appropriate documents prepared by them or under their direct supervision. Although also licensed in South Dakota by the Board of Technical Professions, petroleum release assessors and petroleum release remediators shall <u>not</u> use a professional seal indicating licensure as assessors or remediators. However, assessors and remediators are still required to certify (if appropriate), sign and date appropriate documents prepared by them or under their direct supervision.

Why do we certify, seal, sign, and date technical professional documents?

- A certification statement may be required in some cases and may otherwise be optional. The certification statement is used to stipulate that to which the signer is certifying or attesting.
- The seal is used to authenticate a document for its intended purpose by using a mark (seal) which is unique to the person who is authenticating it and shows the authorization (license) held by the individual which enables the individual to prepare and authenticate the document.
- The seal provides basic information regarding the person who is authenticating the document, which is the name, license number, technical profession in which the license is granted, and the state granting the license.
- The name on the seal is supplemental to the signature, which signature may not be sufficiently legible to the reader for correctly identifying the name of the signer.
- The signature validates and authorizes the document for its intended use, as well as verifies that the seal has been applied personally or as specifically directed by the licensee whose name appears on the seal.
- The date provides the day on which the document was authorized for its intended use by the licensee by sealing and signing the document.

What does application of the seal, signature, and date with or without a certification statement mean? According to SDCL 36-18A-45, "the application of the licensee's seal and signature and the date constitutes certification that the work on which it was applied was done by the licensee or under the licensee's responsible charge."

Why is a certification statement sometimes used? Although not generally required by laws and rules, certification statements can be used by licensed technical professionals to stipulate that to which they are certifying and, in some instances, may also stipulate items or conditions which they are excluding from the certification. In some cases, specific laws or regulations relating to a specific type of document may require a certification statement to accompany the seal, signature and date of the technical professional who personally prepared or was in responsible charge of the preparation of the document.

Why is a "Purpose" declaration sometimes used: Where appropriate, it is recommended that licensees indicate the intended purpose of the document in bold letters on each sheet of the document. Examples of purpose declarations follow: PRELIMINARY; FOR REVIEW ONLY; PRELIMINARY-NOT FOR CONSTRUCTION; FOR BIDDING ONLY; FOR BIDDING AND CONSTRUCTION; AS-BUILT DRAWING; RECORD DRAWING; etc. This list is intended for examples only and is not intended to be a comprehensive list of all "purpose" declarations that might be appropriate or that any "purpose" declaration is needed at all.

"Prepared By" information: It is recommended that all sheets of drawings contain "Prepared By" information, which at a minimum should include the words "Prepared By", name of licensee, title of profession and SD license number (i.e. PE-SD#00000), phone number, and date. Other optional information could include name of firm, email address, and mailing address. The "Prepared By" information is intended to more completely identify the licensee who is signing and sealing the document, as well as provide minimum contact information to the reader/user of the document.

Alternate Methods of Sealing and Signing Documents: The following describes alternate methods for sealing, signing and dating plans and other technical profession documents:

- 1. Wet ink seal and wet ink signature and date.
- 2. Electronic facsimile of seal and wet ink signature and date.
- 3. For electronic submittals, an electronic facsimile of seal <u>and</u> an electronic facsimile of signature and date, providing that the electronic facsimile of the signature is applied to the drawing or document by the licensee who is responsible for that drawing or document or by another person under that licensee's direct personal supervision who has been instructed by the licensee so to do.
- 4. For electronic submittals, an electronic facsimile of seal or "digital" seal <u>and</u> a "digital" signature and date in accordance with SDCL 36-18A-45.1.

Single-profession plan documents with one licensee in responsible charge: Single-profession plan documents with one licensee in responsible charge should contain the seal, signature and date on every sheet. It is recommended that all sheets in the document be identified as being part of that document by name of project, project number, and sheet number corresponding to the list of sheets on the cover sheet; and that each sheet after the cover sheet contain "Prepared By" information on each sheet. If appropriate and needed, each sheet should also include a "Purpose" declaration fitting the purpose of the document.

Single-profession plan documents with two or more licensees in responsible charge: Single-profession plan documents which require the seal/signature of two or more licensees in responsible charge of portions of the document should contain the seal, signature and date on those sheets that each licensee is responsible for. It is recommended that all sheets in the document be identified to be part of that document by name of project, project number, and sheet number corresponding to the list of sheets on the cover sheet; and that each sheet after the cover sheet contains "Prepared By" information on each sheet. If appropriate and needed, each sheet should also include a "Purpose" declaration fitting the purpose of the document.

Multi-profession plan documents with two or more licensees in responsible charge: Multi-profession plan documents which require the seal/signature of two or more licensees in responsible charge of the various professions of the document should be sealed, signed and dated on the cover sheet by the "prime professional" who has overall coordination responsibility for the multi-profession project, along with a certification that stipulates that said licensee is the "prime professional" responsible for the project. Each sheet after the cover sheet should then be sealed, signed and dated by the licensee who has responsible charge for that sheet. All sheets in the document should be identified to be part of that document by name of project, project number, and sheet number corresponding to the list of sheets on the cover sheet; and each sheet after the cover sheet should contain "Prepared By" information on each sheet. If appropriate and needed, each sheet should also include a "Purpose" declaration fitting the purpose of the document.

Specifications documents: Specifications documents which often accompany plan documents typically contain various documents related to the bidding and contracting for construction of the project, as well as specifications for the various components which are part of the project and performance requirements for constructing the project. For single-profession projects, it is recommended that the title page or other appropriate page contain a certification statement stipulating the licensee(s) in responsible charge of either the entire document or specified portions of the document in the case of two or more licensees in responsible charge. For multi-profession projects, it is recommended the title page or other appropriate page contain a certification and seal for the "prime professional" responsible for coordinating the entire project and the portion of the specification prepared by the prime professional. For sections of the specifications prepared by licensees in the other professions involved in the project, it is recommended that the licensee in responsible charge of each profession certify and seal the first page of that section of the specification. Finally, since it is common for portions of the specifications to be extracted from the specifications book and transmitted to specific interested parties during the bidding and construction process, it is recommended that consideration be given to using either a header or a footer on each page, as appropriate, to provide basic identification and contact information. At a minimum, it is recommended that consideration be given to including the following in said header or footer: project number, name and location plus "Prepared By" information as described above. With the header or footer, if any page(s) are extracted from the entire document, it will always be possible to identify the source document from which that portion was extracted as well as contact information for the licensee preparing that portion of the specification.

Report documents: Report documents are often prepared for studies or preliminary investigations performed by technical professionals. It is recommended that the title page or other appropriate page contain a certification statement stipulating the licensee(s) in responsible charge of the entire document. If there is concern that portions of the report may be extracted from the report book and transmitted to specific interested parties, then it is recommended that consideration be given to using either a header or a footer on each page, as appropriate, to provide basic identification and contact information. At a minimum, it is recommended that consideration be given to including the following in said header or footer: report name and location plus "Prepared By" information as described above. With the header or footer, if any page(s) are extracted from the report document, it will always be possible to identify the source document from which that portion was extracted as well as contact information for the licensee who prepared the report.

Record plans: Record plans (sometimes also referred to as as-built drawings) are often prepared by the technical professional after construction of the project has been completed. It is recommended that a disclaimer statement be used describing the source and accuracy of the record information. Record plans are not normally signed and sealed, unless specifically required by the Owner.

Shop drawings: Generally speaking, shop drawings are not required to be sealed. However, if the person preparing the shop drawing is a licensed technical professional, then it would be appropriate for said person to seal the shop drawing. Also, if the specifications specifically require that a shop drawing be prepared by a licensed technical professional, then the shop drawing should be sealed and signed by the licensed technical professional who is in responsible charge of the preparation of the shop drawing.

Survey plats and other recordable survey documents: Single sheet survey plats will normally contain the surveyor's certification which is signed, dated and sealed by the licensed land surveyor, as well as the prepared by information required for recording. It is recommended that multiple sheet survey plats contain the title of the plat along with Sheet # of # Sheets and the prepared by information required for recording on each sheet of the plat and that multiple sheet plats then be signed, dated and sealed by the licensed land surveyor in the surveyor's certification only. Other recordable documents, such as easement exhibits and certified corner records, are normally sealed on each sheet.

SIZE AND TYPES OF SEALS

Size of seal: According to SDCL 36-18A-44, "the seal shall be legible and shall have an outer circle with a diameter measuring at least one inch and no greater than two inches as well as an inner circle with a diameter measuring five-eighths of the diameter of the outer circle."

Rubber stamp seal: A rubber stamp seal has in recent history been the most commonly used type of seal. With this type of seal, the seal is imprinted on the document by first wetting it with ink on an ink pad and then pressing the rubber stamp seal onto the document.

Electronic facsimile seal: An electronic facsimile seal is an electronic seal image (commonly created in CAD software) and included on the CAD drawing of the sheet.

Copied seal: A copied seal is a reproduction of the seal which results from photocopying, blueprinting, or digital scanning the original document which bears a licensee's seal.

Digital seal: A digital seal is an electronic image of a seal which is encoded and linked to a digital signature (as described below) in an electronic document in such a way that if the electronic document file is altered in any way, both the digital signature and the digital seal are invalidated.

Embossed seal: An embossed seal is a device which crimps the paper to imprint the seal. This type of seal is rarely used for documents sealed by technical professionals.

TYPES OF SIGNATURES

Wet-ink signature: A wet-ink signature is the hand scribed signature of the signer on the document typically using an ink pen of some appropriate type. Wet-ink signatures are normally used on the original copy of the document, or on multiple original copies when multiple originals are required.

Electronic facsimile signature: An electronic facsimile signature is an electronic image of the licensee's signature which is placed on the CAD drawing of the sheet by the licensee or by another person under the direct personal supervision of the licensee and who has been instructed by the licensee so to do.

Copied signature: A copied signature is a reproduction of the signature which results from photocopying, blueprinting, or digital scanning the original document which bears a wet-ink signature.

Digital signature: A digital signature is an electronic image of the signer's signature which is encoded with the electronic document in such a way that if the electronic document file is altered in any way, the digital signature is invalidated.


SECURITY OF SEALED DOCUMENTS

Security concerns might consist of possible altering of sealed documents by unauthorized parties as well as forgery of the seal and signature. In the past, best business practice has been for the technical professional to keep an original copy of the signed and sealed document on file. In some cases, the project owner may also require an original copy of the signed and sealed document for the owner's file. Digital signature technology may also be used to enhance security of signed and sealed documents that are delivered as electronic files.


APPENDIX A EXAMPLES OF SEALS

(refer to SDCL 36-18A-44 for specifications and allowable variations)

Large-size seal (2.0" OD, 1.25" ID): The large-size seal is most appropriate for larger sheets (i.e. 22"x34" or larger), which typically have room for the 2" OD seal and which sheets may possibly be printed at reduced scale (up to half size reduction) at some later time.



Mid-size seal (1.5" OD, 0.94" ID): The mid-size seal is appropriate for general use on all documents, as long as the sheet size will most likely never be reduced or will not be reduced by more than two-thirds of the original size causing the seal size to be less than 1" OD on the reduction.



Small-size seal (1.0" OD, 0.63" ID): The small-size seal is the smallest seal size which is deemed to remain legible to the naked eye. This size is appropriate for small size documents generally ranging in size from 8.5"x11" to 11"x17", as long as the original sheet size will likely never be reduced.



APPENDIX B EXAMPLES OF CERTIFICATIONS

The following certifications are provided as examples only. The wording of certifications may be adjusted to fit the purpose of the document and the intent of the licensee in certifying, sealing, signing, and dating the document. Since such certifications have possible legal impacts as part of the sealing and signing process, licensees may choose at their own discretion to seek legal counsel on the wording of certifications which they are signing and sealing.

General Certification

I hereby certify that this plan, specification or report was prepared by me or under my direct personal supervision and that I am a duly Registered (insert title of profession) under of the laws of the State of South Dakota. (this certification is then followed by typed name of licensee and Reg. No., signed, dated, and sealed)

Prime Professional Certification

I hereby certify that this plan, specification or report was prepared by me or under my direct personal supervision and that I am a duly Registered (insert title of profession) under of the laws of the State of South Dakota serving as the prime professional in responsible charge for coordinating all professional activities related to this project. (this certification is then followed by typed name of licensee and Reg. No., signed, dated, and sealed)

Surveyor Certification on a recorded subdivision plat

SDCL 11-3-4 concerning certification, acknowledgment and recording of plats states as follows: "Every plat provided for in this chapter shall be certified by the registered land surveyor, who shall attach an official seal thereto as specified in § 36-18A-45 as being in all respects correct. The landowner, or the landowner's duly authorized agent, shall certify that the plat has been made at the request and under the direction of the landowner for the purposes indicated therein, that he or she is the owner of all the land included therein, and that development of this land shall conform to all existing applicable zoning, subdivision and erosion and sediment control regulations. The landowner certification shall be acknowledged before some officer authorized to take the acknowledgment of deeds and, with the certificate of such acknowledgment, shall be endorsed on or attached to the plat and be recorded as a part thereof in the office of the register of deeds of the proper county."

Land surveyors should consult with specifications for plats and certifications by the surveyor, property owner, and approving agencies which may be contained within subdivision ordinances or other requirements of the jurisdiction within which the property being platted is located.





Experienced designers can now take advantage of the online AXP Portfolio—a new method of satisfying the Architectural Experience Program's (AXP) requirements. Traditionally, licensure candidates must report hours within eight months to earn full credit toward the requirement, or up to five years back to earn half credit. However, the portfolio provides an option for designers with experience beyond five years to complete the AXP. Along with NCARB's recently launched education alternative to certification, the AXP Portfolio is part of an ongoing initiative to offer advancement opportunities to licensure candidates and architects from all career paths.



Applicants who pursue the AXP Portfolio method must:

- Have a current supervisor who is an architect licensed in the United States or Canada and willing to attest to the applicant's knowledge and experience.
- Have at least two years of experience from over five years ago, including at least one year of experience earned under the supervision of an architect licensed in the United States or Canada while employed by a firm engaged in the lawful practice of architecture.

The AXP Portfolio helps the profession become more inclusive while maintaining the rigor needed to protect the public's health, safety, and welfare. To learn more about the AXP Portfolio, visit www.ncarb.org/AXPPortfolio.

Final ARE 5.0 Cut Score Reports Released

Score reports for the two remaining divisions of ARE 5.0—Project Management and Construction & Evaluation—were released May 4, 2017. The release of these final two divisions' score reports marks the end of the ARE 5.0 cut score process. All ARE 5.0 score reports will now be released on an ongoing basis, typically within three business days of testing. Thanks for all you've done to support the launch of ARE 5.0!

2016 Survey of Architectural Registration Boards

Thanks to the contribution of each Member Board, we are proud to release the findings of the <u>2016 Survey of Architectural Registration Boards</u>. While the number of architects in the country dropped slightly (109,748 in 2016 compared to 110,168 in 2015), architects increasingly hold licenses in multiple states. U.S. architects now have 126,554 reciprocal (out-of-state) licenses, a 3 percent increase from 2015.

Every year NCARB collects data on the number of registered architects in the United States. This information helps Member Boards, collateral organizations, and press organizations assess and report on the state of the profession; the survey also brings attention to the value of the public health, safety, and welfare work your boards do. Thank you for supporting this report by providing us with the number of registered architects in your jurisdiction.

NCARB April 2017 Monthly Legislative Update is Available

The <u>April 2017 Monthly Legislative Update</u> is now available. This information enables you to review pending legislation in other jurisdictions. A common theme throughout this legislative update is the presence of the "Right to Earn a Living Act," which seeks to reduce the reach of occupational and professional licensing boards:

House Bill 3319 in Illinois, the "Right to Earn a Living Act," would require agencies
(state licensing boards included) to limit occupational regulations to only those
necessary and carefully tailored to meet public health, safety, welfare objectives.



If approved, this bill provides additional ways for an individual to petition the governor's regulatory review council to include the review of a rule based on their belief that it does not comply with state rulemaking procedures. The "Right to Earn a Living Act" was proposed in Nevada (Senate Bill 330) as well.

 In North Carolina, House Bill 590 would establish a practice act for interior design, and House Bill 701 would require licensing boards to adopt governing rules for hearings before they can suspend a license.

We will continue to closely monitor these bills and gather more information on their potential impact on Member Boards' authority. The complete list of bills summarized in April is in the "Legislation Tracking" library of the Registration Board section. [EXT] Is the future happening to regulation?

Colleagues,

In a <u>2013 interview</u>, Amazon CEO Jeff Bezos made the following observation on his company's disruption of the book market: "Amazon is not happening to book selling... the future is happening to book selling."

What if we changed that statement slightly to read: "Politicians/interest groups are not happening to occupational regulation...the future is happening to occupational regulation."

This assumes accelerating change will impact our community before we're adequately prepared, and that regulation may be disrupted from the outside to the public's detriment.

That's thinking differently about the future of occupational regulation! And it's a conversation that we need to have—and will have—at the upcoming Annual Meeting. More on this later.

First, let's take stock of where we are during this difficult season. At this writing, about 80% of state legislatures (thankfully our Canadian friends have not struggled with these challenges) are set to adjourn in May. Despite a record number of legislative proposals to deregulate or otherwise <u>disrupt</u> licensure the CLARB community remains relatively unscathed, with only <u>Arizona</u> and <u>Mississippi</u> enacting legislation that may prove to be problematic for boards and their stakeholders.

And it's not just landscape architects in the hot seat. A proposal to deregulate engineering was introduced in Montana and the Oregon State Board of Examiners for Engineering and Land Surveying is now being <u>sued by a citizen</u> (represented by the Institute for Justice) for practicing engineering without a license.

On the national level, the Federal Trade Commission's newfound activism and friendlier face continues to generate fodder for regulatory reform advocates. As an example, billionaire entrepreneur Mark Cuban recently tweeted out this to his seven million followers:





This is great. If the @FTC can eliminat the job killing state licenses it will creat jobs than any proposed program

And the U.S. Congress is getting into the act as well. The "New Hope Act," introduced by Senator John Cornyn (R-TX), would permit the use of federal job training dollars (\$9 million in Texas alone) on state regulatory reform efforts.

Yes, with apologies to Dorothy, we're not in Kansas anymore.

What have we learned from this five-month onslaught? Several things:

 The nature of the threat is changing from a direct assault on licensure to a more insidious form of disruption from within. Comparing this to the previous approach is like comparing an apple to an orange.



- We (and I mean the entire regulatory community) don't really understand the specific nature of the new threat, how to deal with it and what role regulators and their support systems should play. That said, I'm pleased that FARB CEOs and advocacy leaders will be gathering in July to discuss this critical topic.
- The threat is bringing together new allies (and strengthening existing alliances) who believe in the value of regulation in the public interest. Examples of this include:
 - Emergence of a Professional Licensure Coalition to push for federal relief for board members from treble antitrust damages.
 - Evolution of FARB into a more proactive resource (most recently evidenced by its
 inclusion in an expert panel to advise a federally-funded effort to assess licensure and
 recommend steps to remove barriers, improve portability and reciprocity).
 - Increased cooperation between CLARB, ASLA, NCARB, the National Society of Professional Engineers and others. The recent <u>editorial</u> in *Landscape Architecture* Magazine is an example of this and a model for other professional groups.
- The need for regulators to "find their voice" in the interest of protecting public health, safety and welfare. While the need for caution is understandable, our collective silence is not serving us

well. For example, legislators this session in Colorado and Washington both posited that the online consumer recommendation service <u>Yelp</u> could be an alternative to licensure for landscape architecture.

All this brings us back to Mr. Bezos' bold 2013 assertion that "the <u>future</u> is happening" to us. So how do we race with the future, rather than try to ignore, fight or outsmart it?

First, we need a runway. We can't change overnight (even if we knew the change we wanted to make) and the public needs protection <u>today</u>.

We can and will continue to do more to defend the integrity of regulation in the public interest—some of which we've described above. But that's not enough. That's where the Board of Directors' **empower members** strategy comes in.

While the profession must be the principal face of licensure advocacy, regulatory boards have much to contribute to the public's understanding of the value of good regulation. While the "what and how" may differ from jurisdiction to jurisdiction, all boards can "up their game" when it comes to being good partners.

Over the next several months, you'll see the initial foundations of this program put in place, leading to a more comprehensive effort through 2018 and beyond. Success will be measured by an increase in our members' ability to prepare for, and respond to, threats to regulation.

Another very practical resource to maintain regulatory relevance is the newly drafted <u>CLARB Model Law and Regulations</u>. This most recent re-write was done to address what we see as new and emerging issues in professional licensure—from initial access to professional practice, to mobility, to the board's ability to effectively execute its public protection role. I hope you can join the May 31 "<u>In the Know</u>" webcast to learn more.

So what about the future?

As leadership guru Marshall Goldsmith observed, "What got you here won't get you there." That's why the CLARB Board of Directors has introduced an innovative approach—borrowed from the private sector (and more specifically entrepreneurial disruptors) to isolate the friction associated with licensure and give us insights into how to eliminate or reduce what doesn't serve the public's interest. We refer to this exercise as **rethinking the licensure process and framework**, and it's a precursor to innovation.

Over the next several months, we'll be doing some basic, initial research that will culminate in a thought-provoking, fun workshop at the Annual Meeting. This will kick off a yearlong research project to identify and analyze the "friction points" in the process. While we don't have any specific solutions in mind, we'll be sharing and inviting ideas and concepts along the way and hope to have a most interesting and consequential conversation at the 2019 Annual Meeting in Toronto.

Yes, the future is happening to us. And we look forward to thinking differently with you to ensure that

regulation thrives.

Bottom Line Up Front

This is a request that you please review the attached map and provide us with any updates by the end of next week.

Background

As you know, the American Institute of Architects (AIA) recently <u>issued a statement</u> in support of two new titles to replace the term "intern" when referring to a candidate pursuing architectural licensure: "Architectural Associate" or "Design Professional." Many jurisdictions safeguard one or both of those titles in law or in regulation so that the public can rest assured that anyone authorized to hold themselves out as an "architect" has the necessary credentials to design buildings that protect the public health, safety and welfare.

In an effort to ensure licensure candidates do not simply adopt these titles and potentially subject themselves to prosecution or disciplinary action, NCARB would like to provide information to candidates and supervisors clarifying which jurisdictions have laws or regulations that conflict with AIA's policy statement. The attached map will be an important part of that communication and should help the community understand the facts on the ground while lessening the burden on you to have to answer lots of questions about the requirements in your states/territories.

Most of you have already responded to this request, we just wanted to take one last shot at making this map as up-todate and accurate as possible for maximum clarity and transparency.

If the map is accurate, we're all set but if you have any updates, please provide them back by the end of next week and feel free to let us know if you have any questions.



NCARB Launches Second Alternative Path to Architect Certification

Architects without a professional degree in architecture can now earn NCARB certification through an alternate path.

Washington, DC—The National Council of Architectural Registration Boards (NCARB) has launched the second phase of its revised certification path for architects without a degree from an accredited program. This newest path comes as part of a multi-year effort to streamline NCARB programs and initiatives to be more inclusive of individuals outside of the traditional path to licensure, while maintaining the rigor necessary to protect the public's health, safety, and welfare.

Through the new <u>NCARB Certificate Portfolio</u>, architects licensed in a U.S. jurisdiction who hold any education other than an architecture-related degree—including those who do not have a college degree—can satisfy the Certificate's education requirement by completing an online portfolio documenting learning through experience. The first phase, which launched in February 2017, enables architects with a four-year, architecture-related degree to satisfy the same requirement by <u>documenting two times</u> the Architectural Experience Program's™ (AXP™) hours.

"Professional mobility is a goal of many practicing architects," said NCARB President Kristine A. Harding, NCARB, AIA. "This revised path makes that goal achievable for a broader range of licensed individuals, while maintaining the quality standards expected by our boards and the public." Together, these alternative paths form the successor to the Broadly Experienced Architect (BEA) Program, which was retired in 2016.

The <u>NCARB Certificate</u> is a valuable credential for architects that facilitates reciprocal licensure across the 54 U.S. jurisdictions and several countries, among other benefits. To qualify for certification, applicants must meet the *NCARB Education Standard*, traditionally done by earning a professional degree in architecture from a program accredited by the National Architectural Accrediting Board (NAAB).

Both the NCARB Certificate Portfolio and two times AXP option are offered at no additional charge to active NCARB Record holders and eliminates the BEA's \$5,000 review fee. It also facilitates a shorter, more objective review process than the previous program, allowing applicants to link exhibits in the portfolio to specific areas outlined in the NCARB Education Standard. Applicants will also need to meet NCARB's experience and examination requirements to earn an NCARB Certificate.

U.S. architects interested in pursuing certification through the portfolio must have at least three years of continuous licensure in any U.S. jurisdiction without disciplinary action, and fall into one of two categories:

- Architects with post-secondary education who have obtained 64 or more semester credit hours. These applicants are required to obtain an <u>EESA evaluation</u> and submit a portfolio to address any deficiencies.
- Architects with less than 64 semester credit hours of post-secondary education. These applicants are not
 required to obtain an EESA and must address all education requirements through a portfolio.



Gender, Racial, and Ethnic Diversity Increases Among Emerging Professionals

Washington, DC—Licensure candidates and new architects are more diverse than ever before, according to new data from the 2017 edition of *NCARB by the Numbers*. Released annually by the National Council of Architectural Registration Boards (NCARB), the publication provides exclusive insight into the <u>number of U.S. architects</u>, the pool of candidates working toward licensure, and diversity in the profession.

Closing the Gender Gap

For the first time since NCARB began collecting demographics data, gender equity improved along every career stage—including gaining professional knowledge through the <u>Architectural Experience Program™</u> (AXP™), starting the <u>Architect Registration Examination</u>® (ARE®), and earning a license.







In 2016, women accounted for 47 percent of new AXP participants and 42 percent of new ARE candidates. While women remain underrepresented among practitioners and NCARB Certificate holders, they now account for 36 percent of newly licensed architects, compared to 34 percent in the previous year. According to 2015 estimates from the <u>U.S. Census Bureau</u>, women make up 51 percent of the U.S. population.

Racial and Ethnic Diversity

Racial and ethnic diversity is also increasing among licensure candidates, although at a slower pace.

Racial and Ethnic Diversity Along Career Stages



In 2016, 42 percent of new AXP participants and 30 percent of new ARE candidates identified as non-white—up three percentage points for both groups. However, diversity among newly licensed architects and NCARB Certificate holders remained the same. For comparison, 38 percent of the U.S. population identifies as either non-white or Hispanic, according to 2015 estimates from the <u>U.S. Census Bureau</u>.

"While several groups remain underrepresented within the profession, these trends point to growing diversity among licensure candidates, and eventually, future architects," said NCARB President Kristine A. Harding, NCARB, AIA. "In response, NCARB will continue to ensure our programs balance inclusivity with the rigor needed to protect the public."



The jury praised the project for incorporating both the design and build to respond to the true needs of the local Liberians.



NCEES awarded the University of Maine's Surveying and Engineering Technology program the \$25,000 grand prize. Letter of Delegate Credentials for Elections

With regard to board delegation and voting rights, Article VI, Section 3 of CLARB's Bylaws state:

"Each member board is entitled to be represented at CLARB meetings by one or more official delegates of that board. The delegate must be a member of the member board. A letter of credential from the delegate's board shall identify a delegate attending the annual meeting or any Special Meeting of CLARB. As many delegates as are able to attend may represent a member board, but only one vote may be cast on each motion for each member board by its delegates."

The credentials letter should be filled out only by a Member Board Executive <u>or</u> Member Board Staff Member. The credentials letter should designate the Member Board Member(s) who is/are eligible to cast your Board's ballot. Only a Member Board Member may cast ballots and only one ballot per Member Board may be cast.

Please submit your board's ballot and credentials letter together as one voting package.

You may choose any of the following options to submit your voting package to CLARB:

- Mail Mailed submissions must be received at the CLARB office by Friday, September 8.
- Email As an attachment (Word or PDF) to Andrea Elkin by Friday, September 8.
- In-person At CLARB's Annual Meeting registration table by noon, Friday, September 15.



ARE 4.0 retires June 30, 2018!

Have you been working to complete the ARE in ways that advance your goals? Here are five key steps to finish the ARE.

Commit

Commit to finishing in ARE 4.0 or finishing your <u>strategic testing</u> divisions. In either case, with less than 12 months to take ARE 4.0, you need to increase your ability to pass any remaining 4.0 divisions.

Maximize Your Opportunity

Create a plan that allows you to maximize your retest opportunities. Remember, if you do not pass a division, you'll have to wait at least 60 days before you can retest. Also, you can only attempt any one division three times within a 12-month period.
