

#### MESSAGE FROM THE CEO



#### Dear Colleagues:

In today's world, those of us who work with and for organizations of any shape or size live in glass houses ... not in the celebrated structures we have viewed or read about, but in corporate structures that house missions, programs, messages, and services. These structures are more transparent, and more subject to challenge regarding their conventions and traditions, than ever before. As such, none of us can afford to throw stones. Instead, especially in these times, we must encourage conversation and collaboration, incentivize change, and lead by being self-aware and by focusing on continuous improvement.

Over a year ago, in the aftermath of our Centennial, NCARB committed to taking a fresh look at the constructs behind its mission to collaborate with licensing boards in protecting the public. Our second century focus has resulted in a series of initiatives designed to constructively criticize and evaluate our programs, our culture, and

our value. On the docket are bias analyses by outside consultants regarding content and delivery of the examination and experience programs. As we move through the pandemic crisis, we are readying for a reinvented Analysis of Practice to assess how competency to practice in today's environment should be best assessed, and whether that assessment should be through some new iteration of the education/experience/examination model or another model entirely. Through the foresight of multiple NCARB presidents, we have collaboratives and task forces focused on topics ranging from the broad issues of how the future and diversity relate to licensure, to current programmatic challenges in the realm of licensure and incidental practice, responsible charge, and interiors. We are moving forward with a planned launch for an online proctoring exam option in November.

We believe our second century obligation extends to demonstrating agility in the face of new challenges, and to providing thought leadership through use of data and real-world knowledge. Whether it is through our increasingly-referenced and ever-expanding NCARB by the Numbers, our new joint assessments on licensure attrition with the National Organization of Minority Architects (NOMA), or future research regarding licensure influencers and impediments, we are focused on informed evolution. Thus, we seek to invite and facilitate fresh thinking toward existing approaches contributing to the licensure framework: with education (reviewing its foundational value in shaping and identifying an ability to practice, including encouraging a serious "four-year degree option" conversation); experience (reviewing its effectiveness in impacting competence to practice); and examination (reviewing its relevance as a primary metric of measuring competence).

Peering into the various glass houses within the architecture community are students, licensure candidates, educators, practitioners, and commentators/opinion leaders of all stripes. We see you. And as NCARB maintains its mission to collaborate with licensing boards to serve the public, the legislative bodies and governors who empower those boards are increasingly curious about requirements and results, taxpayer and business costs, and value to society. We hear you. New technology, global innovation, and a restlessness with outdated formulas are influencing the perspective of the elected and the electorate.

Much about these times remains uncomfortable—and for some, the truths may be seen as inconvenient. Forward movement is a good option. Let's go further.







#### **ADMINISTRATION**

- Supporting annual financial audit, with a final audit report due to the Board of Directors from independent audit firm RSM US LLP in September. Separately, an audit of the Council's 401k plan is also underway.
- Prepping for the launch of M-Files, our new document management system. Administration team members add the majority of new documents to customer Records and are being trained on the new system in anticipation of the launch in September.
- Virtually onboarding new Assistant Vice President of Human Resources (HR) with responsibilities for recruiting, benefits administration, and other key HR functions.





#### **COUNCIL RELATIONS**

- Engaged with NOMA's leadership regarding ongoing efforts related to the survey on equity, diversity, and inclusion in licensure, participation at NOMA's upcoming annual conference, and diversity-training opportunities for the coming year.
- Kicked-off an economic study in partnership with the Alliance for Responsible Professional Licensing (ARPL) and Oxford Economics. The goal of the study will be to examine data related to workforce and licensing standards. Results and marketing materials will be available to NCARB's Member Boards in mid-November.
- Coordinated with the Oklahoma Licensed Architects, Landscape Architects, and Registered Interior Designers Board regarding 2021 legislation and trends in occupational licensing.



#### **CUSTOMER RELATIONS**

- Presented an overview of Customer Relations Record and transmittal services to Member Boards in the NCARB Summer Webinar series. Highlights included upcoming changes in the transmittal process that will reduce transmittal turnaround time to Member Boards for select initial licensure candidates. The first pool of licensure candidates to be piloted will be those who meet the following conditions:
  - o Graduated from a NAAB accredited program
  - o Had their experience submitted and verified online
  - o Completed the ARE solely in ARE 5.0

This pilot will launch in early October to several participating boards. Feedback will be used to inform the final launch this new process to all Member Boards for candidates meeting these criteria.

 Partnering with Information Systems to finalize the Council's new document imaging system. This system offers improved imaging capability and supports future process automation.




#### **EXAMINATION**

- In collaboration with several Council departments, finalized the plan for future exam delivery services, including remote proctoring before the end of the calendar year.

- Examination Committee finalized a recommendation to the Board of Directors to increase exam efficiency and better support online delivery of the ARE. The committee also developed a revised ARE Candidate Conduct policy for Board consideration.
- The Item Development Subcommittee met and completed a statistical review of previously tested items, as well as delivered "NCARB Into the Future: Remote Proctoring 201" during the NCARB Summer Webinar series.
- Business Continuity Exam subcommittees completed first item writing assignment of the year and met to complete peer review of items.
- Forms Assembly and Case Study subcommittees held FY21 kickoff meetings.

# EXPERIENCE + EDUCATION

- In partnership with the Association of Collegiate Schools of Architecture (ACSA), convened the Editorial Board for ProPEL: the Professional Practice Education Library. Currently developing the delivery platform and initial content for this new resource—primarily for professional practice educators.
- The Program Continuum Advisory Committee, Continuing Education Subcommittee, and Ethics Case Study Workgroup got underway with FY21 kickoff meetings.
- Announced the upcoming Licensing Advisors Retreat Week, which will take place the week of October 26-30 in a virtual setting, allowing architect licensing advisors to receive training and network opportunities.



[EXT] NCEES moves computer-based testing transition of PE Civil exam to 2022



#### Dear Member Board Administrators,

The Principles and Practice of Engineering (PE) Civil exam is moving to computer-based testing (CBT), with appointments available year-round at Pearson VUE test centers beginning April 1, 2022. The exam will be offered for the last time in pencil-and-paper format in October 2021. Registration for the April 2022 CBT exam will open November 1, 2021.

NCEES originally planned to complete the PE Civil exam's transition to CBT format in 2023 but fast-tracked the change as part of its response to COVID-19. After the April 2020 pencil-and-paper exam administration was canceled because of the coronavirus pandemic, NCEES added an extra day to the October 2020 administration and began exploring the possibility of moving the PE Civil exam to CBT earlier than planned.

"Under the current COVID-19 guidelines, fewer examinees can be in the exam room at the same time, so we began discussions with Pearson VUE about transitioning the PE Civil exam from 2023 to an earlier date," explained NCEES Chief Officer of Examinations Tim Miller, P.E. "This new format will give examinees more flexibility about when and where they take the exam."

#### Online Proctoring

NCARB is excited to announce that Architect Registration Examination® (ARE®) candidates will have the option to test <u>online</u>, in-person, or a combination of both in mid-November 2020. As test center closures and limited availability continue to impact candidates' licensure progress, this new option will provide flexibility to take the exam in a location of their choice.

Here are some key takeaways to keep in mind:

- Changes that will make online proctoring possible for candidates are expected to launch November 16, 2020
- Candidates can still test in-person at Prometric test centers if they choose to do so
- The exam's content and division structure will not change
- Aspects of the exam's delivery are being updated for both in-person and online administrations to increase exam security and provide a more efficient experience
- More information about exam delivery changes will be released in late-September 2020
- NCARB expects to release updated versions of the ARE Guidelines, ARE Handbook, and demo exam in October 2020
- Ongoing developments to the ARE, including the implementation of online proctoring, will maintain the exam's rigor, while providing candidates with greater flexibility and accessibility
- In summer 2021, NCARB will switch to a new test administration vendor, <u>PSI</u>, for both in-person and online testing

#### **Education Standard**

Effective on January 6, 2021, the 2020 NCARB Education Standard will be implemented to ensure alignment with the 2020 NAAB Conditions for Accreditation adopted earlier this year.

The NCARB Education Standard is an approximation of the requirements of a professional degree from a program accredited by the National Architectural Accrediting Board (NAAB). It includes general studies, professional studies, and electives, which together comprise a professional education in architecture.

To ensure the Education Standard continues to align with the NAAB Conditions—and serve as a guide for Certificate Portfolio applicants without an accredited degree—NCARB has implemented the following changes:

- 1. Two subject categories have been broken out explicitly and added to the Education Standard
  - "History and Theory of Urbanism" added to the "History, Theory, and Human Behavior" subject area
  - "Building Performance" added to the "Building Technology" subject area
- 2. Word changes to utilize more common terminology
  - "Quantitative Reasoning" updated to "Mathematical Sciences"
  - "History and Theory" updated to "History and Theory of Architecture"
  - "Human Behavior" updated to "Human Health and Behavior"
- Additional means to address education deficiencies through EESA (Education Evaluation Services for Architects)
  - Relevant courses from university-based engineering or construction management programs have been added to the acceptable options for fulfilling deficiencies for certain individual requirements
- 4. Reduction of the design categories from four to three areas of deficiencies:
  - · Fundamental Design
  - Investigative Design
  - · Design and Building Integration
- 5. Minor adjustments to credit hour requirements for EESA
  - 45 semester credit hours in "General Education" reduced to 42 semester credit hours in "Liberal Arts"
  - 42 semester credit hours in "Design" reduced to 40 semester credit hours in "Design Synthesis"

The updated <u>Education Guidelines</u> with detailed descriptions of subject areas, categories, and semester credit hour requirements will be available after January 6, 2021.

#### Member Board ARE Online Proctoring Update: 9/24/2020

Earlier this week, NCARB shared a blog post that answered several frequently asked questions from candidates about our announcement related to online proctoring. It has generated a lot of discussion around the answer to one FAQ in particular: the decision to remove access to scratch paper for those taking the ARE in physical test centers beginning November 16.

Will I have access to scratch paper during my online-proctored exam?

Once the option for online proctoring launches on November 16, candidates testing online and in person will no longer have access to physical, paper-and-pencil scratch paper. Candidates will be able to use an online [whiteboard] option instead; more details regarding this tool will be available in October.

To help you answer candidate concerns, we have compiled some key takeaways and more in-depth information around this decision.

#### 1. Scratch paper will be replaced with a digital whiteboard.

All the tools candidates need to complete the ARE will be provided, and we will ensure the whiteboard will be made available prior to launch so candidates can get comfortable with it before using it in a test center or online. Candidates will be able to test and get familiar with the new whiteboard tool when the new demonstration exam launches in mid-October.

2. Consistency and fairness for candidates whether they are testing online or in-person. NCARB needs to ensure candidates have the same test experience whether they are online or onsite. NCARB does not want to introduce variance into the different testing modalities when the online proctoring option launches. One of the key factors in maintaining exam defensibility is to treat all candidates the same.

#### 3. Security requirements for the online proctored exam.

The replacement of scratch paper follows best practices in testing by ensuring there is a "clean desk" for exam security purposes. This is also part of the transition to online proctoring, because it is more difficult to monitor the use and disposal of loose paper when candidates are testing remotely as opposed to in a test center.

#### 4. NCARB did not make this decision lightly.

While the current pandemic has moved up NCARB's timeline to release the online proctored version of the exam, this has been something our Board of Directors and Examination Committee has been considering and evaluating for years. As the ARE is a standardized test all NCARB's Member Boards accept as part of evaluating competency to earn a license, making sure the exam is delivered in a secure and consistent manner is our top priority. To meet those goals, items like scratch paper were identified and discussed early in the process of understanding what it would take to allow the ARE to be delivered through online proctoring.



#### 5. There are more policy and exam changes to be announced.

NCARB's intention is to provide Member Boards with advance notice of major changes we announce over the next two months. The Board of Directors is finalizing many of them at their September Board meeting, and boards will receive notice of upcoming changes to the number of questions per division, test times of each division, and other policies shifts prior to their release to candidates.

#### Remote Proctoring and the L.A.R.E.

As you may have heard during CLARB's Annual Meeting and Annual Meeting recap email, remote proctoring has been prioritized to create a more accessible solution for candidates to be able to take/write certain sections of the L.A.R.E. After a successful pilot in Alberta, British Columbia, and Ontario during the August administration, CLARB will have remote proctoring as an additional testing option for all section 1 and section 2 L.A.R.E. candidates beginning with the December 2020 administration.

This is an exciting opportunity for many candidates to be able to access the exam without having to visit an in-person test center within the schedule offered. A live proctor will monitor candidates' exams through a video feed using advanced security protocols which are thoroughly explained to candidates in the registration and check-in processes.

The registration process for the L.A.R.E. remains unchanged- candidates will still register for the L.A.R.E. through CLARB's website and then select where (in-person test center or home/office) via Pearson VUE's website to schedule their appointment.

There are important differences to note between remote proctor and in-person test options:

- Only sections 1 and 2 are offered through remote proctoring. Remote proctoring is an option provided for candidates, but candidates may always choose the option of testing in a traditional test center.
- Sections 3 and 4 must be scheduled at a traditional test center.
- Remote proctoring for sections 1 and 2 will be available in all jurisdictions where the L.A.R.E. is administered.

- Candidates registering for remote proctoring will need to test their computer settings prior to their test date to ensure the exam and security protocols can be administered.
- Due to security protocols, candidates testing via remote proctor will not be permitted to take a break once the test begins.
- Any candidates requiring special accommodations will need to schedule their exam at a traditional test center.

We are excited to offer this opportunity to exam candidates beginning with the December administration (November 30-December 12). We will be sharing this information with candidates throughout the open registration period. #### MESSAGE FROM THE CEO

#### Dear Colleagues:

We are all living through an era, in this confluence of health/racial/political challenges, that is hyper-charged with conflicting information, with uncertainty and even fear masked by anger, and with conversation that either seeks like-mindedness or uses emotion to talk past each other. Staking out a clear and respectful communication path can be fraught with many land mines and trap doors. Yet at NCARB, in our outreach efforts, we must continue to adhere to the fundamental tenets of our Strategic Plan—facilitate licensure, foster collaboration, and maximize value.

Strategically charting a course for architectural regulation benefits enormously from initiating direct engagements with a variety of communities. In doing so, we consciously incorporate the perspective and role of our licensing boards, to ensure that policy and program decisions are well-informed and best positioned for success. What follows is an update and review of how NCARB is actively listening, engaging, and informing.

For many years, NCARB has consistently worked to broaden the sources of input and comment into our program development process. An example of this effort is found in our "Think Tank" initiatives, comprised of two focus groups/idea incubators that provide a forum to inform and influence NCARB from the perspective of licensure candidates and recently licensed architects. Each year, we have received hundreds of responses when we've issued the call to apply for the coveted positions on the Think Tank (licensure candidates) and the Re-Think Tank (recently licensed architects). NCARB volunteers make the selections based on a "blind essay" process, and the appointees frequently express a healthy skepticism and critical perspective during their year. Now we are convening a special edition of the Think Tank initiative with a regathering of alumni. As we pursue innovation and continuous improvement, we are inviting an assessment of what has worked and how should this effort evolve.

The introduction of Think Tanks into the NCARB culture was intentionally designed to innovate, ensure the presence of fresh perspectives, and to address the "perspective gap" given the mid-to-late career status of many licensing board members and other NCARB volunteers. Engagement with this community during this current fiscal year, as we are positioning to move into the Analysis of Practice, will inform our season of assessing the best paths and tools to ensure licensure represents competency to protect the public. In the coming months, we also anticipate new "focus" opportunities for licensure candidates so that we can receive constant, real-time feedback.

Concurrently, we also have expanded on our history of seeking organizational feedback and engagement. Last year, former President Terry L. Allers, FAIA, NCARB, Hon. FCARM, expanded NCARB's "Advisory Committee" concept beyond just the experience program to the entire portfolio of NCARB programs with a broader representation from external groups. This reinvented roundtable is now called the Licensure Advisory Forum (LAF). In addition to representatives from the traditional architecture collateral community, seats are also occupied by the National Organization of Minority Architects (NOMA), the AIA component executive community, other architecture membership organizations such as the Association of Licensed Architects (ALA) and the Society of American Registered Architects (SARA), the Society for Design Administration (SDA), and a growing list of others whose stakeholders have important perspectives that can shape evolving programs as well as educate LAF participants on commonalities between organizations.

Another new approach involves how our Board of Directors directly dialogues with external organization leaders at each of its Board meetings. This year, President Robert M. Calvani, FAIA, NCARB, has extended these engagements beyond past efforts involving traditional collateral organizations to include NOMA and regulatory organizations from other disciplines who frequently share licensing boards with architecture.

Other efforts are well-established and continually being refined. Every month, one or more visits (now virtual) to our member licensing boards have been accompanied by regular engagements with American Institute of Architects (AIA) state components. Every school with a National Architectural Accrediting Board (NAAB) accredited program is visited every other year (still on schedule with virtual visits) with additional visits to community colleges, firms, and AIA meetings to demonstrate availability and access. Further, we utilize subject matter experts ranging from exam psychometricians, legal counsel schooled in ethics and governance, and consultants with expertise in strategic planning, diversity/equity inclusion, and financial management.

As we consider, blend, and extract information from all these sources, we are conscious of utilizing multiple delivery vehicles to present information with intentional redundancy. Whether it is a robust use of all social media platforms, one-on-one calls, or traditional guidance documents, we are determined to remain present and to provide information based on established facts and best practices.

Our highly considered approaches ensure we adhere to our mission, which is to collaborate with licensing boards in protecting the public's health, safety, and welfare. Our deliverables must satisfy the public's expectations of rigor in our processes and competency in qualification to practice.

We are strengthened by our willingness to receive constructive criticism and a desire to assure an informed conversation. We all benefit from learning how to improve message and service, from discovering new uses for data and data analysis, and from developing relationships that can tolerate disagreement and celebrate forward movement.



### STRATEGIC PLAN

The three goals of Facilitate Licensure/Foster Collaboration/Maximize Value are manifested in the incorporation of online proctoring into the examination process. Online proctoring can be delivered securely in a manner equivalent to the fixed test center experience, as long as the two options are constructed consistently and without disparity. In doing so, the exam immediately becomes available to populations who have been marginalized: those whose condition and/or concern are preventing use of a fixed test center facility, and those whose location creates cost and time impediments around travel, family care, and safety concerns.

The Strategic Plan is also guiding new assessments of unconscious bias in NCARB programs, the issuance of analytics related to the joint NOMA/NCARB Baseline on Belonging assessment of attrition from the licensure path, and committee work related to the growing prevalence of remote work and the real need to embrace alternative approaches to education.



Early findings from the NCARB and NOMA joint study, Baseline on Belonging, were shared in NCARB's 2020 edition of NCARB by the Numbers.

### **NCARB CULTURE**

### ORGANIZATIONAL DEVELOPMENT AND OFFICE LIFE

- The staff focus on innovation is moving from opportunity identification into designing implementation plans and developing internal champions. Chief Innovation and Information Officer Guillermo Ortiz de Zárate has been joined by Experience + Education Senior Manager Patricia Ramallo to lead this effort. The focus will incorporate "transformational" items in departmental business plans, existing workflow processes, and a strategy for leveraging data and data analytics to further the Council's role as a thought leader. A key partnership will involve the Continuous Improvement Team located within the Customer Relations Department.
- The Organizational Health Team is overseeing the expansion of staff groups focused on Quality of Life and Inclusion/Equity/Diversity/Agility (IDEA). The former group will focus on staff connectivity during an ongoing remote work culture, and the latter group will be utilizing upcoming data from a consultant assessment to identify areas for workplace culture to acquire raised consciousness, demonstrate intentional best practices, and provide/require training. The team has also completed departmental focus meetings on findings from the annual employee satisfaction survey.








NCARB's Customer Relations, Examination, and Marketing & Communications teams partnered to answer candidates' online proctoring questions.

- Completed policy updates to support the online proctoring option of ARE; updates to the ARE 5.0 Handbook and ARE 5.0 Guidelines will be released in October to communicate changes to candidates.
- Initiated testing vendor integrations required for the launch of the online proctoring delivery of the ARE.
- ARE Forms Assembly Subcommittee began to assemble the exam forms that will be delivered to candidates as part of the launch of the online proctoring option.
- ARE Item Development Subcommittee and the Business Continuity Examination Workgroups continued their efforts to author new items for the exam.

- Hosted Professional Practice Roundtable featuring a discussion of innovative approaches to teaching.



## A Letter to ARE Candidates

9/29/20 ARE 5.0 Board of Directors

The NCARB Board of Directors, during its scheduled quarterly meeting last weekend, approved recommendations from the Examination Committee regarding the format of the adjusted ARE 5.0 to be launched later this fall as part of adding an online proctored delivery option. As part of our deliberations, we also took into consideration the communication from candidates regarding the ability to utilize scratch paper while taking the ARE at a Prometric testing site.

First, we thank you for sharing your concerns. We understand that any changes to the ARE can cause stress for those on the path to licensure.

Second, please review this explanation of some of the important aspects regarding the upcoming changes, which are designed to assure a consistent and equivalent experience for you whether you take the ARE online or at a Prometric center. Pursuing a consistent approach to exam delivery and exam security assures a scientifically and ethically sound basis for providing both the traditional and the online proctored option for the ARE. Compliance with testing standards is analogous to architects following code requirements.

Third, while the current pandemic has moved up NCARB's timeline to release the online proctored version of the exam, this is not a decision we have come to lightly. Today, candidates with health concerns are not being served on their path to licensure as they stay out of test centers. With a prediction from health experts of a possible COVID-19 resurgence this fall and winter, such a spike could lead to a new round of test center closures. NCARB's Board of Directors, architect volunteers, and psychometricians have been working for many months to determine the necessary adjustments needed to successfully launch an online-proctored exam. We can assure you that the totality of

changes improves the effectiveness of the ARE, maintains security, and ensures the rigor of the ARE does not change.

Fourth, let us address specific key changes.

- The ability to take notes and sketch out concepts will continue to be supported using an integrated whiteboard. NCARB will provide a demonstration of this new tool in mid-October. The new tool will be accessed like the existing calculator and references available today. The whiteboard is designed to work at both onsite and online testing locations with a standard mouse and keyboard. With the evolution to providing an online proctored option, this change was necessitated to ensure a fair, consistent, and equal test experience for all candidates regardless of where they test. Disparate treatment of candidates is unethical and indefensible.
- The adjusted exam will now provide <u>more flexibility for more frequent breaks</u>, based on the NCARB Board's approval of a recommendation from the Examination Committee.
- The total questions in each division will be reduced and more time provided to answer each question, which will result in fewer questions involving a calculation and more time to utilize all the given tools. More details on these changes will issue in early-October.
- The <u>demonstration exam will be updated</u> in mid-October to allow all candidates the ability to familiarize themselves with the updated navigation, the new whiteboard functionality, and all available tools while testing. Please note that NCARB's approach meets its obligation to provide a secure, rigorous, and defensible examination to the licensing boards that, in turn, protects the public. NCARB will continue to consider candidate concerns including delivering the ARE in a manner that is fair and accessible for all.

# Pathways, principles, and pitfalls for interstate practice



THERES DIGNITY IN ALL WORK, AND WE KNOW THAT WHETHER YOU MAKE YOUR LIVING

AS A PLUMBER, A BARBER, A NURSE, OR ANYTHING ELSE, YOU DON'T LOSE YOUR SKILLS SIMPLY BECAUSE YOU MOVED HERE.

Arizona Gov. Doug Ducey, upon signing AZ House Bill 2567, the nation's first universal recognition licensing legislation.

Gov. Ducey is correct that individuals do not lose valuable knowledge or expertise simply by moving across state lines. However, the public's trust in rigorous standards that lead to consumer health, safety, and welfare could be lost if interstate licensing is not designed correctly.

The Alliance for Responsible Professional Licensing (ARPL) supports policies and legislative initiatives that seek to build pathways to interstate practice for professionals in highly technical professions. ARPL represents professions and licensing boards that have more than 100 years of combined experience in creating greater flexibility for professionals and is uniquely positioned to offer best practices

that could be helpful as lawmakers work to achieve interstate practice for a broader mix of professions and occupations. This paper explores several examples of how states can responsibly accomplish flexibility and mobility.

### ONE GOAL, THREE PRINCIPLES

The demand for enhancing interstate practice is readily apparent and evidenced by a surge of legislative proposals during the past two years. The marketing of Arizona House Bill 2567 as a "universal" pathway to deliver greater economic choice and liberty is undoubtedly attractive, with multiple motivating factors contributing to its appeal:

- a) Economic (e.g., ensuring an adequate supply of workers or meeting consumer demand for services);
- b) Ideological (e.g., a belief in limiting the encroachment of government); or
- c) Political (e.g., supporting certain constituencies such as military spouses or members of underserved communities).

However, underpinning this drive to "universality" is the application of a "one-size-fits-all" solution across myriad professions and occupations. This is not an indictment of the desire for uniformity. Uniformity is necessary to enhance

interstate practice. The problem is that applying a solution without first acknowledging the diversity between, and within, occupations and professions compromises time-tested models, frustrating, instead of enhancing, interstate practice goals. The question at hand is how to avoid the unintended consequences of overly broad reform models. The first step is selecting an appropriate and suitable model.

There are several models available, depending upon the policy priorities a state is trying to achieve. For example, is the priority to construct an interstate mobility system that recognizes licensees from states with substantially similar requirements? Or, is it to facilitate reciprocity by requiring out-of-state individuals to obtain a new license through an expedited application process? Either model can create an occupation-or profession-appropriate model.

Three guiding principles provide a simple roadmap for interstate practice reform:

- Recognize mobility and reciprocity systems that work
- Develop substantially equivalent requirements for education, examination, and experience — the "three Es"
- 3) Provide adequate public protection

By embracing these principles, states will have more predictable, implementable and sustainable interstate practice systems that benefit the public and the professions or the occupations being reformed. These guiding principles provide a framework for policies to support professional growth and mobility, and to ensure public health, safety, and welfare.

# PRINCIPLE NO. 1 RECOGNIZE MOBILITY AND RECIPROCITY SYSTEMS THAT WORK

Both mobility and reciprocity are built upon statebased licensing. Either will accelerate interstate practice, but each is unique and may have varying costs and benefits, depending on the occupation or profession. The fact that these terms often are used interchangeably in proposals and testimony suggests there is confusion in the policy goals. Clearing up confusion on the front end helps to ensure clarity in the result.

All ARPL member professions (architects, Certified Public Accountants, professional surveyors, landscape architects and professional engineers) have clearly defined interstate practice systems in place. Professionals can obtain reciprocal licenses or have mobility



### Mobility

(also known as portability) allows licensees to practice their profession or perform duties in a different state without acquiring an additional license (e.g., CPAs use a mobility model).



### Reciprocity

(also known as comity or endorsement) allows states to grant a license based on all or portions of an applicant's qualifications used for initial licensure in another state (e.g., all five professions ARPL represents use reciprocity).



options, giving them the freedom to practice their profession anywhere in the country. For example, the standards for a uniform licensing system are already in place for engineering, surveying, and landscape architecture.

## ARPL MEMBER MODEL LAW EXAMPLES

Model laws can create specific statutory or administrative guidelines necessary to support a well-crafted interstate program beyond initial licensure. ARPL members employ model laws as the legal framework to implement uniform licensing requirements across all 50 states and territories.

### National Council of Examiners for Engineering and Surveying

The National Council of Examiners for Engineering and Surveying (NCEES) has been providing the Model Law as a resource for member boards and state legislators since 1932, updating it as needed to align with current practices. The Model Law reflects best practices as determined by the NCEES member boards and serves as a model for individual state or territorial practice legislation to promote uniformity and simplify interstate licensure for professional engineers and surveyors.

Changes to the Model Law typically go through a two-year process of committee study before being presented for debate and adoption by the full Council membership, which consists of engineering and surveying licensing boards in all U.S. states and territories. A majority of state licensing boards expedite the comity licensure process for engineers and surveyors who meet the Model Law requirements for education, experience and examination. In most of these cases, a license to practice in an additional state can be issued within only a few days.


Additionally, NCEES offers Model Rules, which complement the Model Law by explaining broad provisions stated in the Model Law and offering the details from an administrative

perspective. NCEES Model Rules are designed to assist member licensing boards, board counsel, and board administrators in preparing and updating board rules.

### Council of Landscape Architecture Registration Boards

The Council of Landscape Architecture
Registration Boards (CLARB) Model Law and
Regulations are a resource for legislatures and
licensing boards addressing a range of issues,
from public protection to reciprocity. Similar to
the NCEES Model Law, the CLARB Model Law
promotes uniformity in licensing laws (affording
predictability, commercial efficiency, and
enhanced trust in the profession), establishes
minimal standards of competence, and facilitates
professional reciprocity.

Additionally, CLARB Certification facilitates interstate practice by expediting reciprocal licensure across the United States and Canada. CLARB Certification is a distinction that signifies an applicant has met broadly accepted professional standards that are based on state licensure requirements. CLARB Certification carries a recommendation that the applicant is granted licensure without further review. This industry-recognized tool enables licensing boards to fast track reciprocity and is used in almost every jurisdiction. CLARB Certification expedites the licensing process by verifying an applicant's credentials for meeting licensure requirements and reduces steps within the process.



# PRINCIPLE NO. 2 DEVELOP SUBSTANTIALLY EQUIVALENT REQUIREMENTS FOR EDUCATION, EXAMINATION, AND EXPERIENCE — THE "THREE Es"

A high-functioning, interstate practice system depends upon "substantially equivalent" requirements and qualifications for initial licensing between states. Substantial equivalency is commonly described as jurisdictions requiring comparable amounts of education, the passage of a uniform national exam, and experience, the "three Es."

Substantial equivalency helps ensure all professionals are licensed and regulated equally, regardless of where they practice or who employs them. Substantial equivalency signals the completion of minimal qualifications to boards and the public. In the CPA profession, the Uniform Accountancy Act houses the initial licensure requirements under substantial equivalency:

- 150 hours of education
- · Passing the Uniform CPA Examination
- · One year of work experience

## ACHIEVING THE THREE ES THROUGH MODEL LAWS

Through model law recommendations, boards assist legislatures to establish the standards for the Three Es. In 1970, the National Council of Architectural Registration Boards (NCARB) published NCARB Model Law and Regulations. The document offers a guide for draft statutory and regulatory language and is a national model for architectural regulation. The NCARB Model Law and Regulations help the NCARB's Member Boards carry out their mission to protect the public, by regulating the practice of architecture, and is a resource for jurisdictions as they update their practice.


NCARB's Model Law and Regulations create a legal framework that is flexible, adaptable, and responsive to each jurisdiction's constitutional authority in determining the appropriate level of protection for its citizens. Not all model language will be — or is expected to be — adopted by all U.S. architectural licensing boards. Instead, the document is designed to be a resource that

provides a national model, which assists boards in navigating challenging areas of architectural regulation, offers consistent licensing and regulatory standards, is easily adapted to fit the diverse needs of NCARB's members, and will serve as the foundation for future enhancements to the reasonable regulation of the profession.

In ARPL's collective experience, model law development is best achieved when professional associations and licensing boards work alongside policymakers.



# PRINCIPLE NO. 3 PROVIDE ADEQUATE PUBLIC PROTECTION

Professional licensing statute enforcement is essential to ensure the protection of public health, safety, and welfare. Clearly defined enforcement and oversight functions of licensing boards instill confidence, from both licensed professionals and the public, in a state-sponsored regulatory system. Uniformity and oversight should not end at initial licensure; it should continue throughout the career of professionals.

## ROLE FOR PROFESSIONAL LICENSING BOARDS

The public is best served when state regulatory boards, duly constituted under state law, are free to regulate professional licensure on behalf of the public. In addition to public sector participation, boards are generally composed of qualifying individuals who have met appropriate education, experience, and competency standards for licensure and who adhere to the ethical practice of their profession. The public interest also is best served when the judgment of technical qualifications and the evaluation of professional competence is made by licensing boards that include members who are licensed in the profession.

### ARPL members have their standards codified into state laws and regulations:



### Model law and model regulations

Provide guidelines for establishing and updating laws, rules, and regulations that are common to all jurisdictions and facilitate reciprocity with provisions that allow for consistent requirements throughout all jurisdictions.



### Model continuing education standards

Ensure that licensees remain current in the profession and allow them to continue to learn and expand their skills.



### Model code of professional conduct

Ensure that licensees will practice in the best interest of the client and the general public.



State licensing boards are critical to maintaining professional accountability and guarding against unscrupulous practices. Boards are provided authority, by law, to investigate complaints, hold administrative hearings ensuring due process, revoke or suspend licenses, initiate actions for injunctions, or bring civil or criminal charges against licensees. These oversight functions are critical for protecting public health, safety, and welfare, not only at initial licensure, but throughout the career of the licensee.


**ACCOUNTABILITY GUARANTEED** 

Under an interstate practice system, licensing boards can exercise jurisdiction over any licensee practicing in their state or territory, regardless of where the license was issued. The licensee is still held accountable and to the same standards. Giving each licensing board automatic jurisdiction over any licensee practicing in their state enhances public protection and minimizes duplicative regulation.

Moreover, any licensee practicing across state lines can do so without being subjected to redundant compliance requirements, such as notices to the incoming state's licensing board and additional fees. For example, a landscape architect who is licensed in one state and practices in another would face disciplinary action for any wrongdoing from the boards of both states.

In a 2018 policy paper released by the Federal Trade Commission (FTC), *Options to Enhance Occupational License Portability*, the FTC recognized the accounting profession for utilizing model laws to achieve an interstate

practice system. These laws gave the state granting practice privileges and the state granting the original license oversight over the licensee. At the National Association of State Boards of Accountancy's (NASBA) 111th Annual Meeting, Tara Isa Koslov, chief of staff to the Chairman of the FTC stated, "We recognize accountancy as having done mobility and accountability right." Koslov noted, "Importantly, you are providing disciplinary support beyond state lines."





### Common pitfalls to avoid

Without careful attention to avoiding the most common pitfalls, poorly designed systems can fail the professionals they are intended to help and the public that trusts licensing to create minimum qualifications. Well-intentioned proposals to create interstate practice can easily go awry and cause more harm than good.




### COMMON PITFALLS TO AVOID

# PITFALL NO. 1 FORCING ACCEPTANCE OF OUT OF STATE LICENSES, WITH NO ASSURANCE OF MINIMUM QUALIFICATIONS

Well-functioning interstate practice models are built upon a foundation of substantially equivalent licensing requirements between jurisdictions. These requirements establish the minimum qualifications and competency to practice and are critical to protecting public health and safety. Confidence in the minimum level of qualification allows states to trust licenses from other states, which is an essential requirement for interstate practice.

For professions and occupations without uniform standards, minimum qualifications can vary significantly from state to state. In the absence of consistent, high standards, lawmakers risk creating a system in which their state must recognize out-of-state licenses without any assurance that the license qualifications are on par with their statEs requirements. States have no assurance that license holders from other states have met a minimum level of competency. Moreover, the system lends itself to abuse by enabling someone to get licensed in a state with less stringent requirements, then use that license to practice in a state in which they otherwise would not be qualified.




# PITFALL NO. 2 CREATING NEW BARRIERS TO INTERSTATE PRACTICE

A well-crafted policy should align with the stated objective of the policymaker. Or more simply put, licensing reform to encourage greater mobility should not create barriers that make mobility more difficult.

To illustrate, one-year residency requirements are being inserted into many of the "universal" recognition bills. It is unclear why the residency requirement exists, but it is particularly unnecessary when applied to highly technical

professions that have already solved the issue of uniform competency. For example, a licensed landscape architect, in good standing, can easily obtain a reciprocal license in other states without the residency requirement. More than half of landscape architects already practice in multiple jurisdictions. By instituting residency requirements, newly licensed landscape architects would encounter a barrier that precludes them from bidding on out-of-state projects.



### CONCLUSION

The highly technical and complex professions the ARPL represents have created and refined systems to provide for mobility in all 50 states and territories, while protecting the health, safety, and welfare of the public. The systems these professions have in place and the lessons ARPL has learned apply to other occupations. Policymakers should leverage the years of combined experience and expertise ARPL has acquired and used some of the best practice guidelines ARPL members produce.

The principles and recommendations outlined in this document provide a clear path to interstate practice. States can establish licensing systems that work for everyone by enacting responsible reform that recognizes proven mobility and reciprocity systems that work; developing substantially equivalent requirements for education, examination, and experience; and providing adequate public protection.

States can support employment growth and encourage consumer choice by establishing interstate practice systems that allow state licensing boards to grant licenses quickly to out-of-state applicants. For licensees, a well-designed interstate practice system allows an individual to seek out additional opportunities in a new location and to get to work more quickly.

They outlined funding opportunities for building and fire prevention departments through BRIC and shared best practices for how to successfully leverage BRIC grants through coordination with hazard mitigation officials. BRIC is FEMA's new \$500 million mitigation grant program. It prioritizes the adoption and enforcement of hazard resistant building codes and makes funding available for adoption activities (including staff time and consultant costs), training, certifications, electronic permitting, building department accreditation and online access to codes and standards. Code Council staff focused on assessing wildfire damages, causes and prevention strategies No region is immune to the threat of wildfires, but this year's multi-state wildfires in the West are boosting interest in the International Wildland-Urban Interface Code (IWUIC) and revising strategies to prevent or contain future wildfires. A recent New York Times article describes the situation: "Millions of Americans are moving into wildfire-prone areas outside of cities, and communities often resist restrictions on development. A century of federal policy to aggressively extinguish all wildfires rather than letting some burn at low levels, an approach now seen as misguided, has left forests with plenty of fuel for especially destructive blazes ... loading the dice for more extensive fires." Karl Fippinger, Vice President, ICC Government Relations Fire and Disaster Mitigation, said that while most of the fire service community's focus is on extinguishing the West Coast states' fires, ICC members and staff are preparing to update the IWUIC to changing needs. Members can engage in IWUIC development for the 2024 I-Codes in a variety of ways. The Fire Code Action Committee (FCAC) is meeting regularly and sponsors an IWUIC work group that is open to all members. Members can also submit code change proposals for the 2024 IWUIC via cdpACCESS beginning mid-October until January 11. The IWUIC is among the Group A Codes. Second building, fire officials survey continues monitoring how they cope with pandemic issues Results of a follow up survey of building and fire prevention officials to learn how code officials cope with professional challenges brought on by the COVID-19 pandemic underscore the importance of additional federal resources for code departments. The survey, conducted August 11 to September 3, documented information from more than 800 respondents from jurisdictions that range in size from 700 people to 4 million. Although the U.S. Department of Homeland Security has determined the work of building and fire prevention departments to be essential to the nation's response to the coronavirus pandemic—and no state has made a contrary determination—about half of survey respondents did not have the capability to remotely carry out critical aspects of their work. That's an improvement from 6 in 10 in April, but still unacceptable given code departments' vital role in communities' pandemic response, resilience, economic recovery and long-term success. "The results of this survey show how, in less five months, the Code Council's governmental members have worked to ensure their departments can continue to protect public safety and spur economic activity in a virtual work environment," said 'Code Council Chief Executive Officer Dominic Sims, CBO. "But too many departments have outstanding needs. It's critical that sufficient resources to support building and fire prevention departments are provided by state and local governments through existing CARES Act funds and by the federal government through any subsequent economic stimulus package." ICC receives Commerce Department grant to support publication, implementing of Gulf building codes The International Code Council will receive the Market Development Cooperator Program (MDCP) grant to partially underwrite the work the Code Council will undertake with the Gulf Standardization Organization (GSO) to publish a suite of regional model building codes. The grant is a major show of support for the work undertaken by the GSO since that organization entered into an <u>agreement with the Code Council in 2016</u> to begin work developing the unified Gulf Building Code. The work to develop the Gulf Building Code has been underway for the past four years, involving stakeholders based in all Gulf Cooperation Council member states, and the development process is now in its final stages. Deadline is October 18 to submit comments on solar thermal collectors and systems standards

The deadline is October 18 to submit comments on ICC/SRCC standards for solar thermal collectors and systems which are currently being revised under ICC's ANSI-approved standard development procedures. The IS-STSC has released additional draft changes to the documents for a second public comment period. The Public Review #2 Package document contains proposed changes shown in strikeout and underline format, along with the required comment form and instructions for submitting comments. Comments will only be accepted on these draft changes to the documents developed by the committee since Public Review #1. Code Council's PRONTO now offers five new exams based on the 2021 International Codes
The Assessment Center at the International Code Council recently announced the addition of four new exams based on the 2021 International Codes — M2 - Commercial Mechanical Inspector; M3 - Mechanical Plans Examiner; P2 - Commercial Plumbing Inspector; and P3 - Plumbing Plans Examiner. The exams are conveniently offered through the PRONTO (Proctored Remote Online Testing Option). Look for more to be added within the coming months. Read more here. The Assessment Center also recently announced the new Tall Mass Timber Special Inspector certification. The certification exam is now conveniently available via the PRONTO. Read more here.

Changes to lead reduction regulations finalized by EPA to lower lead content of plumbing products. The U.S. Environmental Protection Agency finalized its changes to existing regulations to provide a framework of compliance under the Reduction of Lead in Drinking Water Act of 2011 (RLDWA), which lowered the allowable maximum lead content of plumbing products to further protect the public from lead used in plumbing materials that provide water for human consumption. The final rule "requires"

manufacturers with 10 or more employees, and importers entering products purchased from or manufactured by manufacturers with 10 or more employees, to obtain third-party certification by an ANSI-accredited third-party certification body." The plumbing manufacturing industry began transitioning products to new lower lead levels circa 2014. Even better, the 2015 IPC and IRC were amended to reflect RLDWA lead content requirements in drinking water pipes, pipe fittings, joints, valves, faucets and fixture fittings. For several years, ICC Evaluation Service has offered certification service to the requirements of NSF/ANSI 372 and is available to address certification needs. ALSC reports more non-ALS lumber grade marks appearing in Missouri and New Hampshire

The American Lumber Standard Committee alerted its members and industry that a lumber grade stamp was recently observed in Missouri and New Hampshire. Similar reports surfaced this year from New York, Texas, Georgia, Massachusetts and North Carolina. The stamp "No.2" does not come from any ALSC-accredited inspection agency, there are no ALS-approved design values that are attributable to lumber bearing this stamp and it should not be represented as a structural lumber product under the ALSC system. Code Council announces updates to Building Valuation Data to aid in calculating permit fees
The Code Council recently announced updates to <u>Building Valuation Data</u> (BVD) for its members. The
BVD is updated at six-month intervals, with the next update in February 2021. The Code Council strongly
recommends that all jurisdictions and other interested parties actively evaluate and assess the impact of
this BVD table before utilizing it in their current code enforcement related activities. The BVD table
provides "average" construction costs per square foot, which can be used in determining permit fees.
Permit fee schedules are addressed in Section 109.2 of the 2018 International Building Code (IBC)
whereas Section 109.3 addresses building permit valuations. Permit fees can be established by using the
BVD table and a Permit Fee Multiplier, which is based on the total construction value within the
jurisdiction for the past year. <u>Read more here</u>.

Residential Seismic Assessment and Retrofit Standard Consensus Committee to Meet for First Time A virtual meeting of the Code Council's Residential Seismic Assessment and Retrofit Standard Consensus Committee (IS-RSARC) will be held from 11:30 a.m. to 2:30 p.m. CT on October 16 to discuss the development of the ICC 1300 standard. As an American National Standards Institute accredited standards developing organization, the Code Council is undertaking a project coordinated with the California Earthquake Authority and the Federal Emergency Management Agency to develop a Code Council standard for the seismic evaluation and retrofit of one- and two-family dwellings (including townhouses) designated as ICC 1300, Standard for the Vulnerability-Based Seismic Assessment and Retrofit of One- and Two-Family Dwellings.

Call for Committee on the Consensus Committee On Log Structures has a November 1 deadline
As an ANSI accredited standards developing organization, the Code Council is revising the ICC 400,
Standard on the Design and Construction of Log Structures, to maintain the standard with current
industry practice. The application deadline to serve on the committee is November 1. Once appointed,
this committee will convene to undergo the revision process in accordance with ANSI Essential
Requirements for the development of American National Standards. This Committee has primary
responsibility for minimum requirements to safeguard the public health, safety and general welfare
through design, construction and installation requirements for log and heavy timber structures. Visit the

### Online Proctoring Update

NCARB is continuing in our efforts to launch the option to allow candidates to take the Architect Registration Examination® (ARE®) via online proctoring. This will be offered in addition to traditional, in-person testing, which will still be offered through Prometric's global network of test centers.

To enable online proctoring, several changes to ARE 5.0's navigation, timing, and policies will go into effect when online proctoring becomes available—impacting both in-person and online exams, including in-person exams already scheduled.

To help candidates prepare for these changes, NCARB released the <u>Guide to Online Proctoring and ARE 5.0</u>. The information contained in this resource, along with <u>updated talking points</u> and a <u>special edition of our Fast Facts</u> were sent to Member Board Chairs (MBCs) and Member Board Executives (MBEs) last week. All of this information is available on the <u>Member Board Community</u>. Additionally, NCARB is drafting talking points for Member Boards in response to recent blog articles and videos—many of which include incorrect information about the ARE.

We will continue to keep you informed every step of the way. In the coming weeks, NCARB will continue to roll out additional information related to the ARE. Later this fall, NCARB plans to release its updated demo exam, which will be available on My NCARB, as well as supplemental test prep videos for candidates. In winter 2021, NCARB will provide further information about the expected summer 2021 transition from Prometric to PSI.

### NCARB Releases New Education Standard

NCARB has released a new version of its *Education Standard*, which has been updated to remain in alignment with the <u>National Architectural Accrediting Board's</u> (NAAB) 2020 Conditions for Accreditation. The updated *Education Standard* will go into effect on January 6, 2021, and is available now as part of NCARB's *Education Guidelines*.

Until January 6, 2021, both the current and updated versions of the Education Standard will be available.

### Purpose of the Education Standard

The NCARB Education Standard approximates the requirements of a professional degree from a program accredited by the NAAB. It is used to evaluate the educational background of individuals who do not have a degree from a NAAB-accredited program—typically those pursuing licensure or certification as a foreign applicant, or those pursuing NCARB certification through the Education Alternative.

The Education Standard comprises pages 23-39 of the NCARB Education Guidelines.

### Changes to the Education Standard

With input from its volunteer experts, members, and Board of Directors, NCARB has implemented changes that align the *Education Standard* with the NAAB's *Conditions for Accreditation*. These include:

- Three subject categories have been broken out explicitly and added to the *Education Standard*: English Composition, History and Theory of Urbanism, and Building Performance.
- Words were updated to utilize more common terminology (for example, "Optional Studies" was renamed "Electives").
- Additional means to address education deficiencies through the Education Evaluation Services for Architects (EESA) process were added in the areas of proficiency in the English language and several of the Building Technology categories.
- The Design categories have been revised and redefined from four categories to three: Fundamental Design, Investigative Design, and Design and Building Integration.
- · Minor adjustments were made to the credit hour requirements for each subject area.

#### Changes to the Education Guidelines

In addition, NCARB made clarifying edits throughout the rest of the *Education Guidelines* to help candidates and architects navigating the education requirement. These changes reflect updated information from both NCARB and the NAAB, including:

- Clarification regarding NAAB-accredited programs outside of the United States and Canada.
- Updated contact information and instructions for navigating the EESA process via the NAAB.
- Guidance regarding pursuing U.S. licensure as a foreign architect vs. a foreign-educated applicant.
- Clarification regarding the two paths of the NCARB Education Alternative.

Updates to the portion of the *Education Guidelines* outside of the *Education Standard* (pages 1-22) are effective immediately.

In the coming months, NCARB will work closely with individuals who are impacted by the updated *Education Standard*, including those in the process of completing the Certificate Portfolio path of the Education Alternative. For more information, contact us.

### **Executive Orders Pertaining to Professional Licensing**

During the COVID-19 public health emergency, we have seen a number of governors issue executive orders pertaining to professional licensing. While the majority of these directives have been specific to the healthcare-related community, we'd like to share a few examples that impact architects.

- Colorado Governor Jared Polis recently issued an executive order to extend license expiration dates.
- New Hampshire Governor Christopher Sununu issued an <u>executive order</u> pertaining to continuing education requirements. The order waives certain requirements for a specific date, authorizes remote instruction, and provides for additional accommodations.
- Kansas Governor Laura Kelly issued an <u>executive order</u> to include waiving any late, penalty, or expiration fees for licensure renewal deadlines.



Most executive orders have provided temporary and supportive accommodations to licensees, but as many states continue to experience economic turmoil and challenges to professional licensure, we will continue monitoring these orders for potential harmful and unintended consequences.

Following the announcements of revisions to the L.A.R.E. Candidate Agreement and updates to the L.A.R.E. Orientation Guide, we wanted to share some additional information related to the roll-out of these changes. The announcements below, also sent to candidates, explain the changes made and where they are located.

CLARB has been working with an attorney who specializes in certification and licensure testing to review our policies and procedures to ensure that we have the best protections in place for the exam program. We followed their advice to enhance and clarify our procedures so that candidates taking the exam clearly understand everything for which they are required to confirm agreeement.

The type of agreement L.A.R.E. candidates sign, and the revised language included, is a standard requirement in high-stakes licensure programs. Additionally, updates to the Orientation Guide specifically include information related to remote proctoring.

Please don't hesitate to reach out if you have questions related to these updates. We want to make sure both you and your exam candidates are fully informed.

### ANNOUNCEMENT - L.A.R.E. Candidate Agreement has been revised!

The L.A.R.E. Candidate Agreement has been revised. All candidates registering for an L.A.R.E. section will be required affirm that they have thoroughly read and understand the Agreement in full. Because this has been revised since the previous L.A.R.E. administration where candidates have read and agreed to the content, it is important for all candidates to be aware of this updated Agreement and thoroughly review it as it remains a required part of the registration and exam check-in process for all sections.

The full L.A.R.E. Candidate Agreement is available for review prior to registering in CLARB's L.A.R.E. Orientation Guide.

### Dear Kathryn,

The online proctoring option for the Architect Registration Examination® (ARE®) is expected to <u>launch on December 14, 2020</u>, along with several important <u>changes to exam navigation, timing, and tools</u> that will impact all candidates—whether testing in-person or remotely.

### Online Proctoring Q&A

We recently <u>held a live webinar</u> to answer questions about online proctoring and the exam changes, and we received over 200 different questions. Now, our staff are answering all the questions we didn't have the chance to answer during the webinar in a new video series—and part one is available now.

### Online Proctoring Now Expected to Launch December 14

Earlier this week, NCARB announced that online proctoring and the related exam changes are now expected to launch December 14, 2020. This updated timeline enables NCARB to implement several enhancements that will lead to a higher quality online testing experience. Learn more about the new launch date and what this means for you.

### Updated Webcam and Cable Requirements

NCARB has updated the webcam and cable/cord requirements for taking an online proctored exam. Candidates testing via online proctoring are now required to have an external webcam to facilitate a "cable-by-cable" assessment of their computer setup at part of their check in. You can find the new webcam specifications, as well as other requirements for online testing, in the updated <u>ARE 5.0 Guidelines</u>.

NCARB understands that requiring an external webcam may create an additional expense for candidates. To help offset this, NCARB will provide all candidates who schedule their first online appointment a one-time \$50 e-gift card. <u>Learn more</u>.

NCARB anticipates launching the new, full-length demonstration exam no later than mid-November. This update will feature the new digital whiteboard tool and additional changes aligning with the launch of online proctoring (such as the new break feature and navigation).

### NASBA Applauds Bipartisan Federal Legislation to Protect State Licensing

### **Boards from Antitrust Damages**

NASHVILLE, Tenn., October 26, 2020 – U.S. Representatives Mike Conaway (R-TX-11), Jamie Raskin (D-MD-08) and David Cicilline (D-RI-01), recently introduced the Occupational Licensing Board Antitrust Damages Relief Act of 2020 (H.R.8680), which protects state licensing boards, their board members and staff from legal damages while performing licensing regulation duties that protect the public interest. The purpose of this important legislation is to address the practical antitrust law implications for state professional and occupational licensing boards affected by the Supreme Court's 2015 decision in North Carolina State Board of Dental Examiners v. Federal Trade Commission. The National Association of State Boards of Accountancy (NASBA) applauds this bipartisan federal legislation to protect state licensing boards from antitrust damages.

"State licensing boards provide an invaluable service to the state," Rep. Conaway explained. "Individuals who serve on these boards should enjoy the same legal protections for working on behalf of the state as all other state officials do. Having served on the Texas State Board of Accountancy myself, I understand that serving on a licensing board is performing an important public service. This legislation ensures that members of state licensing boards will continue to serve the state without fear of personal liability. I am pleased to be working with Reps. Raskin and Cicilline on this bipartisan initiative and encourage my colleagues on both sides of the aisle to support our legislation."

The bill would shield state boards, board members and their staff members from legal damages occurring from their public service. The bipartisan bill still allows for enforcement of anti-trust laws by federal and private entities, and sets the following standards for licensing boards if they are to be immune from damages:

- Operate under a state law that requires an occupational license for the occupation regulated by the board, that specifies the qualifications for the license, and that requires professional and ethical standards to be met;
- Have all members of the board appointed by the state's chief executive officer, the legislature, or other
  designated elected state officer;
- Include members of the public who are not market participants in the regulated profession; and
- Provide mechanisms allowing people aggrieved by the board to contest its actions.

"Public protection can only be attained in its truest form with the passing of this critical legislation," said NASBA President and CEO Ken L. Bishop. "Since 2015, the actions of State Boards of Accountancy, appointed board members and staff have been placed under a cloud of uncertainty, including the prospect of antitrust treble damages as they carry out their duties under state law. This narrowly targeted bill will ensure state boards can continue their statutory mandate to regulate the practice of public accountancy without threat. I commend U.S. Representatives, Conaway, Raskin and Cicilline for leading this effort. As a former Texas State Board of Accountancy member and chair, Congressman Conaway understands the vital role state board members play to protect the public."

NASBA and 11 other organizations impacted by this legislation include: American Institute of Certified Public Accountants, American Physical Therapy Association, American Psychological Association, American Veterinary Medical Association, Association of State and Provincial Psychology Boards, Council of Landscape Architectural Registration Boards, Federation of Podiatric Medical Boards, Federation of State Boards of Physical Therapy, Federation of State Medical Boards, National Athletic Trainers' Association Board of Certification, Inc., and the National Board for Certification in Occupational Therapy, Inc.

A letter of support submitted by these organizations states, "Passage of this legislation will ensure that all volunteer members, including those representing the public, of state regulatory boards are not deterred from civic-minded service because of the potential for personal monetary damages." The letter continues, "Our organizations believe that this legislation is a balanced approach to competition policy that retains enforcement mechanisms against anticompetitive activities while ensuring that current and prospective state licensing board members will continue to be willing to serve and are not dissuaded because of uncertainty over any potential personal liability arising from their public service."

Dear Representatives Raskin, Conaway and Cicilline,

The undersigned organizations, which represent state licensing boards and those professionals who serve on them, write in support of the *Occupational Licensing Board Antitrust Damages Relief Act of 2020*.

We would like to thank Representatives Raskin, Conaway and Cicilline, for your leadership in introducing this legislation. In 2015, in North Carolina State Board of Dental Examiners v. Federal Trade Commission, the U.S. Supreme Court ruled that the North Carolina Dental Board was not entitled to "state action" immunity from antitrust laws because its actions were not actively supervised by the state. Passage of this legislation will ensure that all volunteer members, including those representing the public, of state regulatory boards are not deterred from civic-minded service because of the potential for personal monetary damages.

The legislation seeks to protect state boards, board members, and staff from damage awards by private plaintiffs, while still allowing for enforcement of antitrust laws by federal and private actors seeking to enjoin anticompetitive behavior of licensing boards. It also conditions immunity from damages liability on licensing boards meeting certain standards. Specifically, under this legislation, licensing boards must:

- Operate under a state law that requires an occupational license for the occupation regulated by the board, specifies the qualifications for the license, and requires that professional and ethical standards be met;
- Have all members of the board appointed by the state's chief executive officer, the legislature, or other designated elected state officer;
- Include members of the public who are not market participants in the regulated profession;
- Provide mechanisms allowing people aggrieved by the board to contest its actions including:
  - The opportunity to provide evidence, argument and analysis as to the contested action;
  - o Review of all evidence gathered by the board relating to the action;
  - o Receipt of a written decision from the board after any hearing; and,
  - o The opportunity to appeal any decision to an independent adjudicator, including a court.

Our organizations believe that this legislation is a balanced approach to competition policy that retains enforcement mechanisms against anticompetitive activities while ensuring that current and prospective state licensing board members will continue to be willing to serve and are not dissuaded because of uncertainty over any potential personal liability arising from their public service.

Again, we thank you for your leadership on this issue and look forward to working with you as the bill progresses through the legislative process.

#### **Rethink Regulation Project Updates**

We have kicked off another fiscal year at CLARB working to support you and the continued regulation of landscape architecture across North America. You are likely already aware of our Rethink Regulation work, but we'd like to take a moment to share updates and exciting next steps on each of the three workstreams associated with this critical project.

#### POLICY - UNIFORM STANDARD

The policy workstream is focused on developing defensible requirements for licensure to result in a uniform standard which can be used across all jurisdictions.

Project update: Taking the political environment into consideration, we are working to complete our recommendation (based on research) for a uniform standard this fiscal year. Through this work, we will update CLARB's Model Law which will be subject to a membership vote in 2021.

Get involved! We are currently seeking volunteers interested in offering their time to assist in developing the uniform standard. This volunteer work will kick off in the spring and if you're interested, please reach out to <u>Andrea Elkin</u>.

#### **PROCEDURE - TIME TO LICENSURE**

The procedure workstream focuses on identifying, researching, and supporting the implementation of changes which will reduce friction in the licensure process and reduce the time to licensure for the average candidate.

We are excited to announce that, as of October 1, our member board in Virginia has implemented a

change which removed the pre-approval requirement for exam candidates! After working with our Rethink Regulation team, Virginia was able to make an administrative change to implement this process change. Because of their effort, candidates in Virginia who have an accredited degree can now directly register for the L.A.R.E. Please join us in congratulating Virginia as we all seek ways to advance a friction-free licensure process.

The program to evaluate processes and reduce friction is continuing in the jurisdictions which have previously offered their partnership: Oregon, Maryland, and Texas. To hear their work updates in their own words, <u>click here</u> to view the regional meeting recording (scroll to minute 28:00).

Get involved! Does this work sound like something your board would be interested in doing too? We are seeking interested member boards to partner with in FY2021! We're excited to get started!

#### PROCESS - UNIFORM APPLICATION


The process workstream focuses on developing a uniform application for licensure which can be accepted by all jurisdictions to reduce redundancies in the documentation required.

CLARB's August regional meetings focused on advancing this project and we sincerely thank all who participated and shared feedback related to the uniform application prototype. Following the addition of your input, we made final recommended changes to the application and are now equipped to begin making updates to CLARB's processes over the coming months. #### Online Proctoring Update

To better ensure the quality of the Architect Registration Examination® (ARE®) when the online proctoring option is launched, NCARB has delayed the launch of online proctoring. **The new expected launch date is December 14, 2020.** 

Both the online proctored testing option and the <u>anticipated changes</u> to the exam are now expected to launch on December 14, 2020. This includes the reduction in the number of items, adjustments to exam appointment times, transition to the digital whiteboard tool, and the updated break policies.

Once implemented, all exam changes will apply to both in-person and online exam appointments—including those scheduled to take place on December 14, 2020.

#### Why is NCARB updating the timeline?

As part of our quality assurance process, NCARB has identified a number of potential improvements to the updated exam that we believe will enhance the candidate experience. Moving the launch date helps us ensure a higher quality testing experience and may provide more time for candidates to adjust to the upcoming changes.

#### What does this mean for candidates?


If candidates have an exam appointment scheduled between now and December 13, 2020, the version of the ARE they experience will be the current version, with the policies, tools, and number of items outlined in the current *ARE 5.0 Guidelines* and *ARE 5.0 Handbook*. Candidates will receive immediate provisional feedback before leaving the test center, and their score report will not be delayed. If candidates have an exam appointment scheduled to take place on December 14, 2020, or later, they will experience the updated version of the ARE, with the exam changes detailed in our <u>Guide to Online Proctoring and ARE 5.0</u>, and policies/content outlined in the newly updated version of the <u>ARE 5.0 Guidelines</u> and <u>ARE 5.0 Handbook</u>. Candidates testing within the first four weeks of the launch will likely experience score report delays while the new cut score is established.

#### What can Member Boards expect next?

NCARB anticipates launching the updated demonstration exam in early-November. This update will feature the new digital whiteboard tool, as well as additional changes aligning with the launch of online proctoring, such as the new break feature and navigation. In addition, NCARB will be lengthening the demo exam to include 75 practice items (addressing topics from all six divisions), with a testing time of three hours, to help better prepare candidates for a real test experience. The updated demo exam will be accessible through candidates' My NCARB account. In the meantime, NCARB will continue updating the free resources available to our candidate community, including the ARE Prep videos. We will continue providing Member Boards with updates as new information and resources are available.

Guidelines published by ICC on converting outdoor spaces into temporary seating spaces
Restaurants, bars, and similar establishments are looking for ways to convert outdoor spaces into
temporary seating to offset the COVID-19 mandated reductions to indoor occupancy loads. The Code
Council offers some insights for restaurant and café owners, code officials and Authorities Having
Jurisdiction (AHJ) to help protect employees, customers, and communities. It is in a downloadable
booklet titled "Considerations for Converting Outdoor Spaces into Temporary Seating Spaces." While
these items are intended to decrease the spread of COVID-19, they focus more on the code related
issues. The outdoor seating concept is designed to enable service facilities the ability to increase their
service and customer base at occupancy levels near or at the otherwise normally permitted numbers.
These considerations are meant to supplement – not replace – any state, county, local, territorial, or
tribal health and safety laws, rules, and regulations with which businesses must comply.

January 29 is the deadline for jurisdictions to apply for FEMA's \$500 million BRIC grant program

A great funding opportunity is now available for state, local and tribal jurisdictions to support building code offices, especially if your state or community is in the process or will soon be in the process of

adopting or updating building codes. The Federal Emergency Management Agency's (FEMA) Building Resilient Infrastructure and Communities (BRIC) program is FEMA's new \$500 million mitigation grant program. It prioritizes the adoption and enforcement of hazard resistant building codes and makes funding available for adoption activities (including staff time and consultant costs), training, certifications, electronic permitting, building department accreditation and online access to codes and standards. The Code Council hosted a webinar on BRIC with leaders from FEMA and state and local governments who outlined the opportunity for building and fire prevention departments through BRIC. And according to the institute, retrofitting 2.5 million homes to the 2018 IWUIC could provide a nationwide benefit-cost ratio as high as \$8 to \$1. # What To Watch: Federal Legislation to Provide Antitrust Immunity to State Occupational Licensing Boards

A bipartisan bill (H.R. 8680), supported by CLARB, was introduced by U.S. Representatives Jamie Raskin (D-MD-08), David Cicilline (D-RI-01) and Mike Conaway (R-TX-11) and referred to the House Committee on the Judiciary. This bill, if passed, would protect individual members of state licensing boards from being sued for board actions.

If passed, new members of licensure boards and any members still serving on or working for a licensure board at the time of enactment, would be immune from personal and financial liability for work done in their official capacity of the board. Any of our U.S. members serving on a landscape architect or multidiscplinary board would meet the provisions required for immunity under this act as long as they are acting in their official and appropriate capacity. This will also allow the public and experienced professionals to serve on licensing boards and provide their expertise to protect the health, safety, and welfare of the public while not jeopordizing their own livelihood.

**Bill summary:** The bill provides for the immunity from liability for damages for an occupational licensing board, or any member, officer, employee, or agent of such board for actions taken in official capacity of the board that are in line with appropriate conduct by the board. It also establishes requirements for immunity under this act. These require a state to: have in effect a law that requires a license to engage in the occupation; specifies qualifications to obtain licensure; require a licensee to adhere to professional and ethical standards; members are appointed by government officials; there is public member

representation; and there are mechanisms in place for licensees to contest an adverse action by the board and get the ability to defend themselves and receive an impartial adjudicator (i.e. a court).

The legislation is supported by the following organizations: American Institute of CPAs, American Physical Therapy Association, American Psychological Association, American Veterinary Medical Association, Association of State and Provincial Psychology Boards, Council of Landscape Architectural Registration Boards, Federation of Podiatric Medical Boards, Federation of State Boards of Physical Therapy, Federation of State Medical Boards, National Association of State Boards of Accountancy, National Athletic Trainers' Association Board of Certification, Inc., and National Board for Certification in Occupational Therapy, Inc.
