AGENDA ITEM #1 APPROVAL OF MAY 15, 2009 BOARD MEETING MINUTES (MOTION)

Humphreys brought it to the attention of the Board that the first sentence of the minutes should be corrected to reflect May 15, 2009.

MOTION: By Jans, seconded by Shafai, for approval of minutes of the May 15, 2009 Board Meeting as amended.

AGENDA ITEM #2 APPROVAL OF VOUCHERS SINCE LAST MEETING (MOTION)

MOTION: By Neugebauer, seconded by Jans for approval of vouchers since last meeting.

ACTION: 7-0 AYE (Bacon, Hazard, Jans, Neugebauer, Olson, Shafai, Stafford)

AGENDA ITEM #3 ACTIVITIES REPORT ENDING JUNE 2009. REVIEW OF DEPOSITS AND QUARTLEY REPORT

Humphreys presented preliminary report figure. As of 07/16/09, the State has not closed out the 2009 fiscal year and provided final reports.

AGENDA ITEM #4 INVESTIGATION REPORTS

Case 08-06 Harrisburg, SD Building without A&E services - Discussed by Humphreys. Fire Marshall, City of Harrisburg, and the Board are communicating with each other and are keeping all parties up to date on developments.

Case 09-03 Failure to report Disciplinary Action - Neugebauer discussed. Case is pending.

Case 09-04 Omission of Signature and Stamp for a final report - Jans discussed. Majority of complaint has been dealt with. Case should be done by next board meeting.

Case 09-05 Competency and Professional Conduct - Humphreys mentioned case closed last board meeting.

Case 09-06 Competency and Professional Conduct - Discussed by Humphreys and Shafai. Board getting outside professional services for structural engineering and geotechnical services for investigative committee, and outside legal counsel. One contract has been signed, and two additional contracts will be in place shortly to investigate this matter.

Case 09-07 Competency and Professional Conduct, Need to assign a Board Member - Humphreys discussed with the Board. This case involves the same party as Case 09-03. Humphreys recommended assigning Neugebauer to this case as he already has been assigned to investigating case as Case 09-03. Neugebauer agreed to the assignment, and the Board therefore formally assigned Neugebauer to the Investigation Committee as a Board member. Humphreys, Neugebauer, and Lukkes will be working on this case.

AGENDA ITEM #5 OLD BUSINESS

Meade County Ordinance # 10 - Humphreys discussed. Humphreys has followed up with Meade County. Changes have been entered in Ordinance and will be in effect within twenty days. Humphreys to follow up with Meade County and report the progress at next board meeting.

ABET Accreditation visit to SDSU. SDBOTP invited to provide observer - Discussed by Humphreys. Board has been invited to provide an observer. Neugebauer and Jans will apply to observe on behalf of Board. Humphreys to respond to ABET with names of observers to be approved.

Action Items - Humphreys discussed. Bacon and Neugebauer continuing to rework the Land Survey Take Home Exam.

Surveying Education - Neugebauer reported that at the last annual conference of the South Dakota Society of Professional Land Surveyors there was a panel presentation about educational requirements for licensure that Neugebauer, along with a number of other land surveyors, participated in. Panel members completed a questionnaire at the end of the discussion, results of which have been published in the surveyors' newsletter. Neugebauer stressed the importance for both he and Bacon to attend the Society meetings whenever possible, be kept in the loop, and be involved in their discussions regarding educational requirements for licensure.

AGENDA ITEM #6 NEW BUSINESS

Appointment of Len Neugebauer to the NCEES Engineering Education Task Force - Board extended congratulations to Neugebauer.

Licensure Requirements for Federal Projects - Stafford discussed. Humphreys mentioned he has received an increased number of questions regarding licensure requirements for federal projects. Per Humphreys and Staff Attorney Lukkes, according to South Dakota Statutes, only someone "exclusively engaged as a United States government employee on such government project or projects which lie within federally-owned land" are exempt from requiring licensure in South Dakota.

PE Exam review courses - Discussion by Neugebauer, Humphreys, and Board. It is a consensus by the Board to recommend examinees having failed an exam three times to take review courses prior to reapplying to take the exam. Shafai discussed advantages of taking in-depth courses if necessary to gain additional education prior to the exam. Humphreys mentioned that we cannot insist examinees take additional courses, but we need to strongly encourage additional course study before reapplying to take the test. Board instructed Whipple to prepare a draft letter to examinees having failed an exam three times, adding a paragraph recommending additional course study prior to reapplying to take the exam in the future. Board will review the draft letter at next board meeting.

EIT work on an exempt project - Humphreys discussed his telephone conversations with an individual who currently is an Engineer-In-Training (EIT).

Laser Scanning - Discussion by Bacon, Humphreys, and Board.

Right of Way Plans - Requirements - Discussion by Board and Humphreys. Right of way plans must be signed by a licensed professional.

Engineering Firm's request for interpretation of business practice - Allen Schreier, licensed Professional Engineer in South Dakota, appeared in person and discussed with the Board his business practices of outsourcing surveying services. After discussion by the Board, the consensus of the Board is that this practice is an acceptable practice within the state.

Allen Schreier presented a list of Lawrence County licensees approved to do septic systems in Lawrence County. After discussion by Schreier and the Board, the Board made the following motion.

MOTION: By Shafai, seconded by Neugebauer, to write a letter to Lawrence County licensees on the list provided by Allen Schreier, of professionals approved to do septic systems who are listed individually, but need to either have a business license or if "moonlighting", need a separate sole proprietorship business license. The list needs to show the licensed business rather than the licensed individual professional.

ACTION: (7-0 AYE (Bacon, Hazard, Jans, Neugebauer, Olson, Shafai, Stafford)

LEED AP - Discuss awarding PDH units for completion - Discussion by Humphreys and Board. Regarding LEED certification, buildings are certified, people are accredited, i.e. accredited professional (AP). It was pointed out that LEED certification is a separate accreditation process in itself and should not be confused with the process of becoming licensed to practice in the State of South Dakota,

MOTION: By Neugebauer, seconded by Stafford, to allow up to 8 hours of PDH credits for 1 LEED certification for any professional obtaining LEED accreditation.

ACTION: 7-0 AYE (Bacon, Hazard, Jans, Neugebauer, Olson, Shafai, Stafford)

Schreier brought up other concerns.

MOTION: By Jans, seconded by Neugebauer, that the Board put the complaint process on the strategic planning meeting for next session.

ACTION: 7-0 AYE (Bacon, Hazard, Jans, Neugebauer, Olson, Shafai, Stafford)

Staff Attorney Lukkes mentioned that concerns by individuals should be in the form of a formal complaint in order that the Board can address them in a formal manner.

NCARB Resolution 2009-02 - Discussion by Humphreys, Whipple, and Board regarding the five-year rolling clock and NCARB Resolution 2009-02 as it applies to South Dakota Rules 20:38:13:06. Expiration and 20:38:17:04. Retakes. Board agrees that it wants to modify our Rules to reflect NCARB Resolution 2009-02.

MOTION: By Stafford, seconded by Hazard, to rewrite our Rules 20:38:13:06. Expiration and 20:38:17:04. Retakes to reflect NCARB Resolution 2009-02.

ACTION: 7-0 AYE (Bacon, Hazard, Jans, Neugebauer, Olson, Shafai, Stafford)

Retirement of Warren Fisk, Board Investigator - Fisk mentioned that he has extended his contract as Board Investigator through July 31, 2009, and at that time he will be retiring as Board Investigator. Humphreys and the Board extended their thanks and gratification to Fisk for all the work he has done.

Jans and the board suggested, because of the number of complaints received by the board, the amount of investigation work already being handled by the Executive Director, the obvious understaffing for workload, vacations, sick leave, and mandatory travels, that this may be the opportunity to hire another full-time employee (FTE). The Executive Director could then shift some of his duties and responsibilities to other office staff, including the new FTE, which would allow the Executive Director to pick up most of the duties of investigator. When outside expertise is required, then in those few instances, it could be obtained under contract. Humphreys stated that he would like to discuss the proposition with his staff, ask for their feedback, ideas, and suggestions, and then report back to the board. Neugebauer and Bacon agreed to oversee Land Surveying testing.

Grievance regarding the requirements of ARSD 20:38:24:11 - Humphreys discussed. Staff Attorney Lukkes has responded to grievance with a letter to the individual.
