The South Dakota Cosmetology Commission requires continuing education in microdermabrasion and electric files. These are one-time educational requirements. Documentation must be sent into the Commission upon immediate completion of any course. A \$35 verification fee must be paid by the licensee to the Commission IF the provider is not approved by the Commission. The providers on this list are approved providers for South Dakota licensees so the licensee does not have to pay the \$35 verification fee to the Commission.

Microdermabrasion (closed-loop system) requires 16 hours and must be completed <u>before</u> starting microdermabrasion services. Electric files require 8 hours and must complete the electric file course before using the electric file.

If a licensee does not complete the education requirement and continues the service, the license may be suspended or revoked.

The Commission is not responsible for any course dates, rescheduled courses, cancelled courses or fees paid to the provider.
