### SOUTH DAKOTA COSMETOLOGY COMMISSION NOTICE OF PUBLIC HEARING TO AMEND RULES

A public hearing will be held by the South Dakota Cosmetology Commission via conference call on December 4, 2012, 10:00 a.m.(CST), to consider the proposed amendments of rules numbered §§

The effect of the rules will be to update and clarify general rules language, reorganize the rules so as to make the rules more streamlined and easier to read, define “clean”, “disinfect”, “disinfectant”, “infection control”, “massaging”, and “pedicure foot-spa station”, clarify the differences between the different infection control standards, set standards for branch schools regarding equipment, safety standards, and curriculum, add language and requirements to allow for short-term substitute senior instructors, clarify prohibited equipment, add language to clarify that schools are allowed to offer students the opportunity to earn more than eight hours of credit per day, update the required text books to be used in schools, and streamline rules as to when same rules apply to both business establishments and schools.

The reason for adopting the proposed rules is to clarify a number of administrative rules, make the rules easier to read for both the public and licensees, allow for short-term substitute senior instructors, give schools more flexibility in the structure of the courses they offer to meet the demands of students, clarify which equipment is not allowed to be used on clients to further protect the public, and update the outdated education books that schools use in their curriculum.

Persons interested in presenting data, opinions, and arguments for and against the proposed rules may do so by appearing in person for the conference call at the South Dakota Cosmetology Commission office located at 111 E. Capitol Ave, Pierre, SD, or by calling 605-773-2327 and entering the conference password of 6320# (for assistance call 605-773-3011) to join the meeting via conference call, or by mailing them to the South Dakota Cosmetology Commission, 500 E. Capitol Ave, Pierre, SD 57501. Material sent by mail must reach the South Dakota Cosmetology Commission office by November 29, 2012, to be considered.

After the hearing, the Board will consider all written and oral comments it receives on the proposed rules. The Board may modify or amend a proposed rule at that time to include or exclude matters that are described in this notice.

Notice is further given to individuals with disabilities that this hearing is being held in a physically accessible place. Please notify the South Dakota Cosmetology Commission at least 48 hours before the public hearing if you have special needs for which special arrangements must be made.
