[20:44](#) defines an "Owner's exemption" as an exemption from licensure requirements in [SDCL 36-16-13](#) for an individual owner who is **personally wiring** an electrical installation on a residence or farmstead. Owners doing electrical work on their own residence or farmstead in compliance with [SDCL 36-16-15](#) may not allow their wiring permit to be used by any other person. Violators may be assessed a \$350 administrative fee.
