CONSENT ORDER

In resolution of the above matter and in lieu of issuance of a Notice of Hearing and a formal hearing, the undersigned parties do hereby agree to the following:

DANIEL RODRIGUEZ, whose address of record is 914 Benton Dr. Apt 32, Iowa City, Iowa 52246-5231 holds a non-resident insurance producer license in the State of South Dakota;

DANIEL RODRIGUEZ is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The Division alleges the following with regard to DANIEL RODRIGUEZ:

- 1) DANIEL RODRIGUEZ failed to report administrative actions taken by Kentucky and Iowa within 30 days of the final disposition, in violation of SDCL § 58-30-193;
- 2) DANIEL RODRIGUEZ failed to report a felony charge within 30 days of the pretrial hearing date, a violation of SDCL § 58-30-194;
- 3) DANIEL RODRIGUEZ failed to timely update his address, a violation of SDCL § 58-30-157;
- 4) Pursuant to SDCL §§ 58-30-167(2) and (8), the Director of the Division may revoke DANIEL RODRIGUEZ's insurance producer license for the above cited violations.

DANIEL RODRIGUEZ is aware of and understands the nature of the allegations and has been informed that he has the right to a Notice of Hearing, counsel and appeal and that by agreeing to sign this Consent Order, waives these rights;

In return for DANIEL RODRIGUEZ agreeing to and complying with the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute an informal disposition of this licensing matter pursuant to SDCL § 1-26-20;

By the execution of this Consent Order and the payment of a penalty pursuant to this Consent Order DANIEL RODRIGUEZ waives his right to contest the allegations contained in this Consent Order in any future actions or licensing procedures with the Division;

DANIEL RODRIGUEZ agrees to pay \$500 pursuant to SDCL §§ 58-30-167 and 58-4-28.1, in lieu of an administrative hearing and Final Decision;

DANIEL RODRIGUEZ further agrees to conduct himself in accordance with the insurance laws and regulations of the State of South Dakota;

DANIEL RODRIGUEZ further agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

DANIEL RODRIGUEZ waives his right to contest the allegations contained in this Consent Order in any future actions or licensing procedures;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that DANIEL RODRIGUEZ pay a monetary penalty in the amount of \$500 payable to "South Dakota Division of Insurance" for deposit in the general fund of the State of South Dakota; and it is further


ORDERED that DANIEL RODRIGUEZ abide by the agreements made by him in this Consent Order; and it is further

ORDERED that should DANIEL RODRIGUEZ fail to comply with the provisions of this Order, the Division may seek the suspension or revocation of DANIEL RODRIGUEZ non-resident insurance producer license at hearing, or seek other remedies available at law; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.


