In resolution of the above matter and in lieu of issuance of a Notice of Hearing and a formal hearing, the undersigned parties do hereby agree to the following:

ZURICH AMERICAN INSURANCE COMPANY ("ZURICH AMERICAN"), whose address of record is 1400 American Lane, Schaumburg, IL 60196, is an insurance company holding a certificate of authority to transact business in the State of South Dakota;

ZURICH AMERICAN is aware the South Dakota Division of Insurance ("Division") has conducted an investigation of its insurance-related activities in South Dakota;

The Division has alleged the following:

- 1) ZURICH AMERICAN failed to timely file a First Report of Injury Form concerning state claim number 1463432 in violation of SDCL § 62-6-3;
- 2) ZURICH AMERICAN failed to timely file a First Report of Injury Form concerning state claim number 1463680 in violation of SDCL § 62-6-3;
- 3) ZURICH AMERICAN failed to timely file a First Report of Injury Form concerning state claim number 1476474 in violation of SDCL § 62-6-3;
- 4) ZURICH AMERICAN failed to abide by the terms of a November 2011 Consent Order in which ZURICH AMERICAN agreed to conduct itself in accordance with the insurance laws of South Dakota and maintain compliance with SDCL § 62-6-3;
- 5) The Division issued Warning Letters to ZURICH AMERICAN on June 14, 2012, and April 15, 2015 for failing to timely file First Report of Injury Forms in violation of SDCL § 62-6-3;
- 6) Any of the above-cited conduct provides grounds for the revocation or suspension of ZURICH AMERICAN 'S certificate of authority in South Dakota pursuant to SDCL § 58-6-46;

ZURICH AMERICAN is aware of and understands the nature of the charges and has been informed that it has the right to notice, hearing, and appeal, and that by agreeing to and signing this Consent Order waives these rights;

In return for ZURICH AMERICAN agreeing to the provisions of this Consent Order, the Division agrees not to proceed to hearing and agrees that this Consent Order will constitute an informal disposition of this licensing matter pursuant to SDCL § 1-26-20;

ZURICH AMERICAN agrees to a monetary penalty in the amount of \$15,000 pursuant to SDCL § 58-4-28.1, in lieu of contesting this matter formally; and

ZURICH AMERICAN further agrees to conduct itself in accordance with the insurance laws and regulations of the State of South Dakota;

ZURICH AMERICAN further agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that ZURICH AMERICAN pay a monetary penalty in the amount of \$15,000 payable to "South Dakota Division of Insurance" for deposit in the general fund of the State of South Dakota; and it is further

ORDERED that should ZURICH AMERICAN fail to comply with the provisions of this Order, the Division may seek the suspension or revocation of ZURICH AMERICAN's Certificate of Authority at hearing pursuant to SDCL § 58-6-46, or seek other remedies available at law; and it is further

ORDERED that ZURICH AMERICAN abide by the agreements made by it in this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
