ORDER OF REVOCATION

JACOB R. LUITHLE, whose address of record is 13001 County Rd., #10 CVC, Plymouth, MN, 55442, is a nonresident insurance producer in the State of South Dakota;

JACOB R. LUITHLE's insurance producer license was revoked in Minnesota by that state's Insurance Commissioner on October 25, 2017. The reasons for the revocation would be violations of SDCL § 58-30-167(2), (3), and (8). The State of Minnesota was JACOB R. LUITHLE's home state of domicile.


Pursuant to SDCL 58-30-160, a hearing is not necessary if the nonresident insurance producer's license is revoked in their home state of domicile.

It is hereby ORDERED that JACOB R. LUITHLE's South Dakota insurance producer's license is revoked pursuant to SDCL § 58-30-160; and it is

FURTHER ORDERED that this Order may not be used by any person for any competitive purpose or used in a manner that would violate SDCL Ch. 58-33.


