PROPOSED DECISION**

This matter came for hearing before the Office of Hearing Examiners on March 23, 2017, pursuant to a Notice of Hearing issued by the South Dakota Division of Insurance ("Division") on February 23, 2017. Benjamin Eirikson appeared as counsel for the Division. JOSEPH MILBAUER did not appear, either in person or through counsel. The Division admitted its Exhibits 1 through 8 into evidence and moved that the Hearing Examiner enter these Proposed Findings of Fact, Conclusions of Law, and Proposed Decision as a default disposition to this contested case.

ISSUE

Whether the Non-Resident Insurance Producer License of JOSEPH MILBAUER should be revoked for failing to timely report an administrative action(s) to the Division; for violating any insurance laws; for demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in this state or elsewhere; and for having a revocation or suspension action(s) in another state(s) in violation of SDCL 58-30-167(2), (8), and (9), and 58-30-193.

FINDINGS OF FACT

1. JOSEPH MILBAUER was licensed by the Division as an insurance producer on February 15, 2013. The license is currently active. (Exhibit 1).
2. JOSEPH MILBAUER was the subject of an administrative action in another jurisdiction. (Exhibit 2).
3. JOSEPH MILBAUER had his insurance license revoked by the state of North Dakota. (Exhibit 2).
4. JOSEPH MILBAUER did not timely report the administrative action to the Division.
5. The Division previously issued Warning Letters to JOSEPH MILBAUER on May 27, 2014, and September 3, 2014, for failing to timely report administrative actions. (Exhibits 7 and 8).
6. Any additional Findings of Fact included in the Reasoning section of this decision are incorporated herein by reference.
7. To the extent any of the foregoing are improperly designated and are instead conclusions of law, they are hereby redesignated and incorporated herein as conclusions of law.

SCANNED

REASONING

This case involves a request by the Division to revoke the South Dakota Non-Resident Insurance Producer's License of JOSEPH MILBAUER. As a consequence of the potential loss of Respondent's livelihood from the lack of licensure, the burden of proof in this matter is higher than the preponderance of evidence standard, which applies in a typical administrative hearing. "In matters concerning the revocation of a professional license, we determine that the appropriate standard of proof to be utilized by an agency is clear and convincing evidence." *In re Zar*, 434 N.W.2d 598, 602 (S.D. 1989). Our Supreme Court has defined "clear and convincing evidence" as follows:

The measure of proof required by this designation falls somewhere between the rule in ordinary civil cases and the requirement of our criminal procedure, that is, it must be more than a mere preponderance but not beyond a reasonable doubt. It is that measure or degree of proof which will produce in the mind of the trier of facts a firm belief or conviction as to the allegations sought to be established. The evidence need not be voluminous or undisputed to accomplish this.

Brown v. Warner, 78 S.D. 647, 653, 107 NW2d 1, 4 (1961).

SDCL 58-30-193 states that "[A]n insurance producer shall report to the director any administrative action taken against the insurance producer in another jurisdiction... within thirty days of the final disposition of the matter. This report shall include a copy of the order, consent order, or other relevant legal documents." In addition, the Division considers SDCL 58-30-167 (shown in pertinent part) as follows:

The director may... revoke or refuse to continue, any license issued under this chapter... after a hearing... The director may... revoke... an insurance producer's... for any one or more of the following causes:

- (2) Violating any insurance laws or rules, subpoena, or order of the director or of another state's insurance director, commissioner, or superintendent;
- (8) Using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in this state or elsewhere;
- (9) Having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory;

The evidence indicates that JOSEPH MILBAUER violated the insurance laws of another jurisdiction and failed to report that action. Applying the law to the Findings of Fact it is clear the Non-Resident Insurance Producer License of JOSEPH MILBAUER is subject to revocation and should be revoked.

CONCLUSIONS OF LAW


1. The Division has jurisdiction over JOSEPH MILBAUER and the subject matter of this contested case. The Office of Hearing Examiners is authorized to conduct the hearing and issue a proposed decision pursuant to SDCL 1-26D-4.
2. The Division bears the burden of establishing the alleged statutory violations by clear and convincing evidence.
3. The Division established by clear and convincing evidence that JOSEPH MILBAUER violated SDCL § 58-30-193.
4. The Division established by clear and convincing evidence that the South Dakota Non-Resident Insurance Producer License of JOSEPH MILBAUER is subject to revocation.
5. The Division may revoke or impose any penalty against a person who violates Title 58, even if the person's license or registration has been surrendered or has lapsed by operation of law pursuant to SDCL § 58-30-170.
6. Any additional Conclusions of Law included in the Reasoning section of this decision are incorporated herein by reference.
7. To the extent any of the foregoing are improperly designated and are instead findings of fact, they are hereby redesignated and incorporated herein as Findings of Fact.

Based on the above Findings of Fact, Reasoning, and Conclusions of Law, the Hearing Examiner enters the following:

PROPOSED DECISION

The South Dakota Non-Resident Insurance Producer License of JOSEPH MILBAUER should be revoked.


