CONSENT ORDER

---

In resolution of the above matter and in lieu of a formal hearing, the undersigned parties do hereby agree to the following:

ROBIN ELLIOTT, whose address of record is 2623 Mohawk Dr., Jefferson City, MO 65101, holds a nonresident insurance producer license in the State of South Dakota;

ROBIN ELLIOTT is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The Division alleges the following:

- 1) ROBIN ELLIOTT failed to respond to Division inquires dated October 4, 2018, November 4, 2018, and March 20, 2019 in violation of SDCL §§ 58-33-66 and 58-33-68;
- 2) ROBIN ELLIOTT failed update her mailing address with the Division within 30 days, in violation of SDCL § 58-30-157;
- 3) Pursuant to SDCL §§ 58-30-167(2) & (8), 58-30-157, 58-33-66, and 58-33-68, the Director of the Division may revoke ROBIN ELLIOTT's nonresident insurance producer license for any one of the above-cited reasons.

ROBIN ELLIOTT is aware of and understands the nature of the charges and has been informed that she has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

In return for ROBIN ELLIOTT agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute the final disposition pursuant to SDCL § 1-26-20;

ROBIN ELLIOTT agrees, agrees to pay \$500 pursuant to SDCL §§ 58-30-167 and 58-4-28.1, in lieu of an administrative hearing and Final Decision;

ROBIN ELLIOTT further agrees to conduct herself in accordance with the insurance laws and regulations of the State of South Dakota;

ROBIN ELLIOTT further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

By the execution of this Consent Order, ROBIN ELLIOTT waives her right to contest the allegations contained in this Consent Order in any future licensing proceedings;


Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that ROBIN ELLIOTT pay a monetary penalty in the amount of \$500 payable to "South Dakota Division of Insurance" for deposit in the general fund of the State of South Dakota; and it is further

ORDERED that ROBIN ELLIOTT abide by the agreements made by her in this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.


