**ORDER REVOKING  
CERTIFICATE OF AUTHORITY**

RECIPROCAL OF AMERICA (hereinafter "the Company"), whose mailing address of record is 4200 Innslake Dr., Glen Allen, VA 23060, is an insurance company holding a certificate of authority to transact business in the State of South Dakota;

The South Dakota Division of Insurance has received information that that the Company has been placed in receivership, conservatorship, rehabilitation, or other delinquency proceedings.

Pursuant to SDCL § 58-34-19, the director may revoke an insurer's certificate of authority for failure to comply with any provision of the insurance title.

Pursuant to SDCL §§ 58-34-48, 58-6-44, and 58-6-45, the director must forthwith revoke an insurer's certificate of authority upon the impairment of surplus requirements and a hearing for the revocation of the insurer's certificate of authority is not required when a company no longer meets the requirements for the authority on account of deficiency of assets or otherwise.


Therefore, pursuant to SDCL §§ 58-34-48, 58-6-44, and 58-6-49, it is hereby ORDERED that the Company's Certificate of Authority to transact business in the State of South Dakota is hereby revoked; and it is further

ORDERED that, pursuant to SDCL § 58-6-61, this Order automatically suspends authority of any insurance producers to act as insurance producers of the Company in this state; and it is further

ORDERED that this Order may not be used by any person for any competitive purpose or used in a manner that would violate SDCL Chapter 58-33.

This Order may be appealed to the Circuit Court and South Dakota Supreme Court pursuant to SDCL Chapter 1-26.




