- 2) Pursuant to SDCL §§ 58-30-167(1) & (2), the Director of the Division may revoke SHAWNA MARIE HARPER SCOTT's nonresident insurance producer license for any one of the above-cited reasons.

SHAWNA MARIE HARPER SCOTT is aware of and understands the nature of the charges and has been informed that she has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

SHAWNA MARIE HARPER SCOTT agrees, agrees to pay \$500 pursuant to SDCL §§ 58-30-167 and 58-4-28.1, in lieu of an administrative hearing and Final Decision; '-

SHAWNA MARIE HARPER SCOTT further agrees to conduct herself in accordance with the insurance laws and regulations of the State of South Dakota;

SHAWNA MARIE HARPER SCOTT further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

By the execution of this Consent Order, SHAWNA MARIE HARPER SCOTT waives her right to contest the allegations contained in this Consent Order in any future licensing proceedings;
