CONSENT ORDER

In resolution of the above matter and in lieu of a formal hearing, the undersigned parties do hereby agree to the following:

BROCK DEVRIES, whose address of record is 206 1/2 South Churchill Circle, North Sioux City , SD 57049 is an individual who was formally licensed as a resident insurance producer in the State of South Dakota;

BROCK DEVRIES is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The Division alleges the following with regard to BROCK DEVRIES:

- 1) BROCK DEVRIES was the subject to administrative actions in the State of Iowa;
- 2) BROCK DEVRIES failed to report the administrative actions to the Division within 30 days, in violation of SDCL § 58-30-193;
- 3) BROCK DEVRIES had an insurance producer license, or its equivalent, denied, suspended, or revoked in another state, province, district, or territory, in violation of SDCL § 58-30-167(9);
- 4) Pursuant to SDCL §§ 58-30-167(2), (9), and 58-30-193 the Director of the Division may revoke BROCK DEVRIES's insurance producer license for violating the insurance laws of South Dakota. Pursuant to SDCL § 58-30-170, the Division may revoke BROCK DEVRIES's insurance producer license even if it has lapsed.

BROCK DEVRIES is aware of and understands the nature of the charges and has been informed that he has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

By the execution of this Consent Order BROCK DEVRIES neither admits to nor denies any violations of the laws of the State of South Dakota, but waive his right to contest the allegations contained in this Consent Order;

In return for BROCK DEVRIES agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute the final disposition pursuant to SDCL § 1-26-20;

BROCK DEVRIES agrees, in lieu of contesting this matter formally, to the revocation of his nonresident insurance producer's license and to cease the transaction of insurance business in this state;

BROCK DEVRIES further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;


By the execution of this Consent Order, BROCK DEVRIES waives his right to contest the allegations contained in this Consent Order in any future licensing proceedings;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that the nonresident insurance producer's license of BROCK DEVRIES is hereby revoked; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
