Dear Mr. Lumpkins,

This letter is to notify you that your application for licensure as a nonresident insurance producer in South Dakota has been denied. The reason for the denial is as follows:

You submitted an application for an individual nonresident insurance producer license to the South Dakota Division of Insurance ("Division") on February 24, 2021. You answered "yes" to the question asking whether you had ever been charged with or convicted of a misdemeanor and "no" to the question asking whether you had ever been subject to an administrative action. The Division conducted an investigation that confirmed you were found guilty of a misdemeanor Deceptive Practice in Illinois on June 16, 2019, for which you were sentenced to court supervision. The Division also found that you were subject to administrative actions on April 8, 2019 in Kansas and May 23, 2019 in Connecticut, both of which resulted in the denial of your license application. The Division wrote you on March 30, 2021, asking for an explanation as to why you provided an incorrect answer with your application, but never received a response. The Division wrote you again on August 3, 2021 and again never received a response. To date, the division has not received a response to any of its correspondence.

Based the above, your application is denied under SDCL 58-30-167(1), (2), (3), (8), and (9) for providing incorrect, misleading, incomplete, or materially untrue information in the license application, violating any insurance laws or rules, subpoena, or order of the director or of another state's insurance director, commissioner, or superintendent, obtaining or attempting to obtain a license through misrepresentation or fraud, using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in this state or elsewhere, and having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.

Please note that this denial is considered an administrative action which will be reported to the database maintained by the National Association of Insurance Commissioners. If an administrative action occurs, an insurance producer may be required to report the action to any and all states in which an insurance license is held and in accordance with the timeframes and requirements of each state.
