In resolution of the above titled matter and in lieu of an application denial, Notice of Hearing, and a formal hearing, the undersigned parties do hereby agree to the following:

RONALD REPASKY, whose address of record is 1411 S Locust St, Casper, Wyoming 82604-3325, is a non-resident insurance producer applicant in the State of South Dakota;

RONALD REPASKY is aware that the South Dakota Division of Insurance has conducted an investigation;

The Division alleges the following with regard to RONALD REPASKY:

- 1) RONALD REPASKY submitted an application for a South Dakota non-resident insurance producer license on January 8, 2021;
- 2) RONALD REPASKY answered "No" to having been named or involved in an administrative action on his application for licensure;
- 3) On March 4, 2018, RONALD REPASKY was subject to a Wyoming administrative action resulting in a Consent Order granting him a probationary license and fining him \$1,500 for five consumer complaints against him;
- 4) Pursuant to SDCL 58-30-167(1), (2), (8), and (9), the Director of the South Dakota Division of Insurance may deny RONALD REPASKY's non-resident insurance producer application for any of the above cited reasons.

RONALD REPASKY is aware of and understands the nature of these allegations and has been informed that he has the right to a Notice of Hearing, counsel, and appeal, and that by agreeing to sign this Consent Order waives these rights;

In return for RONALD REPASKY agreeing to and complying with the provisions of this Consent Order, the Division agrees not to deny RONALD REPASKY's non-resident producer application and agrees that this Consent Order will constitute an informal disposition of this licensing matter pursuant to SDCL 1-26-20;

By the execution of this Consent Order and the payment of a penalty discussed herein, RONALD REPASKY waives his right to contest the allegations contained in this Consent Order in any future actions or licensing procedures with the Division;

RONALD REPASKY agrees to pay \$500 pursuant to SDCL 58-30-167 and 58-4-28.1, in lieu of a hearing and Final Order and further agrees to conduct himself in accordance with the insurance laws and regulations of the State of South Dakota;

RONALD REPASKY further agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that RONALD REPASKY pay a monetary penalty in the amount of \$500 payable to "South Dakota Division of Insurance" to be submitted with this completed Consent Order for deposit in the general fund of the State of South Dakota; and it is further


ORDERED that RONALD REPASKY abide by the agreements made by him in this Consent Order; and it is further

ORDERED that the non-resident insurance producer reinstatement application of RONALD REPASKY is hereby APPROVED for licensure on the effective date of this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further


ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
