Re: Application for South Dakota Non-resident Insurance Producer License

Victor Fernando Mejia Garcia,

This letter is to notify you that your application for licensure as a non-resident insurance producer in South Dakota has been denied. The reason for the denial is as follows:

You submitted an application for an individual nonresident insurance producer license to the South Dakota Division of Insurance ("Division") on August 26, 2021. You answered "yes" to Question 1B of the licensing application asking if you had ever been convicted of a felony.

On September 8, 2021, the Kansas Insurance Department reviewed your application for a nonresident insurance producer license. The Kansas license was denied based on the prior felony charge for fraudulent use or possession of identifying information of another person. The Kansas denial was not reported to the Division in your application.

The Division wrote to you on December 1, 2021, requesting an explanation as to why a license should be granted considering your recent criminal history. The Division received no response and wrote a citation letter on January 11, 2022, which was sent via email, first-class mail, and first-class certified mail. No response was received. A call was placed to your home phone of record on April 21, 2022, in an attempt to contact you. When the Division's compliance agent advised as to the reason for the call, the person on the other end hung up the phone.

Therefore, your application is denied based upon SDCL 58-30-167(1), (2), (8), and (9) for providing incomplete information in the license application, violating any insurance laws, rules, or order of another state's insurance director, using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in this state or elsewhere, and having a license denied in another state.

Please note that this denial is considered an administrative action which will be reported to the data base maintained by the National Association of Insurance Commissioners. If an administrative action occurs, an insurance producer may be required to report the action to any and all states in which an insurance license is held and in accordance with the timeframes and requirements of each state

Pursuant to SDCL 58-30-168, you may make a written request to the Division of Insurance within 30 days of the date of this denial for a hearing to determine the reasonableness of this decision to deny your application for licensure.
