In resolution of the above matter and in lieu of issuance of a Notice of Hearing and a formal hearing, the undersigned parties do hereby agree to the following:

HEALTHCARE HIGHWAYS RX, LLC, doing business as CERPASSRX ("CERPASSRX), whose address of record is 5904 Stone Creek Dr Ste 120, Lewisville, Texas 75056-2636, is an applicant for a Third-Party Administrator ("TPA") License with a Pharmacy Benefit Manager ("PBM") qualification in the State of South Dakota;

CERPASSRX is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation of its insurance-related activities in South Dakota;

The Division has alleged the following:

- 1) CERPASSRX has adjudicated thousands of drug claims in South Dakota without a TPA License, in violation of SDCL 58-29D-21, 58-29D-31(4) & (8), and 58-29E-2;
- 2) On April 26, 2024, CERPASSRX submitted a TPA license application with a PBM qualification;
- 3) The above-cited conduct may be grounds for the denial of its Third-Party Administrator License and/or the denial of its PBM qualification pursuant to SDCL 58-29D-21, 58-29D-24, 58-29D-31(4) & (8), 58-29E-2 and 58-30-167(2);

By the execution of this Consent Order CERPASSRX waives its right to contest the allegations contained in this Consent Order in any future actions or licensing procedures with the Division;

CERPASSRX is aware of and understands the nature of the charges and has been informed that it has the right to notice, hearing, and appeal, and that by agreeing to and signing this Consent Order waives these rights;

In return for CERPASSRX agreeing to the provisions of this Consent Order, the Division agrees not to proceed to hearing and agrees that this Consent Order will constitute an informal disposition of this licensing matter pursuant to SDCL 1-26-20;

CERPASSRX agrees to a monetary penalty in the amount of \$10,000 pursuant to SDCL 58-4-28.1, in lieu of contesting this matter formally;

CERPASSRX further agrees to conduct itself in accordance with the insurance laws and regulations of the State of South Dakota;

CERPASSRX further agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that CERPASSRX pay a monetary penalty in the amount of \$10,000 payable to "South Dakota Division of Insurance" for deposit in the general fund of the State of South Dakota; and it is further

ORDERED that CERPASSRX abide the agreements made by it in this Consent Order; and it is further

ORDERED that should CERPASSRX fail to comply with the provisions of this Order, the Division may seek the suspension or revocation of CERPASSRX's Third-Party Administrator's License at hearing pursuant to SDCL 58-29D-31, or seek other remedies available at law; and it is further

ORDERED that the TPA application with PBM qualification of CERPASSRX is APPROVED as of the effective date of this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or thirdparty administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
