## BEFORE THE DIVISION OF INSURANCE DEPARTMENT OF LABOR AND REGULATION STATE OF SOUTH DAKOTA

IN THE MATTER OF MAKSYMILIAN KONOPKA	)	CONSENT ORDER	

In resolution of the above matter and in lieu of a formal hearing, the undersigned parties do hereby agree to the following:

MAKSYMILIAN KONOPKA ("KONOPKA"), whose address of record is 425 Austin Ave, Waco TX 76701, is a nonresident insurance producer licensed in the State of South Dakota;

KONOPKA is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The Division alleges the following:

- 1) On March 14, 2024, KONOPKA's insurance appointment was terminated for cause from an insurer due to signing policies without proper authorization, in violation of SDCL 58-30-167(8);
- 2) On March 10, 2023, the State of Louisiana suspended Konopka's license, in violation of SDCL 58-30-167(2) & (9);
- 3) On April 13, 2023, the State of Louisiana revoked and fined Konopka, in violation of SDCL 58-30-167(2) & (9);
- 4) Pursuant to SDCL 58-30-167(2), (8), & (9), the Director of the Division may revoke KONOPKA's insurance producer license for any of the above-cited reasons.

KONOPKA is aware of and understands the nature of the charges and has been informed that he has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

In return for KONOPKA agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute the final disposition pursuant to SDCL 1-26-20;

KONOPKA agrees, in lieu of contesting this matter formally, to the revocation of his nonresident insurance producer's license and to cease the transaction of insurance business in this state;

KONOPKA further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that the nonresident insurance producer's license of MAKSYMILIAN KONOPKA is hereby revoked; and it is further

ORDERED that MAKSYMILIAN KONOPKA abide by the agreements made by him in this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
