In resolution of the above matter and in lieu of a formal hearing, the undersigned parties do hereby agree to the following:

CHRISTIAN NAOMI NWUJU ("NWUJU"), whose address of record is 2575 Irving Ct Apt B, Omaha, NE 68131-1677, is an individual holding a non-resident insurance producer license in the State of South Dakota.

NWUJU is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The Division alleges the following:

- 1) NWUJU was subject to administrative actions in the states of Kansas and North Carolina;
- 2) On September 26, 2023, the State of Kansas denied NWUJU's license application due to failing to disclose another state's administrative action, in violation of SDCL 58-30-167(9);
- 3) On April 17, 2024, the State of North Carolina fined NWUJU due to failing to report Kansas' action, in violation of SDCL 58-30-167(2);
- 4) NWUJU failed to report the states of Kansas and North Carolina administrative actions to the Division, in violation of SDCL 58-30-193;
- 5) NWUJU failed to respond within 20 days the Division's requests for an explanation dated February 22, 2024, March 18, 2024, April 8, 2024 and May 2, 2024, in violation of SDCL 58-33-66(1);
- 6) Pursuant to SDCL 58-30-167(2), & (9), 58-30-193, and 58-33-66(1), the Director of the Division may revoke NWUJU's insurance producer license for any of the above-cited reasons.

NWUJU is aware of and understands the nature of the charges and has been informed that he has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

In return for NWUJU agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute the final disposition pursuant to SDCL 1-26-20;

NWUJU agrees, in lieu of contesting this matter formally, to the revocation of their nonresident insurance producer's license and to cease the transaction of insurance business in this state;

NWUJU further agrees that this Consent Order may be considered in any future licensing procedures with the South Dakota Division of Insurance and for the purpose of determining the appropriate sanction in any

future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

By the execution of this Consent Order, NWUJU waives his right to contest the allegations contained in this Consent Order in any future licensing proceedings;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that the nonresident insurance producer's license of NWUJU is hereby revoked; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.

I have read and understand the terms of this Consent Order and the waiver of my due process rights and voluntarily enter into this Consent Order.
