In resolution of the above titled matter and in lieu of administrative action concerning RX VALET s Discount Medical Plan Organization ("DMPO") Application License, the undersigned parties do hereby agree to the following:

RX VALET, LLC ("RX VALET") whose address of record is 1580 Atkinson Rd., Lawrenceville, GA 30043 is an entity seeking to be licensed as a DMPO in the State of South Dakota;

RX VALET is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation regarding their activity in this state;

The Division alleges the following with regard to RX VALET:

- 1) RX VALET submitted a DMPO application on April 19, 2024;
- 2) The Division discovered that RX VALET had been acting a DMPO in South Dakota without a valid license or registration in violation SDCL § 58-17E-4 and 58-17E-9;
- 3) Pursuant to SDCL § 58-17E-14 and 58-17-18, the Director of the Division may deny RX VALET's DMPO License application for any of the above-cited reasons.

RX VALET is aware of and understands the nature of the allegations and has been informed that it has the right to a Notice of Hearing, counsel and appeal and that by agreeing to sign this Consent Order, and it affirmatively waives these rights;

In return for RX VALET agreeing to and complying with the provisions of this Consent Order, the Division agrees not to deny RX VALET's DMPO application and agrees that this Consent Order will constitute an informal disposition of this licensing matter pursuant to SDCL § 1-26-20;

By the execution of this Consent Order and the payment of a penalty pursuant to this Consent Order, RX VALET waives its right to contest the allegations contained in this Consent Order in any future actions or licensing procedures with the Division;

RX VALET agrees to pay \$25,000 pursuant to SDCL §§ 58-29D-18 and 58-4-28.1, in lieu of a Final Order and further agrees to conduct itself in accordance with the insurance laws and regulations of the State of South Dakota;

RX VALET further agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that RX VALET pay a monetary penalty in the amount of \$25,000 payable to "South Dakota Division of Insurance" to be submitted with this completed Consent Order for deposit in the general fund of the State of South Dakota; and it is further

ORDERED that RX VALET abide by the agreements made by it in this Consent Order; and it is further

ORDERED that the DMPO application of RX VALET as amended to date is hereby approved for licensure on the effective date of this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or thirdparty administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
