SCOTTISH RE (U.S.). INC, has been placed into Liquidation in their domiciliary jurisdiction of Delaware;

Pursuant to SDCL § 58-14-16.20 an order revoking a reinsurer's accreditation can be entered without a hearing a hearing if the order is based on regulatory action by the reinsurer's domiciliary jurisdiction.


ORDER




