CONSENT ORDER

In resolution of the above titled matter and in lieu of a Notice of Hearing and formal insurance license revocation proceeding, the undersigned parties do hereby agree to the following:

TYLER BJERKE has an address of record of 4229 66TH ST S, FARGO, ND 58104 and has an active insurance producer license in the State of South Dakota;

TYLER BJERKE is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation;

The Division alleges the following:

- 1) TYLER BJERKE failed to timely report an administrative action to the Division, in violation of SDCL 58-30-193;
- 2) TYLER BJERKE conduct described herein amounts to violations of SDCL 58-30-167(2) and 58-30-193 constitute grounds to suspend or revoke his insurance producer licenses.

TYLER BJERKE is aware of and understands the nature of the charges and has been informed that he has the right to counsel, hearing, and appeal and that by agreeing to and signing this Consent Order, waives these rights;

By the execution of this Consent Order TYLER BJERKE neither admits to nor denies any violations of the laws of the State of South Dakota, but waive his right to contest the allegations contained in this Consent Order;

In return for TYLER BJERKE agreeing to the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute the final disposition pursuant to SDCL § 1-26-20;

TYLER BJERKE agree to pay a monetary penalty in the amount of \$2,000, pursuant to SDCL 58-4-28.1, in lieu of contesting the matter formally; and

TYLER BJERKE further agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or any Order of the Director;

Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that TYLER BJERKE pay a monetary penalty in the amount of \$2,000, which is to be payable to "South Dakota Division of Insurance" and submitted with this completed Consent Order for deposit in the General Fund of the State of South Dakota; and it is further

ORDERED that TYLER BJERKE abide by the agreements made by him in this Consent Order; and it is further

ORDERED that should TYLER BJERKE fail to comply with the provisions of this Order, the Division may seek the suspension or revocation of his license at hearing pursuant to SDCL 58-30-167 and Chapter 1-26, or seek other remedies available at law; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
