CONSENT ORDER

In resolution of the above matter and in lieu of issuance of a Notice of Hearing and a formal hearing, the undersigned parties do hereby agree to the following:

CHRISTOPHER HAUSMAN, NPN 8783212, with an address of record is 11018 X ST
OMAHA, NE 68137-3722, holds an insurance producer license in the State of South Dakota;

CHRISTOPHER HAUSMAN is aware that the South Dakota Division of Insurance (Division) has conducted an investigation into their insurance related business;

The Division alleges the following with regard to CHRISTOPHER HAUSMAN:

1. CHRISTOPHER HAUSMAN misrepresented himself to South Dakota consumers, in violation of SDCL 58-30-167(8) and 58-33-6;
2. CHRISTOPHER HAUSMAN discussed products with South Dakota consumers that contain securities products, without a South Dakota securities registration, in violation of SDCL 58-33-90 and 47-31B-404;
3. The Director of the Division may revoke CHRISTOPHER HAUSMAN's insurance producer license and/or issue an order to cease and desist under the securities laws for any one of the above-cited violations;

CHRISTOPHER HAUSMAN is aware of and understands the nature of the allegations and has been informed that they have the right to a Notice of Hearing, counsel, and appeal, and that by signing this Consent Order, waives these rights;

In return for CHRISTOPHER HAUSMAN agreeing to, signing, and complying with the provisions of this Consent Order, the Division agrees not to proceed to administrative hearing and agrees that this Consent Order will constitute an informal disposition of this licensing matter pursuant to SDCL 1-26-20;

By the execution of the Consent Order and payment of a penalty, CHRISTOPHER HAUSMAN neither admits to nor denies any violation of the laws of the State of South Dakota but waives his right to contest the existence of this Consent Order in any future actions or licensing procedures with the Division;

CHRISTOPHER HAUSMAN agrees to a monetary penalty in the amount of \$5,000 pursuant to SDCL 58-4-28.1, in lieu of an administrative hearing and Final Decision;

CHRISTOPHER HAUSMAN further agrees to conduct business in accordance with the insurance laws and regulations of the State of South Dakota; and

CHRISTOPHER HAUSMAN further agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;


Wherefore, good cause appearing from the foregoing, it is hereby ORDERED that CHRISTOPHER HAUSMAN pay a monetary penalty in the amount of \$5,000 payable to "South Dakota Division of Insurance" for deposit in the General Fund of the State of South Dakota; and it is further

ORDERED that CHRISTOPHER HAUSMAN abide by the agreements made by them in this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or third-party administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
