**ORDER REVOKING

Larry Deiter, Director of the South Dakota Division of Insurance ("Director"), in accordance with SDCL 58-30-167.2 & 58-30-167.3, hereby gives notice that **NATHANIEL ROBINSON has violated the Insurance Code of the State of South Dakota, failed to timely respond to the South Dakota Division of Insurance ("Division"), and that NATHANIEL ROBINSON's Insurance Producer License will be revoked unless a hearing is requested in writing within 60 days of this Order.** NATHANIEL ROBINSON is expressly notified that they are entitled to a hearing pursuant to SDCL 58-30-167.3 if the Division is timely contacted in writing. Therefore, supported by the Exhibits attached hereto, the Director makes the following Findings of Fact, Conclusions of Law, and Order:

FINDINGS OF FACT

- 1) NATHANIEL ROBINSON, who holds an active Insurance Producer License, is required to maintain an accurate address of record pursuant to SDCL 58-30-157; the address above is the last address recorded at the Division. (Exhibit 1).
- 2) NATHANIEL ROBINSON was the subject of a license revocation administrative action in a different jurisdiction, which was not reported to the Division. (Exhibit 2).
- 3) The Division sent inquiries to NATHANIEL ROBINSON at their address of record above regarding licensure matters. (Exhibit 3-4).
- 4) NATHANIEL ROBINSON did not respond to the Division's inquiries.
- 5) Any additional Findings of Fact included in the Reasoning section of this decision are incorporated herein by reference.
- 6) To the extent any of the foregoing are improperly designated and are instead conclusions of law, they are hereby redesignated and incorporated herein as conclusions of law.

CONCLUSIONS OF LAW

1. The Director of the Division has jurisdiction over NATHANIEL ROBINSON and the subject matter of this contested case.
2. Due to the loss of livelihood from lack of licensure, the Division bears the burden of establishing the alleged statutory violations by clear and convincing evidence. *In re Zar*, 434 N.W.2d 598, 602 (S.D. 1989) and *Brown v. Warner*, 107 N.W.2d 1, 4 (S.D. 1961).
3. The Division established by clear and convincing evidence as attached in Exhibits hereto that NATHANIEL ROBINSON violated SDCL 58-30-193 and 58-33-66.
4. The Division established by clear and convincing evidence that NATHANIEL ROBINSON's South Dakota Insurance Producer License is subject to revocation pursuant to SDCL 58-30-167(2) & (9).
5. The Division is authorized to issue this Order revoking NATHANIEL ROBINSON's producer license without a hearing pursuant to SDCL 58-30-167.2, and 58-30-167.3.
6. Any additional Conclusions of Law included in the Reasoning section of this decision are incorporated herein by reference.
7. To the extent any of the foregoing are improperly designated and are instead findings of fact, they are hereby redesignated and incorporated herein as Findings of Fact.

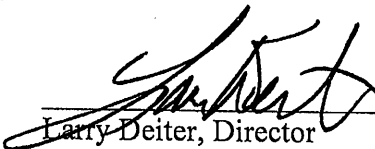
ORDER

Now therefore, good cause appearing from the foregoing, IT IS HEREBY ORDERED, pursuant to SDCL 58-30-167(2) & (9), 58-30-167.2, 58-30-167.3, 58-30-193, and 58-33-66, the South Dakota Insurance Producer License of NATHANIEL ROBINSON is hereby REVOKED, unless a hearing is requested in writing within 60 days of this Order; and it is further

ORDERED that NATHANIEL ROBINSON may request a hearing on this Order within 60 days of the date of this Order; and it is further

ORDERED that if NATHANIEL ROBINSON makes a timely written request to the Division, a Notice of Hearing on this matter will be issued within 30 days the request pursuant to SDCL 58-30-167.3, which will be conducted according to procedures for contested cases as prescribed in SDCL Chs. 1-26 and 1-26D.

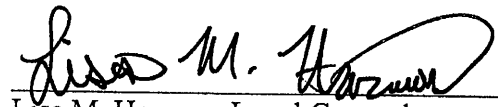
