In resolution of the above titled matter and in lieu of administrative action concerning RXEDO CONSULTING SERVICES, LLC's ("RCS, LLC") Discount Medical Plan Organization ("DMPO") Application, the undersigned parties do hereby agree to the following:

RCS, LLC, with an address of record is 7800 Dallas Parkway, Suite 460, Plano, TX 75024 is an entity seeking to be registered as a DMPO in the State of South Dakota;

RCS, LLC is aware that the South Dakota Division of Insurance ("Division") has conducted an investigation regarding their activity in this state;

The Division alleges the following with regard to RCS, LLC:

- 1) RCS, LLC submitted a DMPO application which is pending;
- 2) RCS, LLC has acted a DMPO in South Dakota without a valid registration in violation SDCL 58-17E-4 and 58-17E-9;
- 3) Pursuant to SDCL 58-17E-14 and 58-17E-18, the Director of the Division may deny RCS, LLC's DMPO application for any of the above-cited reasons.

RCS, LLC is aware of and understands the nature of the allegations and has been informed that it has the right to a Notice of Hearing, counsel and appeal and that by agreeing to sign this Consent Order, and it affirmatively waives these rights;

In return for RCS, LLC agreeing to and complying with the provisions of this Consent Order, the Division agrees not to deny RCS, LLC's DMPO application and agrees that this Consent Order will constitute an informal disposition of this registration matter pursuant to SDCL § 1-26-20;

By the execution of this Consent Order, RCS, LLC neither admits to nor denies any violation of the laws of the State of South Dakota, but waives its right to contest the allegations contained in this Consent Order in any future actions or registration procedures with the Division;

RCS, LLC agrees that this Consent Order may be considered for the purpose of determining the appropriate sanction in any future actions with the Division for any violations of the laws or regulations of the State of South Dakota or for failing to abide by any order of the Director;

RCS, LLC agrees to refund amounts collected from all South Dakota pharmacies for the period in which RCS, LLC was unregistered;

Therefore, good cause appearing from the foregoing, it is hereby ORDERED that RCS, LLC refund amounts collected from all South Dakota pharmacies since January 1, 2022, during which RCS, LLC was unregistered; and it is further

ORDERED that the DMPO application of RCS, LLC, as amended to date, is hereby APPROVED for registration on the effective date of this Consent Order; and it is further

ORDERED that RCS, LLC abide by the agreements made by it in this Consent Order; and it is further

ORDERED that the use of this Consent Order for competitive purposes by an insurance agent or thirdparty administrator holding a license in the State of South Dakota, or by any company holding a Certificate of Authority, or by anyone on their behalf, may be deemed unfair competition and be grounds for suspension or revocation of said license or authority; and it is further

ORDERED that the provisions of this Consent Order shall be effective from the date the Director signs this Order.
